George was one of the early members of the Society. He was always interested in family history and genealogy an was a resolute researcher. As a result of his research over many years the society has a wealth of knowledge and information especially regarding the Metcalfes in India and their families back in Britain. His research was the basis of the *Metcalfes in India* booklet of which he was co-author.

George Died on 31 August 2015.



I got to know George after I took over as editor in 1994. He was already a prolific



contributor to the Society's Mecca News having provided an article as early as Issue 4. He was always keen to provide items and articles for our magazine especially on India which was his favourite area of research.

George would finish his shift and regularly go off to the British Library and delve into the India Office records. He did this for over a decade resulting in hundreds of pages of information and over a thousand Mecca entries. His interest was not solely with the sub-continent as he researched his family in the Dales which resulted in a semi-permanent display at the Swaledale Museum.

I became friendly with George and his wife as a result of his magazine contributions and my wife and I visited George and his wife when they moved to the Midlands. The sudden and unexpected death of Janet last Autumn affected him badly and earlier this year he went into a nursing home where he died peacefully.

Abraham Medcallffe born about 1500 and Branch 59 from History of the Clan

From the "Oxford Church Courts Depositions 1570-1574" No.10 26 May 1570 we read of Master Abraham Medcallffe of Woodstock Oxfordshire resident 42 years, aged 70. This is recorded in a Case of Defamation brought by John Haynes of Bladon against John Fletcher of Woodstock. Medcallffe was brought on as a witness for Haynes, and things got a bit messy when Fletcher decided to bring into doubt the character of Haynes' witnesses:

Witnesses for Fletcher attacked the character of Haynes' witnesses in some detail saying, inter alia, that Medcalffe was an habitual drunk, denying when sober what he agreed to when drunk, often making outrageous remarks about the Mayors of Woodstock, at odds with Fletcher when Fletcher was Mayor about putting a pair of butts on the common ground, for which he was put out of the aldermanship; and that he had violently attacked a little girl who had taken a small piece of cloth in his shop 'to make his daughter a baby'. [I think that should read "who had taken a small piece of cloth from his shop intending to make clothes for her dolly" or something like that]. Haynes witnesses testified at length about the honesty, sobriety and good name of his witnesses referring to the number of times Medcallffe and Cresseley had been mayor, and to Medcallffe being reinstated after having been disenfranchised by Fletcher for disobedience etc etc".

I am convinced that this Abraham holds the clue as to why one branch of the family became the Abraham alias Metcalfes (see Branch 59 in the History of the Clan). Metcalfes were mayors of New Woodstock Oxfordshire in the sixteenth, seventeenth and eighteenth centuries. This Metcalfe family was strongly rooted in Woodstock, Bicester and Banbury but it was the Banbury branch where the Abraham alias Metcalfes flourished.

I am still working on this genealogy and would be happy to share my findings with the society when my research is complete.

In the meantime the reason that I am writing to you is to enquire whether you or any of your readers can shed any light on where Abraham Medcallffe born about 1500 may have been baptised. We know from the above that he only moved to Woodstock in around 1528 so where did he move from?

There were Metcalfes at that time in Henley on Thames and also in London, but I am wondering did he come down from Yorkshire perhaps to study at the University at Oxford and settled in Oxon instead of returning. Abraham Metcalfe seems to have been a popular name in the Askrigg area. Can anyone identify an Abraham Metcalfe perhaps from a family of drapers who travelled south to study or trade and did not return? I would be pleased to hear from you.

The first one I looked at (Elizabeth) was born in Yorkshire! (See page 28.)

The June edition of 'Suffolk Roots' of the Suffolk Family History Society had an article about men from Long Melford, Suffolk who were involved in the Peninsular War and/or the Battle of Waterloo. One of these men was **James Medcalf (born c1789 at Long Melford)**. There seems to be good research and more and or different data to what we have on our database.

First a sad note. I was very sorry to learn a few days ago that our Vice President George Buxton passed away recently. He was one of our first members with a membership number with two 00s in front of it to prove it! During the society's existence he spent hours on Metcalfe research. He will particularly be remembered for his research on the Metcalfes in India. He amassed thousands of references to the family in India, some of which you can find in our society's publications of that name. George was generous with his time and the Society would be much the poorer if he had not voluntarily carried out, often in his lunch hour, so much research on our behalf. I was indebted to him for all the references he found in the Indian archives on Lambert. As he put it, since he was looking for Ms he could very easily look at the Ls too! Tributes are paid to him elsewhere. Regrettably his last few years have not been easy or free from ill health. He will be missed by us.

Our Metcalfe 35th anniversary muster and AGM was duly held at Tennants Garden Suite, Leyburn. You will be able to read about the day and see photographs in this Mecca News. It is our Society's main event of the year, made special this time as we celebrated our 35th anniversary, by a change in location from previous years. The venue was superb-brand new state of the art premises with spacious and comfortable rooms and a good cafe and restaurant downstairs. We would not exist if it had not been for her and the late Vera Adams who founded the Society.

Dr George Redmonds gave an excellent thought provoking talk after lunch which was well received. He is an excellent speaker and we were very fortunate that he agreed to come. Stephen Benson the chairman of the Federation of Family History Societies visited us too and stayed throughout the day, which was an honour for us.

At the AGM I am pleased to say Dr. Michael Pope, the son of Dorothy Pope one of our earlier members, was elected onto the committee. He is most welcome. The rest of the committee were re-elected for another year. No one was appointed though as a replacement treasurer for Marsden Holden who stepped from that post. Vivienne Metcalf also retired. I would like to thank them both for the time and effort they gave whilst on the committee.

We also elected a new President Nina Benson who took over from Charles inequality who had held the post since 1997. My renewed thanks to him for serving as our President so well and for so long! I congratulate Nina upon her election as President. She was accompanied to the muster by her grandson, who said he would like to return next year as he had enjoyed his day so much! We have just agreed to hold our next Muster at Tennants once more, on Saturday 8 October 2016, so he will able to do so!

One of the highlights at the Muster was the launching of our new website. Diane Howarth demonstrated how it worked and showed us how to use it. It has a new design, lavout, clearer navigation and more useful information. Do look at it if you have not done so We also elected a new President Nina Benson who took over from Charles Metcalfe

recently. Thanks to Carol Herbert, our webmaster, who dealt with the technical side of setting up the new site. It was good to see her too at the Muster. Earlier in the year Diane encouraged us to look at our society's Facebook page which is regularly updated by her. At the point of writing we had 337 'likes' and 300 'post reaches' according to google analytics. I was delighted to see on it that member no. 1369 Fred (William) Parker in Minnesota had been the guest of honour (should that perhaps be spelt honor?) at a Veterans Commemoration event and sat next the State Governor. He will be remembered by several of you from previous Musters when he visited with members of his family.

George Redmond's in his talk challenged researchers generally to find evidence for what they believe and state to be true. Where is the written evidence? Can we prove in records rather than hearsay that William de Dent's progeny became known as Medecalf / Metcalf(e)? There should be records if they did so. I cannot answer that point but given the recent anniversary of the battle of Agincourt I wondered about the Agincourt rolls and searched those online to see if our Metcalf was named in the retinue of Lord Scrope. He was not listed in the muster rolls I was able to check online. That is not to say he was not there. The rolls are not I believe complete. I started also on a red herring having seen that Lord Scrope was, before the battle, arrested with others and executed for treason by the King when he was in the south of England preparing for the voyage to France. Did that explain why there is no Metcalfe? Would he have served if his lord had been guilty of treason? Our editor pointed out quite rightly that the traitor was the 3rd Baron Scrope of Masham and that he was not one and same as Lord Scrope of Bolton Castle. I have found an article by the College of Arms which explains all at http://www.college-of-arms.gov.uk/news-grants/news/item/119-the-battle-of-agincourt

I see that a firm in Cumbria- Atlantic Geomatics - has been working on a project to record burial grounds by taking aerial photographs using an unmanned aerial vehicle, which flies about 40 to 50 metres high. Images are also taken at ground level. By combining the photographs a 3D map is prepared. They also scan burial registers and photograph stones so that a complete digital record is created. A number of churches in Cumbria are on the system. The group is keen to encourage more churches to become involved. I wonder if they would be able to work in the Dales? Is this the way ahead? [I saw this on pp32-34 of Cumbria November 2015 issuel

I hope you have all enjoyed being members in 2015 and that you will continue in 2016. May I end by wishing you all a very Merry Christmas and a happy and successful 2016.

Edgar Metcalfe, The Theatre, Emmotts, Lee Ingleby

The item in August's Mecca News (page 21) about the death in Australia of Edgar Metcalfe, known as 'Mr Playhouse' and a 'Legend of Theatre', interested me because of the details of his early life in Blacko, near Nelson in Lancashire. The information that he was adopted by Tom and Mary Emmott of Stone Edge Farm led me to look further into Tom's background, as I felt that there would be a link between him and a George Emmott who married my fatherinlaw's sister. He (my fatherinlaw) was Frank Metcalfe, born in 1896, his eldest sister being Mary Ellen, always known as Nellie, born in 1893.

In the 1891 census I found a large Emmott family living at a farm, Blears Side, near Thornton, Skipton. William Emmott, a farmer and mason, and his wife Martha had eight children, the youngest of which was Thomas, a baby under 12 months old. The next youngest son was George aged five. Among the three girls in the family was Esther Jane, then aged 14.

Moving through to the 1911 census William and Martha were by then at a farm called Higher Gills, Rimington (not far from Blacko), with one daughter and two of their sons, including George. Esther Jane was married to Ernest Hargreaves, had five children, and was living at Little Stone Edge Farm, Blacko. Thomas Emmott, Ernest's brotherinlaw, was also there, aged 20, working on the farm. So this establishes Thomas in Blacko, clearly he was still there when Edgar was adopted. George married Nellie Metcalfe in 1917; they had a son and two daughters, one of whom, Mary Emmott, married Christopher Ingleby in 1937.

From this marriage there is another association with the theatre. Mary and Chris's grandson is the now well established actor Lee Ingleby, who has played in many television dramas. Perhaps his best known role is that of John Bacchus in George Gently, with Martin Shaw as the title character. Most recently he took the lead as George Mottershead in Our Zoo, the story of the establishment of Chester Zoo, and he also had a small part in the film Mr Turner. I remember going to Chris's funeral in 1997, when Lee was about 20, and being so impressed when he movingly read "a poem for Grandad". I'm sure that Edgar Metcalfe would have welcomed this other Emmott connection with the theatre.

do brag a bit when a series of George Gently is being shown, on the lines of Lee's grandma being my husband's cousin. A tenuous link to fame. In the Mecca News context it can equally proudly be claimed that Lee Ingleby's greatgrandmother was a Metcalfe.

VOLUNTARY AID DETACHMENT



1914. It took up to 5 days on average for seriously wounded soldiers to reach a UK hospital from the front line in France.

Getting of the battlefield itself could take hours - in some instances days - especially those who were unable to move and had to wait for stretcher bearers.

Once removed from the conflict zone the wounded were taken to a Regimental Aid Post and then depending on the severity of their injuries to a mobile Advanced Dressing Station (still within a few miles of the battlefield). Those needing more intensive treatment went to a Casualty Clearing Station with the most serious cases transferred to larger hospitals on the French Coast or shipped back to England for longer term treatment and/or convalescence.

Where they were sent back to in 'Blighty' was a matter of chance dependant upon the vagaries of transport and hospital availability. So many ended up well away from their base/home.

The Government was prepared for casualties having worked on plans for dealing with the wounded since 1909. By the commencement of hostilities they had some 7000 hospital beds plus a further 12000 beds at Territorial Force General Hospitals. Casualties overwhelmed these facilities.

An expansion of existing hospitals, establishment of special military hospitals and the setting up of auxiliary and convalescent facilities by voluntary organisations increased the beds available to some 360,000 by the end of WWI

Auxiliary hospitals were mainly set up by the British Red Cross and the Order of St John and known as the

Voluntary Aid Detachment.





Initially wounded and convalescing soldiers were put up anywhere where they could be housed - civic buildings, ordinary houses, church halls and the like. This position rapidly changed and large private family houses were volunteered. These premises whilst not ideal for major surgeries were right for minor operations and those recovering and convalescing.

The VAD's offered professional nursing care and were run along military lines. The detachments were either run by men with over 50 volunteers or by women who ran VAD's with smaller numbers (around 24). With many of the men on war service it was difficult to staff these larger establishments, so a majority were female run.

They were controlled by a commandant (often the female owner of the house) and a trained nurse. The remainder of the staff tended to be volunteers with up to 10 in a section including a least four good cooks. These volunteers were mainly married women or young girls often from domestic service working part time without pay although they were often paid expenses.










Some 3000 large houses (often stately homes) were used and whilst not ideal for surgery provided space for beds and outside facilities for recovering combatants.

The beds were regularly changed and the soldiers were allowed a few creature comforts both on a personal and on a group basis.

The large halls were ideal for a soldier's mess and rest area.







The cost was covered by the voluntary organisations under the auspices of the Joint War Committee.

Between the Red Cross and the St John's Ambulance Service over £21m was raised which covered the major funding requirement.



Some of the recovering soldiers had major disfigurements or suffered serious traumas due to their experiences. Many of the younger women found their VAD service harrowing having to deal with these cases and on occasion assist with surgery.

They were in close proximity to the injured throughout their shifts and the nurses station was often only a curtain covered space in a corner of a large room off the main ward.





Run along military and hospital lines the VAD had strict times for meals, recreation and any visitors. When the Medical Officer (MO) made his rounds those able to stand to attention were expected to do so whilst those bed bound were expected to lie at attention.

The VAD's began closing after the 1918 Armistice although many were still operational for twelve months or more afterwards. Some 1.2m patients were handled by these hospitals.

In 1920 the British Red Cross and the Order of St John recognised the efforts of their volunteers (who were not eligible for any military awards) with a medallion.

To a packed audience Dr Redmonds opened his talk by challenging information available in current publications!

is talk was on the sources of surnames. Most surnames originate between 1250 and 1550 and whilst many are personal names others relate to places, trades, and nicknames. Often those with place sounding names are not necessarily the source.

The assertion made at the beginning of the talk was that as genealogists/historians we should investigate and test the sources we use. Whilst many of the publications are by learned researchers we should ask what their expertise is. Many of them approach the investigation of surnames from a certain point of view which is coloured by their own area of interest. We should use a number of sources. We should also be aware of the style of language of the time as meanings change over the passage of time distorting the original meaning.

As family historians we should investigate the documentary evidence from the time under review. That might include rent records, tithe and land grants for example. *Subsidy Rolls* 1510-1547 (Yorkshire Records - Vol 145 by Professor Hoyle) were considered a useful source (although he suggested we ignore the index and concentrate upon the content!) as well as Hearth tax Records from the 1660's. Other sources included Richmondshire Wills, North Riding Quarter Session records and Ribblesdale by Chris Spencer amongst others.

One of the records lists a **George Edward Metcalf** (record No 36609).

On a whim I followed George up and found the following:

He was a member of the crew of the Georgic (Official no 105326)

and his details from the list gave his age as 51,

First Engineer born in Liverpool.

The Georgic of the White Star Line of Liverpool (owners of the Titanic) had a short history. In early 1916 whilst on passage from the USA with supplies and 900 horses it was intercepted by the German raider (Auxiliary Cruiser) Moewe and sunk. The crew were taken prisoner and spent the rest of the war as POW's in Brandenburg.

George was not one of them having left the ship earlier. Film of the sinking can be seen on *Youtube.com/watch?v=dp9XTZcNMjE*. From our own records I found that George had been baptised in early 1864 in Liverpool, married Agnes H McBride in 1884 (who died in 1906 aged 47) had a daughter Agnes Hood in 1889 and seemingly died in 1933.

Mecca Plantation Owners and Slave Masters

he enslavement of nations/families/individuals has been a feature of human development throughout the ages. It is mentioned in the books of The Bible (Genesis/Exodus) when the Egyptians kept the Israelites captive. There are many more examples:- from the Romans - whose economy depended upon slaves - to the Celts/ Saxons/ Danes/ Norsemen through the Norman Conquest - where England was enslaved - right down to modern times, when the practice is often more subtle but still undertaken.

n the 15th and 16th centuries Spain and Portugal discovered the Americas and undertook the colonisation and development of these "new lands". The native peoples were killed or beaten into submission and as the Americas economy grew so did the need for workers. Whilst Europeans took advantage of the opportunities many were not suited to the climate or the conditions. The Iberian conquerors looked to their African colonies to satisfy the demand.

frican tribes had fought each other for generations and often enslaved the beaten tribes people or sold them to other tribes or Arab traders. It was only a small step for them to supply the New World developers with these unfortunates especially as they often received guns in exchange, further enhancing their superiority over local tribes.

Spain and Portugal's influence waned as the other European maritime powers such as Holland, Denmark, France and England became more aggressive looking to take advantage of the opportunities on offer.

y the early 17th century the British were in the ascendency in the Caribbean - they took over Bermuda in 1609 and were expanding in North America. Colonists flocked to these new territories but there were still not enough of them. Consequently the French, Dutch, Danes and British copied their Iberian cousins and sought human supplies from Africa.

oncerns around the slave trade and the moral issues were being expressed as early as the 1700's. However the supply of goods in particular sugar meant that commerce held sway. It was not until the 1780's that the anti-slavery movement which included William Wilberforce started to gain ground. However they encountered many difficulties and setbacks and it wasn't until 1807 that their campaign prevailed when the British Parliament banned the slave trade by stopping the transportation of slaves in British vessels. However they had not banned slavery. It was another 26 years before it was banished from British Territories.

ome 1 million Africans were shipped to the Caribbean and North America in the century up to the British ban. (Altogether some 8-12m people were estimated to have been transported to the Americas between the 1500's and the mid 1800's.)

which the banning of slavery from the British Empire (except British India) in 1833 Parliament sought to recompense those slave owners who were now making losses due to the freeing of their slaves. The 1833 Abolition of Slavery Act set aside some £20m for this purpose. Those granted compensation were listed in a Parliamentary return of 1837-8 (Volume 48) together with the sums allowed and the number of slaves affected.

The UCL (University of the City of London) has set up two projects tracing the impact of slave ownership on the formation of modern Britain - Legacies of British Slave Ownership and The Structure and Significance of British Caribbean Slave Ownership 1763-1833. Part of the work undertaken in these recently completed projects was the extraction of the lists of compensated plantation owners and amongst them were a number of Meccas.

One large plantation and slave owner on the list is **George Metcalfe** of Rigg House, Hawes and his wife **Elizabeth**.

George's involvement in the slave trade was part of a display on *Africans in the Dales* shown at the Dales Countryside Museum in 2009 and his grave lies at the front of St Margaret's Church Hawes. He died in 1821 but the beneficiaries of his will who took over his plantation on his death received compensation. They were his widow Elizabeth and relatives

Edward Metcalfe, John Wilson Metcalfe and Robert Metcalfe who may have shared nearly £3750 for their holdings.

There were two others:

based in Kingston Jamaica

Rebecca Metcalf who received £58 12s 6d for 3 *enslaved* and **Robert Metcalfe** who was granted £55 11s 4d for 5 *enslaved*.

have digitised the Archbishop of York's church court records for the period 1300-1858. Known as the *Cause Papers* these records deal with matrimonial/wills/tithe/defamation and church matters. They hold a wealth of information concerning their time and attitudes. A fascinating social snapshot.

There are some 126 Meccas mentioned as plaintiff, defendant or witness.

Yorkshire Group meeting, 25th July 2015

The meeting opened with a talk by Keith Sweetmore, who is well known in the county, having worked for both West and North Yorkshire Archive Service until fairly recently. He has now been appointed the Engagement Manager, for the North of England, for the Archive Sector Development, The National Archives. Keith reported that TNA has a collection dating back to 974AD, and contains 12 million records. There are 4 Engagement areas, North, West, East and London, and they work as advocates for archives, developing networks and partnerships, as well as conducting inspection of 'places of deposit'. His job covers 450 archives in the 7 historical northern counties. TNA is responsible for accrediting all archives – not necessarily to criticize, but to suggest ways of improving the service. The Explore Your Archive event, for November 12-24 2015 will promote use of archives as well as involving media and organising special events.

Keith's 'big' project is Ancestral Tourism. Yorkshire was chosen as it has the strongest regional identity, and a unique diaspora of population over the years, with Yorkshire men and women spreading to virtually every part of the world. He would like assistance in quantifying the number of Yorkshire people who have travelled overseas, and to where, so this can be harnessed into a programme publicising this unique asset the county has. It is hoped that it could be used to boost tourism, as well as the use of archives and family history resources. Access will emphasise that although there is a tremendous amount of material online, more information is available in the archives and on the ground.

Potential Ancestral Tourists are people 45+ years old, 'empty nesters', singles or couples with a high disposable income but with time on their hands. They are often computer savvy so need to convinced that there is more to find within the county. They will often visit frequently, possibly out of season, go to less 'popular' destinations, and they will be looking for a sense of belonging and pride in the county – all of which local family historians are very good at demonstrating. This could help to promote our Family History Societies, but we also need to do our part in producing useful and informative web sites and documents, as well as encouraging visitors to look at family history trails around the county.

The Metcalfe Society is already well on the way to doing this – with our Muster attracting both members and non-members to the Dales every year. Those from overseas or more distant parts of the country often come for days or weeks, and travel around the county, contributing to the economy as well as learning about their personal family history, so I believe we have a major contribution to make to this project.

There was a report on the Who Do You Think You Are exhibition in Birmingham and it was very successful. Plans are advancing for WDYTYA 2016, again in Birmingham, and members in the area are invited to volunteer for a short period on the Yorkshire stall to help visitors. Arrangements can be made for admission and parking concessions to all helpers – if you are interested, please let me know. Find My Past plans to release the 1939 Register are well advanced and should be released in November 2015. It was thought that for less

England Jurisdiction Maps

The London FamilySearch Centre can be found on the first floor of The National Archives at Kew. It is extensively used by family historians who consult its large stock of films of parish registers and other resources.

The Centre's recently upgraded website now includes a series of interactive maps showing the boundaries of a range of key jurisdictions in England as at 1851. The separate layers available include:

- Counties
- Civil registration districts
- Dioceses
- Poor Law Unions
- Hundreds

For each layer, you can zoom in to parish level and confirm the relevant jurisdiction. Readers can choose from three different background options:

- Map: A simple map
- Satellite: Modern aerial view
- Ordnance Survey: 19th-century Ordnance Survey map

When you find an locality of interest, you can home in on "street view" or follow up a range of options such as compiling a list of parishes within a particular district. Your search can also move on to discover associated material in the Library catalogue and Research Wiki .

Navigation is supported by a written introduction.

This facility is a major boost for anyone with English ancestry. It is particularly helpful if you do not live in the same area as your forebears and are unfamiliar with the record-keeping organisations that operated there in the past.

Manorial Documents Register (MDR)

We would like to update you on the search within Discovery (http://discovery.nationalarchives.gov.uk/manorsearch), which we launched earlier this summer. The new MDR search replaces the nationalarchives.gov.uk/mdr platform, which will be retired on 30 October 2015.

The MDR identifies the nature and location of manorial records. A standard Discovery search will show general information about manorial records held at The National Archives and elsewhere; the powerful new manor search tool provides information about manorial records as defined by the Manorial Documents Rules.

More and more researchers from across the UK and beyond are using Discovery to find information about records held by other archives. We hope that integrating the MDR into Discovery will increase its visibility and make the service more accessible to all users whether they are familiar with using the MDR or not.

Originally a paper based register, the MDR is gradually being updated and made available online. You can find up to date information about this work on our project page (http://www.nationalarchives.gov.uk/archivessector/manorialdocumentsregister.htm). We would like to say thank you to all of those who have contributed to the growth of the Register and to the generosity of the funding bodies who have supported this.

The landing page for the manor search retains the title of 'Manorial Documents Register'. This is an acknowledgment of the legal status of the MDR but also demonstrates our commitment to its delivery and presentation as a defined entity in Discovery.

We have sought extensive user feedback throughout the development process and we have already implemented a number of enhancements to ensure that this resource offers the same high level of service as its predecessor. We continue to welcome feedback on the development of Discovery, which helps inform our ongoing programme of documenting, prioritising and developing enhancements.
