One Day Conference at Spofforth held by the Guild of One-Name Studies Saturday 24th March 1984.

Over 60 people attended the conference representing 20 One-Name Groups. Each group was allotted table and wall space to display any material they had. The displays were interesting and revealed the enthusiasm and hard work put in by members of each group. Most groups produce a Newsletter two or three times a year; many displayed family trees, copies of documents and albums of photographs, letters, newspaper cuttings and other ephemratics.

The opening speaker was Mr George Pelling, the Chairman of the Federation of Family History Societies, who discussed the general legislation for protection of records. As access to archives is vital for genealogists the possibility of charges being made for this caused him some concern. The matter has been raised in Parliament and, although a motion was passed by the Lords condemning charges when the Bill got to the Commons, it fell. The question was raised at the Brighton Conference in September 1983 but to date there has been no revival of the Bill but it is every possible. So we all know what to expect:

Mr Pelling also warned members the effect dismemberment of the Metro-politan Boroughs may have on archives. The creation of the C.R.Os played a great part in record keeping and it is feared that the new legislation may have the reverse effect as existing offices may have to be split into smaller units.

After coffee Mr Alan Wise, Head of the history department at North Axholme School, Crowle spoke about using a computor to store records. He advised any would-be computor recorder not to write his/her own programme but to buy a Standard Data based programme which will accept family history records. He himself has recorded all the parish records for Crowle on a computor and stressed the importance of using good discs and not to be tempted with cheap offers. He added that computors must not be the only way of recording and advised another aid in case of failures or power cuts. He illustrated his own way of recording on a computor with the use of an overhead projector.

Four One-Name Studies followed the lunch break. They were the Beresford, Ethell, Hebden and Parley families. Doug Beresford, who has written a book on family history said it was important to record the family of the present as well as the family of the past as both form the family history of tomorrow. Pauline Litton speaking for the Ethell family began her study in the early 70s, before One-Name Societies existed when Portugal Street still had the original Census Books available to researchers. These have since been put on microfilm. John Hebden speaking for the Hebden family had a great deal of work done by a predecessor, William Holden of Halifax, which is invaluable to the group today. Finally Mary Griffiths, for the Parley family spoke of the advantages and disadvantages of researching a very small family group. She said all the Parleys were related and the family had been connected with the lace trade. She was very anxious to hear of anyone bearing that name.

After a break for tea Derek Palgrave, Chairman of the Guild of One-Name Studies chaired a question and answer session which gave many people the opportunity to clear up any difficulties and misunderstandings.

The Conference ended at 4.15 pm.

"Lodge Hall, a fine upstanding house, used to be called Ingman Lodge, it stands on the valley side, 5 miles North of Horton in Ribblesdale, looking out over the drumlins to Pen-y-ghent, one of the finest buildings in the whole area. Unlike most of the houses hereabouts, which wisely face South, Lodge Hall faces Fast. The windows are glazed with diamond-shaped panes, set in lead. In the south-east corner is a strangelittle window set in the angle of the house and facing both southwards and eastwards. The front door is impressive with a heavy carved stone arch above it and a date stone set under the arch and carved C W 1687. On each of the stone uprights either side of the door

The front entrance leads through a porch to the living room and in the opposite wall a passage leads to the main staircase which is built of stone slabs, with great stone slates forming the half-landings. The stairs lead to the first and second floors. On the first floor are three bedrooms, the front room, at the south end, having a little powder closet in the corner, lit by the small oval window which is visible from outside at the front. A powder closet has no connection with todays euphemistic "powder room", it was the little room where the ladies and gentlemen of the eighteenth century went to have their wigs powdered, the scented flour must have flown all over the room.

The second floor, where the roof beams are in a sad state of disrepair, contains the attics.

The initials on the door stand for Christopher Weatherhead, a Quaker, who bought the house and evidently re-built it c 1687. People have been living on the site for centuries. Like Nether Lodge and Colt Park it was a grange of Furness Abbey. It is said to have served as the judge's lodgings for the Assize circuit and this gave it the older name of 'Angman's (Ingmans) Lodge'. Another legend has it that murder was committed in the bedroom next to the powder closet, where a stain on the boards remains as evidence.

There is a Quaker burial ground under the trees opposite the house and nearby the ruined walls of a building that may have been a meeting house.

A track leads up to the Horton - Ribblehead road where, at the bottom of a dip, lies Gauber, a small farm. Beyond lies a meadow with the name of 'Dismal', it gives credibility to the 'Angman's Lodge' story, surely the meadow once bordered the crossroads where the old road from Horton met the turnpike road leading from Lancaster to Richmond. (Gallows were traditionally erected at cross-roads)."

The foregoing is an extract from the book "The Three Peaks of Yorkshire", published 1983 by Wildwood House Ltd and written by Harry Ree. Mr. Ree's theory that the house was originally called 'Angman's Lodge' is interesting, but surely rather far fetched?

Also if it was ever a Quaker Meeting place it must have been for only a short time, in c 1712 James Metcalfe was farming at Lodge Hall. I learn from Helen Offer that this James Metcalfe was married 1703 to Margaret Standing at Arncliffe, and their four eldest children were baptised at Arncliffe, the family were then living at Cosh. Their younger children were baptised at Ingleton Fells, from 1713 - 1725. (There was a total of 9 children). They were then at Lodge Hall.

On James's death in 1747, the farm was taken over by his son, George, who survived his father by only 8 years and was then succeeded by his (George's) son, William - only 15 years old. As far as is known William had three daughters and no sons. In 1777 another George Metcalfe was farming at Lodge Hall but it is not known which was his family or where he came from.

Research into the Metcalfe families of the eighteenth century in the area Horton in Ribblesdale - Ribblehead - Chapel le Dale, is extremely difficult, there were so many of them! In fact it almost seems that this area was entirely populated by Metcalfes, at that time.

# THE METCALFES OF RAISGILL, ASHES, AND GAUBER

I am able to add to Mrs. Benson's history of the Metcalfes of Raisgill which appeared in IMecca News', No. 11. According to the parish Registers of Ingleton and Ingleton Fells, Christopher Metcalfe of Horton parish and Catherine Leake of Ingleton parish were married in Ingleton by publication on 22nd January, 1697/8. A year later on 30th January, 1698/9, Phebie a daughter of Chris. Medcalfe was baptised at Ingleton and on 27th March, 1700 Chris Medcalfe of Razegaile had a son George baptised at Ingleton. On 21st May, 1699 Phill a daughter of Chris. Medcalfe was I can only think that this is a clerk's error for buried at Ingleton. Phebie. Katherine wife of Christopher was buried in Ingleton on 19th November, 1743, and I think the Christopher, householder, buried at Ingleton on 6th November, 1757, is this Christopher. I cannot discover another birth in Ingleton, Ingleton Fells or Arncliffe that could be assigned to this family.

It is a little puzzling that they should go so far from Raisgill when the church at Hubberholme was only down the road. However the fact that Catherine came from Ingleton may explain this. She may have been delicate, which is perhaps indicated by her having only two children, and had gone home to her parents for her lying in. Her child was buried in Ingleton and therefore the parents used the same grave for their burial.

On 26th September, 1742, Frances Metcalf, a convert (? from Quakerism) then living at Raisgill was baptised at Hubberholme. This was whilst the first Christopher was living there. Was she any relation to him, a niege perhaps brought in to help his wife in her middle age? Catherine died the next year. The next day, 27th September, Frances married Martin Sympson of Raisgill. Martin may have been a farm manager or help for Christopher and presumably ran the farm after Christopher's death in 1757. He and Frances had a daughter Margaret who married the second Christopher who came from Aisgarth parish, on 7th December, 1772. This Christopher farmed Raisgill until his death in 1788. The transcript from the parish registers for Arncliffe and Hubberholme stops at 1812 and none of Christopher's sons appears on it as having children before that date.

But what happened to George the son, of the first Christopher?

We have, however, the will of Christopher son of Christopher and Barbara nee Swinbank, baptised 1784. He became the farmer of Ashes in Horton-in-Ribblesdale and his will is dated 14th January, 1828, probate being granted on 11th November of that year. We know that they are one and the same as he mentions his sister Francis (sic) wife of Reuben Downham; his sister Barbary wife of John Spence; his sister Mary Metcalfe and also hisnephew Alexander Metcalfe of Gauber son of John, who is not yet 21. For Alexander to be his nephew John must be his brother -or half brother - and is therefore John, the base born son of Barbery Metcalfe, widow of the second Christopher. Christopher of Ashes had, apparently, no children living nor is there mention of a wife.

John of Gauber had married Ellen and had according to the 1841 census Alexander born c. 1825; Barbara c. 1827; Betty/Elizabeth c. 1828; John c. 1830; Jane c. 1831; James, c. 1832; Mary c. 1834; Ellen c. 1836. By the 1851 census he is dead and hiswife Ellen born in Ingleton is running the farm of 500 acres with no labourers but with all her children except Barbara, all being unmarried.

By 1861 Ellen does not appear in the census for Gauber. Alexander

has married Ann, born in Melling, Lancs., and has his brother James, age 26, as a shepherd. By 1871 he is a farmer of 515 acres employing two servants, with wife Ann and daughters Elizabeth, born c. 1865; Jane c. 1867; and Barbara c. 1870 with them. His children Ellen born c. 1862 and John c. 1863 are not with them.

In 1881 he is still living at Gauber, stating that he was born at Ingleton, with wife Ann, Ellen, John, Jane, Barbara; Mary born c. 1872; Agnes c. 1874; Alexander c. 1877; and James, c. 1879. The farm is now of 535 acres.

On November 8th, 1893, Alexander died age 68 according to his grave in Horton-in-Ribblesdale churchyard, and his widow Ann, age 80, on 11th April, 19? at Tunstall.

He had two other children, Robert born c. 1866, died 4th February, 1866, and Alexander born c. 1869 died August 15th, 1869; and his daughter Elizabeth died 9th September, 1888, all buried with their parents in Horton-in-Ribblesdale.

With a little bit of spare time and a lot of patience I was able to build up the following picture, Isaac's parents and their family.

Isaac was born 1822 at Kilburn , son of RICHARD and HANNAH.

RICHARD METCALF married HANNAH COOPER 11 June 1811 at Kilburn. Wit Robert Mt.

Mrs. Rowlands also mentions that during her research in Lincolnshire, she has found a NINION METCALF and FRANCES, who had children in Winterton, Lincs and later at East Retford, Notts:. His earliest child, William, according to her list, was bpt 1727 and his last in 1748 in East Retford, where Ninion died in 1755 and was 'Exciseman'. Mrs. Rowlands wonders if there is a connection with this family and the Yorkshire Ninions, which occur mainly in the Hawes area.

The index now comprises over 10,000 cards, some of which are single entries, some of which show a whole family with birth, marriage, birth of children, domicile and deaths. There is also a location index giving names and dates of persons baptised, living or dying in that locality. All this has been achieved by the industry of members and their williness to send the results of their researches to the Indexer.

Whilst warmly thanking them for their past generosity, and hoping that they will continue to forward their findings, may I make one or two points that would help me in my task.

1. Please do send lists with the years in consecutive order. It is so much easier for me to check that I have entered the card correctly when I have an enquiry.

- 2. Please remember that until 1st January 1752 the year began on 25th March so that January, 1750, followed December, 1750, and 25th March, 1751, followed 24th March, 1750. To avoid confusion when copying from the parish registers, it is advisable to put both old and new style dates, i.e. January, 1750/1; 24th March, 1750/1. If this is not done one never knows whether the correction has been made or not, and can lead to difficulties.
- 3. Please be as accurate as possible and even more so. Occasionally I get lists compiled from the same parish registers and these do not always agree: names for the same date and parents are not the same; the baptism, marriage, or burial may be at a different church or the date may And when it has appeared that the list has been copied be different. consecutively, from the years, omissions have occurred. I do want your findings but please be very careful in making them. It will help you in the long run in your researches as they won't have to be done again at a later date and they will certainly prevent a great loss of hair on my part!

Inaccuracy is the bugbear of our hobby. The C.F.I. is by no means The Mormons have relied in many cases on very amateur family genealogists tracing their forebears so that they may be baptised posthumously into the Mormon church. And the Parish Registers themselves were often kept by semi-literate clerks who frequently copied them into the Register at a later date from a scrap of paper.
