Re'Convict Ships 1788 - 1868'by Charles Bateson: ....throughout the 'Burnells' voyage in 1832 the crew was insubordinate, threatening the master, JOHN METCALF, with violence and breaking into the spirit room, but they did not refuse duty until after the ships arrival at Port Jackson. Seven of the seamen were charged in the Police Court, but faced with the certainty of punishment, agreed to return to their duty. Three however, were sent for trial and ultimately convicted and sentenced for having broken into the spirit room. This was the second voyage of the 'Burnell' with John Metcalf as master, he sailed from London on 21.1.1832 taking 129 days - with 101 female convicts on board - maybe they were the reason some of the crew decided now was the time for a party and broke into the spirit locker !!

The first 'Fleet' sailed from England in May 1787 - were there any Metcalfes on board?

Re the ship 'Surprise' (see Apl 1987 issue 21 p 13)...this was the first steam ship to be built in Sidney, approximately 1826.



### STARS OF THE SILVER SCREEN

Members of the Society will be well aware that star quality is no stranger to the Metcalfe family. It is therefore hardly surprising to find a number of Metcalfes listed in ' Who was Who on the Screen?' by Evelyn Mack Truitt. These include: James S. Metcalfe:

Born 1901 and died on the 2 April 1960 of a heart attack at Northridge, in California.

A stage actor, he also appeared in the films 'The Iron Claw' (1941), 'The Hardway', 'Who is Hope Schuyler?' and 'A Gentleman at Heart' in 1942.

None of his films, unfortunately, seem to have featured amongst the cinema's classics, although some of our members may well remember having seen them.

Edward Metcalf:

Born 1867 and died on the 2 April 1951 at Brentwood, New York.

A stage, screen and vaudeville actor, he appeared in both the stage production

and the Paramount Pictures screen version of 'Animal Crackers', the latter of which starred the Marx Brothers and is still remembered for many of its classic dialogue exchanges.

### Earl Metcalf:

Born 1889 in Newport, Kentucky and died on the 27 January 1928 at Burbank, in California.

Probably the most intrepid, as well as the most prolific of the family's film stars, his screen appearances spanned the period from 1915, when he moved on from his stage roles into a career in films with Vitagraph, (a very successful early U.S. production company which was taken over by Warner Bros. in the twenties), until his death in 1928.

His career included no less than forty three films, beginning with 'The Insurrection' in 1915, quickly followed by 'Perils of Our Girl Reporters' in 1916. The latter, no doubt a classic, now unfortunately lost to us, was followed by a number of other films in what we might refer to as his 'romantic' period, culminating in his appearance in 'Silk Stocking Sal', in 1924. Unfortunately, 1925 marked a turning point in his career, which was ultimately to lead to his untimely death. This was the year in which he turned to more adventurous roles, with 'Kit Carson and the Great Divide' (1925) and 'The Call of the Klondike' (1926). After this, a fatal fascination with flying began to manifest itself, with his appearances in 'The High Flyer', followed by 'The Airmail Pilot' and 'Eagle of the Night', a serial.

Sadly, the serial was cut short at the beginning of 1928, as was his life, when he was killed in a flying accident.

The official cause of his death was reported as "falling off a plane "thus earning him the distinction of being the only Metcalf(e) in history believed to have perished in this fashion.

### THE CARIBBEAN CONNECTION

In the last issue of "Mecca News", Dorothy Pope M.N. 55, related two legends which she had unearthed relating to certain ghostly goings on involving members of the Metcalfe family.

Dorothy ended her article wondering if either of the Metcalfes mentioned in these stories were related to any of our members. This brought the following intriguing reply from Shirley Withers, M.N. 33, of West Perth, Western Australia.

" I was interested in Dorothy Pope's story about the ghost of Rigg House, as for several years I have suspected that one of the Metcalfes mentioned in these two stories may be related to me.

In 1981, I wrote to 'The Dalesman', asking for information about my great, great, grandfather, John Wilson Metcalfe, who was born in Hawes in 1802 and who had a connection with Birkrigg. Birkrigg consists of two farms across the road from Rigg House. I received a reply from a Miss Snowden, who was, at that time, researching the history of Rigg House for the owner, who was a friend of hers. However, she was mainly interested in the Hillary family who had owned it at various times. Through Miss Snowden, I was eventually able to contact Miles Metcalfe, M.N. 141, who kindly sent me a copy of his family tree going back to the early 1600's. Imagine my delight at finding that a sketched in branch of his tree corresponded with mine. Only a fellow addict could understand the joy of finding oneself being suddenly transported back to the 1600's, after having been hopelessly stuck at 1800.

Before this contact with Miles, however, Miss Snowden had sent me an extract from 'Haunted England' by Christina Hole, which told the story described in Dorothy's article, adding that the problem of the old woman's ghost was solved by 'pulling down the middle portion of the house and destroying the rooms where the ghost walked. Rigg House was thus reduced in size and the smaller cut off section of the building was renamed Rigg Cottage. This rather drastic form of exorcism seems to have been effective, for the old woman's spirit has not been seen or heard of since.'

Miss Snowden was dismissive about this story, saying that the house was divided in the early part of the nineteenth century, sometime between 1807 and 1841 and that there is a local story of two sisters who quarrelled and divided the house by pulling down the centre part.

However, a copy of a map sent to me by Miles Metcalfe, dated 1807, shows that the house had already been divided into two parts before that time.

Now back to Miles' tree, This showed that my great, great, great, great, great, great, grandfather, Isaac Metcalfe, who was born in 1725, had a brother, Robert, who had two sons, George and Robert, both of whom had lived in Dominica. George returned to England where he married Elizabeth Davis of Gargrave in 1812, when she was 26 and he was 55. They both lived at Rigg House until he died in 1821 and she died in 1846.

Nina Benson very kindly let me have details of the inscription on George's tomb stone, which is as follows:

' For many years President of Council of Dominica, Colonel of the St. George's Militia in that Island.

Miss Snowden has also advised me that he was appointed one of the Lands Trustees of the Manor of Bainbridge in 1816. He left quite a lot of property, with a life interest to his wife, Elizabeth, but specifies that 'I further will that my dear wife shall not marry again ', otherwise she would lose the entire estate. His will also refers to his 'estates, negroes and houses in the Island of Dominica 'and one of his heirs is described as 'of Dominica 'as if he were out there managing the estate.

I have explained all this as George Metcalfe fitted the description of the slave owner from the West Indies insofar as he had property and 'negroes' in Dominica and lived at Rigg House from 1812 until he died in 1821. However, as he appears to have led a public and exemplary life he apparently was not the slave owner in the story and, in any event, it would seem that the house had been divided into two before he lived there.

His brother, Robert, however, is a much more shadowy figure. In fact I have been able to discover nothing at all about Robert, except that Miles Metcalfe's map of 1807 shows a large area of land surrounding the houses of Birkrigg as being 'Mr. Robert Metcalfe's land '.

As Robert was not mentioned in his brother, George 's will, in 1821, I think that he must have died before 1821, unless, of course, he was the notorious slave owner who had been forced to leave the area because of the gossip and dark suspicions of his neighbours, as described in Dorothy's article and had been cut out of his brother's will.

There is a little more to the story. Last year, a Jane Metcalfe sent me, through Margaret Metcalfe, a cutting dated 1982, from the 'Northern Echo'.

'The sale of a strange house has re-opened the intriguing mystery of a bickering Dales family who literally divided their home.

Details of the ancient family feud have vanished into the mists of time and all that remains are the two houses - separated by a tiny gap. Yesterday the owner of Rigg House, of Hawes, Mrs. Mgt. Haighton, said the house is up for sale as a whole. 'It's terribly sad as it's the nicest house in Wensleydale, 'she said.

The forgotten quarrelsome family is believed to have demolished a music room and dining room to end a war of words between two sisters and today the historic house is still in two pieces.

In nearby Hawes, Rigg Lane is known as 'the haunted house 'and local legend tells of how part of the house was knocked down to force out a ghost.'

These stories were dismissed by Mrs. Haighton, who said that during the twenty

years that she had lived in the house there had been no trace of ghosts. The paper went on, however, to quote Hawes Primary School teacher, Roger Stott, who said

' I know a number of people who have lived there and all swear that it is haunted.'

He added that there were even stories that the house was haunted by the ghosts of slaves who died there when it was owned by the Governor of Dominica.

I promptly wrote to Roger Stott, but his reply merely said:

'I think the haunting story comes from local folklore concerning the Governor of Dominica who according to legend employed black slaves at Rigg House. Legend has it that several of these poor creatures died there and were buried round about which is not impossible given the era and the rules about consecrated ground.'

Shirley says that she has visited Hawes twice and visited the Birkrigg farms, but, unfortunately, not Rigg House, as she did not know much about the haunting story at that time. Her theory is that the story could well be an amalgam of happenings, a sort of composite formed over the years, bringing together several different people and happenings to form one story, when there might have been several. She adds that if it is true that the two sisters divided the house, then where did the ghost come from ?

Shirley makes the point that it is extremely difficult trying to track down the truth of the matter from Western Australia. I wonder if any of our members can help her?

### NECESSITY'S CHILDREN

Sal Illingworth, M.N. 242, of Colliers Wood, London, has painstakingly extracted all of the Metcalfe entries between 1617 and 1867 from the list of Patentees of Inventions housed at the Scientific Research Library, Southampton Buildings, in London. (The list continues to date for those of you interested in tracing any patentees after 1867.)

Sal deserves our thanks, not only for extracting all of this information, but also for bringing to our attention a source of which I am sure many of our members were unaware.

Alongside the names of the inventors listed below are given the date the invention was patented, a brief description of the invention in question and its Progressive Number. This number refers to a file which includes the specification and other facts relating to the invention, including the address of the patentee.

Metcalfe, Thomas

7 Dec 1814

P.N. 10.422

Manufacture of brooms, brushes or similar articles.

Metcalf, Jacob

30 Sep 1816

P.N. 4,065

Tapered hair or head brush.

Metcalf, David 21 Nov 1844 P.N. 10,398

Manufacturing or preparing of vegetable preparation appliances to dyeing blue and other colours.

Metcalfe, John 8 Aug 1848 P.N. 12,232

Machinery for preparing and spinning cotton and other fibrous substances.

Metcalfe, Thomas 5 Oct 1848 P.N. 10,595

Construction of chairs, sofas and other articles of furniture for sitting upon.

Metcalfe, Thomas 10 Sep 1853 P.N. 2,098

Portable chairs and tables.

Metcalfe, Thomas 1 Mar 1854 P.N. 506

Manufacture of portable and folding bedsteads, chairs, tables and cots.

Metcalfe, Thomas 7 Nov 1854 P.N. 2,357

Construction of portable carriages, chairs and other articles for sitting or reclining upon.

Metcalf, John 3 Sep 1856 P.N. 2,043

Manufacture and treatment of tar oil for dissolving india rubber, gutta percha, gums and gum resins and also in deodorising all fabrics, wood or any article impregnated with tar oil or coal tar products.

Metcalf, John 13 Dec 1856 P.N. 2,965

Manufacture of alum - sulphate of alumina.

Metcalf, Tho. 20 Feb 1858 P.N. 328

Purification of crude tar oil, rendering the same suitable for lubricating machinery and other similar purposes.

Metcalf, Henry and Thos. 19 Jul 1865 P.N. 1,875

An improved apparatus for cooling liquids and cooling or condensing vapours or gases.

Metcalf, John 10 Apr 1867 P.N. 1,065

An improved pressing iron and appliance thereto, for use of tailors, hatters, laundresses and also for domestic use.

Metcalf, Thos. 20 May 1867 P.N. 1,487

Burning all hydrocarbon oils, such as creosote, petroleum, parafin oil, shale oil, gas tar and other similar products capable of being used as fuel.

It is to be hoped that all of the above inventors were more successful than Arthur Pedrick of Selsey, Sussex, arguably the world's worst inventor, who patented more than 150 inventions, not one of which was a success. Whilst one cannot help but admire his enthusiasm, one has the feeling that his efforts were somewhat misdirected, as illustrated by his plan to irrigate the world's deserts by sending a continuous supply of snowballs from the polar regions. The nearest he ever came to success was

inventing a golf ball that could be steered in flight, an acheivement that despite its obvious attractions was, unfortunately, totally unacceptable to the governing body of the game.

### WHERE THERE'S A WILL THERES A WAY

Dale Piercey M.N. 227, of Esperance, Western Australia, has been good enough to send us the following precis of three wills and what she assumes to be a declaration of administration relating to the Metcalfe family of Spennithorne.

Although Dale has been unable to trace any connection between the Metcalfes named and her own family, she hopes that the information may be of assistance to other members.

WILL OF JOHN CLARKSON 1724

Left everything to Christopher and Elizabeth Metcalfe, the children of Anthony Metcalfe, late of Spennithorne.

Witnesses: Mary Metcalfe and R. Fleming

MARY METCALFE OF SPENNITHORNE ( This appears to be a declaration of administration )

"The condition of this obligation is such that if the abovebound Mary Metcalfe administratrix of all and singular the goods chattels and credits of Anthony Metcalfe late of Spennithorne ......."

Witnesses: R. Fleming and Christopher Metcalfe Followed by an inventory dated 30 September 1724

WILL OF JOHN METCALFE OF BELLERBY ( SPENNITHORNE )

2 July 1788

Left his housekeeper Mary Brown his linen and plate and gave Mary and her son, John Brown, the right to live in his house, plus an annuity.

Others mentioned were his youngest son Thomas Metcalfe, eldest son John Metcalfe, Matthew Brown of Bellerby, Christopher Theakstone of Constable Burton and Mr. Tamar Williamson of Bedale.

He expressed a wish to be interred at St. Martin's, Outwich, London.

Witnesses: Charles Lonsdale, George Blackburn and Francis Janson

WILL OF JOHN METCALFE OF BELLERBY, SPENNITHORNE ( Blacksmith )

5 July 1797

Mentions his wife, although her name is not given and sons, Thomas, Timothy, William and James.

His sons Thomas and John were executors.

Witnesses: John Walker, Mary Metcalfe, George Blackburn

Dale finds the will of John Metcalfe dated 2 July 1788 particularly interesting in view of his express wish to be buried in London. Does anyone know why? The wills precised above are from the West Yorkshire Archives Service in Leeds.

### MORE TALES OF DERRING DO

In our last issue, we featured the story of Lance Corporal William Henry Metcalfe, V.C., whom we subsequently learn was promoted after the end of the First World War to the rank of Lieut. in the York Regiment, C. Comp., St. Stephen, New Brunswick and retired in 1936 to live in his home State of Maine, in the U.S.A.

News of yet another Metcalfe decorated for bravery during the First World War comes from Paul Metcalfe, M.N. 137, of Thirsk, Yorkshire.

This concerns Private A. A. Metcalfe, No. 2016, who was a member of the 1st Battalion, the Manchester Regiment. His battalion arrived in France in October 1914 and formed part of the 3rd Lahore Division; Jullunder Brigade, under Major General P.M. Carnegy, which was part of the Indian Expeditionary Force.

Soon after their arrival in France, the 1st Manchesters were placed at the southern end of the British line, in the Cuinchy - Givenchy area.

During the fighting at Cuinchy, on the 11 December 1914, Private Metcalfe crept out, under fire, to the body of a dead German officer, lying some eighty yards in front of the British trenches, to obtain his papers, which he managed to bring safely back to his own lines.

Two days later, on the 13 December, he again showed both coolness and courage under fire, when he insisted upon remaining at his observation post after the British trenches had been vacated and he, himself, had been wounded.


The 'London Gazette' of the 14 January 1915 shows that, for this, he was awarded the Distinguished Conduct Medal.

Are there any more heroic Metcalfes that you know of ? If so, why not write and let us know, particularly if they were in the navy or the airforce - why let the army have all the glory ?
