#### MECCA MUSTER & AGM 13th OCTOBER 1990.

79 members and their guests attended at Ripon College on a foggy morning which did not help some members find their way across the mountain tops, however they were greeted with a hot cup of coffee and soon settled down to the business of the AGM chaired for the last time by John Holden who will be missed by all - though we do hope to see him at future AGMs.

After Apologies were taken and the Minutes dealt with the full Constitution as approved by the Charity Commissioners was read through by the Secretary and it was formally adopted unanimously. John Holden and Valerie Metcalfe were thanked for their work.

The Secretary reported a slowing down in new memberships, at present we have 316 active members, in 1989 we gained 86 and lost 31, this year we have gained only 38 so far. She particularly welcomed Canadian member Joe Awmack whose Metcalfe ancestors came from Ripon. The Treasurer reported a current balance of £ 2732.76 and answered queries on all the accounts. The Editor made his usual plea for articles, large or small. He had brought along a very impressive display comparing A4 and A5 format for future Mecca News production and invited all members to examine it thoroughly and to indicate which they preferred, without ANY doubt the A5 format, with no reduction of print size, won the day.

The long awaited publication The Index to Lists was on sale and we thank those members - Susan Liptak, Diane Howarth, Charles Metcalfe, Sandra Metcalf and Kay Davey - who have worked on the projection over the years. Our Data Registration only needs formal authorisation.

Copies of the etchings by an unknown Metcalfe artist were on sale and we thank Warwick Metcalfe for providing these and for donating the whole of the takings (£ 28.00) to the Society. Mary Metcalfe brought along some samples of her artistic work and we aslo thank her for donating £ 30.80 to the Society.

When election time came around the following were duly elected :- Chairman - Charles S. Metcalfe. Secretary - Nina Benson. Treasurer - Margaret Metcalfe. Editor - Stuart Metcalfe. General Committee - Vera Adams : Carol Arkwright : Denny Gibson : Diane Howarth : David Lambert : Joe Metcalfe : Stanley Metcalfe .

Diane Howarth offered to begin a photographic record of the Society so members are requested to send in copies of any photographs taken over the years.

After the AGM Founder Members Vera Adams and Mary Metcalfe cut the delicious 10th Anniversary cake, a piece of which was sent, together with a 'Best Wishes' card, to Jean & Frank Bradley. Members enjoyed a thoroughly good luncheon and then went on to browse through all the records - chat to other members from far & wide - some of us also discovered new 'cousins' providing a perfect ending to a great day. Come and join us next year - Saturday 12th October 1991.

The Dalesmen of the Mississippi River by David Morris. £ 7.95

## Remarkable Potholing Discoveries beneath Dambrook House owned by John Moores of Littlewoods Pools.

......"the pothole found when workmen poked an iron bar through flagstones in the yard of Dambrook Farm, near Amcliffe, Littondale, immediately beneath the kitchen window, is a mile long with many passages still to explore......David Hodgson of Settle, who undertook the early exploration said.."I had no idea of the discoveries to come, when I arrived the entrance was just an apparently insignificant hole in the kitchen wall in the yard."

As David descended on a potholing ladder he noticed "shotholes" in the wails, and found a circular drystone wall about 2 feet high on the rocky floor 22 feet below. After some 70ft of an undulating dry passage came the brink of a short climb down into a chamber, where a stream welled up from the floor and sank amid boulders after a few yerds.

To his surprise on the walls were scratched the names with dates of J.Metcalle (1862) John Gill (1862) Thos. Coulthard and W.Ward (1867) J.Lee (1867) W.Morrison (1867) and what could either be John Colton or Polion (1862).

It looks as though W.Morrison was the Walter Morrison, one time owner of Malham Tam Estate, which he took over in 1860 because a Thos. Coulthard was Head Gardener at Malham Tam at the time

A family of Metcalfes used to live at Middle House, Malham Moor and some Wards used to farm the moor also."

## Emigration in the Seventeenth Century

John Balderston submits the following fascinating article which may well be of particular interest to overseas members whose ancestors left England during the Seventeenth Century.

Members may have read of the emigrant Michili Metcalfe of Norwich (dornix weaver) who with his family of 8 children and servant sailed on the 15th April 1637 from Great Yarmouth and arrived 18th June 1637 in Boston New England.

However members may not be aware that after July 21st 1635 passengers to Holland, New England and elsewhere over the sea had "to procure a passe". (A 17th century passport).

On that day King Charles 1 issued a proclamation in these terms:-

"Whereas it is one of the principall duties of all our Subjects, to attend at all times the service and defence of their King and native Countrey either within the Realme, or without, when they shall be thereunto required: And foreseeing our Princely providence what danger might ensue to this State, if Our Subjects might at their pleasure passe and depart out of this Realme unto the Kingdomes, Countreys and Dominions of forraine Kings or States.

For prevention whereof We have thought fit to publish Our Royal Will and commandment......and doe therefore hereby, straitly prohibite and forbid all Our Subjects of this Realme, of what estate or degree soever they be, that they shall not at any time hereafter, without the special licence of Us,....passe or depart out of this Our Realme of England....."

This proclamation in effect extended the restrictions already in force for the control of certain classes of travellers. An Act passed in 1606 for the better discovering and repressing of Popish Recusants

included the following clause:-

"X11 And forasmuch as it is found...that such as go voluntarily out of this realm of England to serve foreign princes....are for the most part perverted in their religion and loyalty by Jesuits and fugitives...be it therefore enacted that every subject of this realme that ....shall go out and serve any foreign prince...not having before his going asforesaid taken the Oath (of allegiance to the King)....shall be a felon."

Seventeenth Century practice often fell short of precept. The terms of the proclamation were not strictly enforced and six months later - on Jan 21st 1835/36 the King himself actually facilitated travel by giving to one Thomas Mayhew a 21 year grant of "the office of writing and entering passes granted in all parts of England and Wales by virtue of his Majesty's commissions lately renewed for keeping a register of such persons as depart this Kingdom with such fees as have heretofore been received for the same....." (StatePapers 1635/6 CCCX11, p 175).

"On June 21st 1636 the Council wrote to all Customers and Officers of Ports referring to the King's proclamation of June 21st 1635 and charging them to aid Mayhew and not to suffer passengers to ship themselves without a due pass".(Stae Papers 1636 CCCXXV8 p.523)

The records, extracts of which ave been transcribed, are taken from three documents, one in the Bodleian Library (Tanner MS 433 Michaelmas 1637 to Michaelmas 1638) and two in the Public Record Office (E 157/21 and 22..28th March 1637 to 29th September 1637 and Michaelmas 1638 to Michaelmas 1639).

Maynew evidently worked through the Custom Officers. The procedure is noted in a diary of John Evelyn:

"1641 the 16th July, haveing procur'd a passe at the Custome House, I went to Gravesend.....with a purpose to take the first opportunity of a passage for Holland."

## A Seventeenth Century Survey of the Manor of Wensleydale

(Yorkshire Archaeological Society Records Series C1V 1941 ed.T.S.Willan and E.W.Crossley)

John Balderston also draws members attention to this article which he reviews here. He says it may well be interesting particularly to members with forbears from this area, possibly to locate the locality of the house and fields they rented.

Some 40 different Metcalfes are listed, describing the premises they occupied and land they held or rented..."At the Dissolution of the Monasteries and the atainder of the Abbot of Jervaulx, the Manor of Wensleydale was worth £68..13..4d per annum."

It was granted in 1544 by Henry V111 to Matthew, Earl of Lennox and Margaret his wife but returned to the Crown in the person of James 1 (their grandson). On 6th Aug 1603 it was granted to Ludovick Stuart Duke of Lennox.

In Elizabeth's reign there had been disputes between the Crown and the tenants (of the manor) in 1570 and between the Crown and Countess in 1573 over the title of the Manor. Now the Duke of Lennox found himself in conflict not with the Crown but with his new tenants. Under the Countess they had paid fines value 9-10 years rent for leases of 21 years. Now for leases of the same term they were paying fines of 30 years rent to the Duke. Early in 1606 some tenants who had taken out leases met at Hardraw near Hawes and decided to ask Lennox to mitigate their fines. If he refused they would complain to the King. In the meantime they collected money for the necessary charges and but the matter in the hands of Peter Metcalfe - (Peter of the bowebriggs [the present Bowbridge, Dale Grange near Bainbridge(). Peter and others interviewed Lennox's commissioners and were "sharply reproved" as "but busy fellowes....who came not in the business of their neighbours...

The tenants thereupon assigned a letter of attorney to Peter Metcalfe and Edmund Pratt to solicit their cause. Others took up their cause. Anthony Besson, founder of Yorebridge Grammar School who became, more than Metcalfe, leader of the tenants - also one Richard Besson who challenged the Duke's authority (following a meeting at Hawes Chapel) to hold a court at Dale Grange.

For want of further evidence the story ends here but it would appear that the tenants were sadly unsuccessful in their struggle with their landlord!

Don Halliday is seeking the baptism of EDWARD MEDCRAFT married at Dawlish, Devon on 26 Dec 1807. #### From mem no 132.

John Kitchin sends the following extract from an article by Jessica Lofthouse in The Dalesman which David Joy (editor) has kindly allowed us to reproduce in our Journal.

[Editor - I make no excuse for including this article. Obviously there are questionable statements of fact in the earlier section but it "tells a good tale" as we say in Yorkshire and, after all that is how most of us came to our interest in history...am I right? No doubt you will let me know if I'm not! At any rate some of our newer members may not have had the opportunity to read some of the more fanciful and florid stories which abound)

Lady Anne Clifford of Skipton Castle received a ready welcome from the Metcaites of Nappa Hall, kinsmen of the Cliffords, for had not a daughter married Sir Christopher Metcaife, a low match obviously for he took her with a meagre dowry of 90 marks - her father having a graded scale when dowring his daughters, according to the rank of their bridegrooms. Sir Christopher was low grade.

Raydale folded within the arms of bare fells is so tranquil a "backwater" it is well nigh impossible to picture it full of fighting men as it was in June of 1617 when the belligerent Sir Thomas Metcalfe ied forty "armed with guns, bills, pikes, swords and other war-like instruments" against the Hall. The master being away they were bold in their attack. Mistress Robinson and her small children escaped in their nightclothes across the lake delta marshes to Stalling Busk. That siege of Raydale House made quite a stir in the local news circle.

The Metcalles and Nappa Hall, Wensleydale.

In the fourteenth century members of the clan "Metcaffe" arrived in this dale. Of the family of a certain Adam Metcaffe of Middle Tongus high up Dentdale, who was slain during the reign of the first Edward, they were to prosper and multiply greatly

during the next two centuries. As high ranking officials large tracts of forest land came into their hands, enough to supply the needs of sons and nephews. At military musters the head of the "Meccas" (local name for the clan) rode proudly forth leading men of his own name. In 1534 of ninety six mounted Meccas sixty two were from Nappa. On one historic occasion one, as High Sheriff, collected more than three hundred Metcalfes to ride with him and do him honour in York, all mounted (so the story goes) on white horses which were probably Yorkshire Greys.

The Nevilles went with Kings to war - the Metcalfes followed the Scropes, so it was James Metcalfe who fought well at Agincourt who was rewarded on return from the French wars with land at Nappa. James had ambition and family pride. Soon he was to obtain a licence to erect a battlemented hall which was to prove anything but a joke. His "high roofed halle" between two tall strong, battlemented and castellated towers, his capacious stables and outbuildings enclosed a large paved courtyard to which access was gained by a deep gated archway. And, so it is today, though none of the Metcalfe name live there [Sec. it is owned by a Metcalfe however].

The Nevilles showed suspicion of Scrope's ambitions when Castle Bolton looked like a threat to Middleham's position. So did the Scropes feel qualms, and had second thoughts about giving land to the Metcalfes. But, too late - Metcalfes were not content to stay down on the fourth rung of the feudal ladder. They would hold up their heads with the Nevilles and Scropes; let them wait and see!

James, the second of Nappa, was Chancellor of the Duchy of Lancaster and held high office in the Lordships of Richmond and Middleham during the reign of Henry V1. The third James was able to keep his feet on the slippery ladder from which the

Scropes had fallen when Henry ousted their patron Richard 11 and from which the Nevilles were to topple in the fall of the House of York to which they were so closely bound. The third James had followed Richard of Gloucester in his travels and from the Duke had received ranks, and honours in the Lordshop of Middleham. He was Master Forester of Wensleydale, Raydale and Bishopdale, high honours indeed with many "perques", and became High Sheriff of the county.

When Richard became king - and then fell before Henry Tudor - the Metcaffes clung to the ladder and kept their hold, persuading the new King that they were too valuable to go down.

Metcalfes were in full force at Flodden, and in the forefront whenever Henry V111 needed support of north countrymen. They continued to prosper.

Thomas Metcalfe added to other family estates, clisafforested lands in the upper dale, when hunting preserves were becoming vaccaries, or cattle ranches. In his time the family fortunes were firmly consolidated. In young Sir Christopher's days the Metcalfes were at their most resplendent for he was a typical Tudor type, fond of high living and lavish entertainment, the Hall ringing with feasting and merriment, the courtyard filled with horsemen returning from the hunt or riding away to visit other wealthy and noble families in other dales.

One day a hunting party came through the gateway, with Mary Queen of Scots among them. Sir Christopher entertained her right royally. His wife was a Clifford, daughter of the first Earl of Cumberland.

Sir Christopher entered his inheritance with a liability. When old Sir James died the Scrope of the time, with great malice, set lawyers to find what claim the family had to the estateshis forebears had bestowed on the first James Metcalfe - no legal

right at all - so, to buy the lands they had enjoyed for so many generations, the new owner had to sell and mortgage Nappa estates. After his high living the possessions were even more depleted, his grandsons dividing the residue. A century later the South Sea Bubble took what was left. Soon there were no more Metcalfes at Nappa Hall!

Nappa Hall is a farm now, the towers are tall: from the trefoil headed windows in the thick walls are fine views over countryside Metcalfes once were able to say - "all that is ours"!!

The first Metcalfe founded a Chantry Chapel in Askrigg Church- three generations of the family lie there - but little is to be seen now of chantry or tombs.

## Magdalen Metcalfe (1714/5 - 1740/1)

From an article by Ms OLIVE HAYGARTH in my Spring copy of the "Sedbergh Historian" I find that Magdalen was the mother of Dr. JOHN HAYGARTH (1740/1 - 1827) who had a distinguished career in the medical profession.

Magdalen, baptised 27.11.1714/5 at Hawes P.C. was the daughter of THOMAS and ELIZABETH METCALFE of Ashes, Hawes. She married WILLIAM HAYGARTH 7.12.1737/8 at Aysgarth and died 15.3.1740/1 (at Garsdale?) of puerperal fever, probably at John's birth, whose baptism is not recorded. Could Thomas and Elizabeth be ancestors of one of our members? If so the article would be of great interest and I am willing to send a copy to anyone interested. (For Dorothy's address see back page of this News.)

### REV. LISTER METCALFE 1740-97

### (Cont. from Aug. 1989 Issue)

This is the concluding section of an article written by Warwick Metcalie concerning one of his ancestors, a preacher in the Northern Dales of Yorkshire, Westmoreland and Cumberland in the late 18th century. Warwick Metcalie shares this ancestor with many other of our members. In particular Dorothy Pope and John Holden have also been active in researching the life of this fascinating character.

.....What keeps us in touch with Lister more than anything else are his sermons. Thanks to his systematic record of where and when they were given we can say exactly where he was on several occasions. Few clergymen of the 18th century can have had their whereabouts charted quite so fully and I have prepared a map based on this information (see below). He must have travelled between these places on horseback or on foot, quite likely the latter (anyone familiar with Dorothy Wordsworth's diaries will be aware that she and her brother thought nothing of a 30 mile walk).

A group of 5 sermons in a slightly different hand in 1783 bear the suffix "Script Sim Metcalfe" or "S.Metcalfe". I take it this is Lister's eldest son Sim who became a grocer in Richmond and may have been the subject of the poem uncovered by Dorothy Pope for an earlier issue of the Mecca News. He was born at Crosthwaite in 1765, died in Richmond and was buried at Muker in 1837. In 1783 he would be 18 and his education complete. I take it "script" means that he only wrote out these sermons for his father, and the authorship, judging from the style, is still Lister's. Why he should have written them out may never be discovered - perhaps Lister was ill?

Be that as it may, we might expect the sermons themselves to give us an insight into the kind of person Lister was. Here we come up against the difficulty that it will take a long time to read them through, and it is necessary not only to accustom oneself to the copperplate hand but particularly the ornate 18th century idiom in which they are written. For these are not unselfconscious joitings or notes for spontaneous delivery but quite the opposite, a set of carefully prepared and fully written out dissertations on biblical themes designed to reconcile all manner of human behaviour or natural manifestations of holy writ.

Whilst it is evident from his notebooks and occasional books that my great great grandfather was fully alive to the 18th century's predilection for literature, philosophy and natural science, these sermons make it clear that he was far from sharing the thread of religious scepticism which runs through much of the intellectual climate of the age.

He lived through stirring times. The foundations of the British Empire were being laid in India and Canada, Cook's voyages were opening up Australia and the Far East, the early stages of the Industrial Revolution were manifesting themselves in Yorkshire and over the border in Lancashire, whilst the French Revolution and Napoleonic Wars had broken out in Europe. Yet so far as I can see on a first glance through his sermons none of these events might ever have taken place!

The topics, therefore, are self-contained, the form throughout is rational, the pace tempered by the steady classical rhythms which suggest logic, and the words studded with felicitous similes that characterise 18th century prose. Also many words are underlined, so that one obtains a strong sense of the cadences of my great great grandfather's delivery. So far as I can see the end product therefore is neither an explanation nor an affirmation, but a declamation. Each sermon is a carefully designed manifesto to be read from the pulpit aimed at confirming his congregation in their Christian faith by constant reiteration of the theme, in different guises, that all things in the end can be traced back to the hand of God.

Like so many changes in taste resulting from the passage of time we may wonder how Lister's congregations managed to sit through sermons of this nature Sunday after Sunday, but we have to remember that by the standards of his day the Dales and Pennines were relatively remote regions and even where members could read and write the general level of knowledge would tend to be very localised. In such cases the form' is often a more

sounds and images that he conjures up rather than trying to reason them out in depth.

One sermon delivered at Crosthwaite in 1765 caught my eye because Lister has made a note alongside the date stating "this was ye first sermon I preached after my fever". Curious to learn how he might have reacted to what had evidently been a traumatic experience, or he would hardly have

effective means of conveying a message which needs to be kept simple than its 'content'. Therefore if we can manage to tune our ears less to what is being said than is our custom today and more to the way it is delivered, we may come upon the meaning of Lister's sermons more effectively through subjective means, through response to the

made such a note, I decided to read further.

As might be expected he chose an appropriate theme taken from Psaim 17 verse 3 "When I am in heaviness I will think upon my God." The text is heavily loaded with apposite and often felicitous metaphors.

As an experiment listen to these cadences in your mind's eye or better still get someone to read them aloud to you emphasising the words Lister has underlined, and imagine you are hearing them as they were first delivered 224 years ago. Remember the underlinings have as much to do with the rhythm of voice as to the sense.

"Adversity has its peculiar advantages to bring us to a just sense of God and our duty to him. For first adversity will make us however unwilling reflect and descend into ourselves. When we enjoy an uninterrupted flow of wordly bliss, when we sail along a smooth and unruffled surface with easy and gentle gales; Reason our pilot when she do sit vigilant at ye helm, is too often luiled into a fatal security: But adversity arouses the mind from its indolence, puts us upon thinking closely and turning our thought every way. Those who have met with no misfortunes to mortify ye pride of heart, which is the growth of prosperity, say to themselves 'Come on, let us enjoy the good things that are present, let us fill ourselves with costly wines and ointments. and let no flowers of ye spring pass by us. Let us crown ourselves with Rosebuds, before they be withered.' Thus ye glittering scenes of life beget a thousand gay ideas, a swarm of fantastic images. which, like insects, wanton and flatter in ye warm sunshine of prosperity; but disappear, die and are no more, upon ye first inclemency of ye season. It is amazing that men in the fulness of health and plenty, when everything smiles around, should shut out ve consideration of ye Being to whom they owe ve fulness of their health and plenty like croves in all ye freshness of their verdure with all their leaves thick upon them shutting out the beams of the sun to which they are indebted," etc. etc..

This extract will, I hope, convey something of the flavour of Lister's sentiment which is very much what can be expected of an 18th century cleric of an earnest disposition, and would seem to bear out the gist of the testimonials and petitions addressed to the Bishop of Chester on his behalf. The style

too has more than a touch of charm and felicity in turn of phrase which might spring from the author of an English grammar.

Three sermons dating from 1797, the year of his death, were separated from the rest, two of them bound in a small notebook. These were preached in Muker Church on Jenuary 15th and February 5th respectively while the last was apparently delivered twice in successive weeks on March 5th and March 12th, the only occasion on which this appears to have happened in the 34 years covered by the 92 sermons that survive. As such it would be out of character and surely an indication of the onset of Lister's final illness. The sermon given in January had been preached at Muker previously on February 20th 1780, that given in February was first delivered at Middleham on October 1st 1769, and the last (given twice in March) also had its first outing in Middleham in the same year on March 7th. The fact that this particular sermon was given on two successive weeks and has been bound into a notebook therefore suggests that March 12th 1797 was probably the last occasion that my great great grandfather preached in Muker church and that he was probably already feiling at the time. He was buried there on May 31st barely two and a half months later; he was only 57.

His theme was surely appropriate to a minister and schoolmaster who, I would like to believe, was conscientious in his duties and served his parishoners and pupils with the kind of strong and simple faith which fitted the tough and isolated lives they lived.

Mark 12 verse 30 "Thou shalt love the Lord thy God with all thy Soul and with all thy Mind and with all thy strength. This is ye first commandment". Perhaps he had a premonition that the first would also be the last commandment he would preach!

Dear Editor

I have a plea for help, please, and in exchange offer a little information on the only two Metcalf(e) references I could find in the shipping lists of immigrants arriving in New Zealand last century. The records of assisted immigrants have been preserved whereas records of those paying their own tares have not always survived. Families with no more than four dependant children could have some or all of their passage money paid by the Government in return for filling job vacancies in this country.

As you will see with Thomas Metcalf and family the vital information of county of origin, occupation and port of embarkation have been missed from the shipping list. However, if someone has 'lost' a brother of an ancestor the name of the wife and child would identify him. Emma came here somewhat later, after the earlier campaign to encourage immigrants. The information 'single woman' and 'single man' after the names of the two younger members of the family mean they were put in those cabins. Young people were strictly segregated, and only those under 12 could stay with their parents. Both voyages were quite fast, two and a half months for the "Mitiades", and only six weeks for the "Ruapehu". Some of the earlier voyages took over five months...imagine being at sea in cramped conditions, poor food, often freezing cold and desperately sea sick!

I hope this information will be of use to someone. I would be happy to make a small search in the New Zealand Registrar General's indexes of births, marriages and deaths from 1848 to 1920 if this would help members.(A British airmail stamp in lieu of a s.a.e. would be fine.) Civil registration began

here in 1848 but was not compulsory until 1875. The indexes are available to the public only up to 1920.

I hope you will have room for my request - poor Jane has been parentless for so long on my chart I just had to try something.

### Help wanted, please

I am unable to find the parents of my ancestor Jane Metcalfe who married Matthew Forster 31 Aug 1723 at Muker -"both of the parish of Aysgarth". Presumably they were married at Aysgarth because Matthew's Uncle Christopher Forster was curate there. Matthew was a grocer in Askrigg who died in 1737, possibly unexpectedly as he did not leave a will. His Admon. in 1738 mentions his widow Jane and the executor was George Metcalfe. The Forsters seem to have been in Askrigg at least back to the buriel of Matthew's grandfather John in 1683.

Does anyone have a Metcalle Will proved in the early to mid 1700's which mentions a daughter Jane wife of Matthew Forster?

The absolutely marvellous Wills booklets published by the Society - thanks to Nina Benson and helpers - shows just how many possibilities there are for a Metcalfe of Aysgarth parish. In the Mecca News no 10 I find that Aysgarth had four Chapetries, Askrigg, Stalling Busk, Hawes and Lunds with Hardraw. This leaves (counting Aysgarth itself) five possible residences for the Metcalfe I want - always providing of course that he left a will. Hopefully someone in the society might be able to help.

#### **Shildon Charities**

An extract from "History and Topography of Durham" (thought to date 1856)

"By the will dated July 19th 1675. EDWARD METCALFE gave his house and his lands in Shildon to four poor persons during their lives and after their death to other four in like manner. The land consisted of about 3 acres of meadow and is let at £5.6s per annum. £60 having been received some years ago, on account of the railway passing thropugh it. Two cottages were erected on the site of the original one, which had fallen down. The rents arising from these premises instead of being appropriated to four persons, are distributed to the poor of the township of Shildon not receiving perochial relief or in some cases, in addition to their weekly pay, chiefly in sums of 10c and 20c."

"Holy Trinity ... in the market place..in the tower, the beliman came to live and perform his craft. The traders followed the beliman in quick succession. The shop of Arthur Thomas the Sadler hugged the tower on its western side, Robert Metcal! the Corn-chandler and William Myers the barber kept it cosy on the south.

As far back as 1442, Commissioners of Array sent inspecting officers into every county to muster and set in military order all men between sixteen and sixty years old. The Aldermen and principal inhabitants shared the private armour of fourteen corsiets with furniture. Pichard Bellamy, Barneby Taylor and John Metcalf had musquets but all had a pound of powder, match and shot...and women were not excluded. Elizabeth Metcatte was allowed John Metcelfe for her bearer, it is surely safe to assume that John was her husband, and her contributor as well as her bearer. He had been charged with private armour, but received a musquet and no corsiet. Perhaps the true explanation is that he found it more convenient (and more healthy) to bear and contribute for this Amazon of the Metcalfe family, then militant here in Richmond."
