Ellen who m Arthur Toft had at least 1 brother, James and three sisters, Alice, Annie & Polly. James bMay 1848 Appleby Carr, Scriven Yks, son of James & Mary (Metcalfe) Mte m Aug 1828 Ripon Cathedral. James b c1811 Grewelthorpe/Kirkby Malzeard may have been son of John & Sarah. Mary was bpt June 1813 at Masham dau of Thomas & Mary (Pearson) Mte who lived at Ilton and married Oct 1807 at East Witton. they also had Eleanor 1808, Ann 1815, Thomas 1816, Frances, 1821, Robert 1824, Matthew 1827 and another Ann 1830 (the first died aged a few days).

Christopher A. b Oct 1885 High Blean in Raydaleside, Wensleydale, Yks. son of William Christopher & Mary Isabella (Carter) MTE who m Aug 1885 at Stallingbusk, Yks. William C. b Feb 1858 Countersett son of Christopher & Jane (Metcalfe) MTE Jane was his 1st wife and they m Jan 1846 at Stallingbusk, his 2nd mge was Sep 1878 to Esther Alderson, widow, nee Tiplady who was sister to Mary Tiplady who married Christopher & Jane's son JOHN. Christopher was the eldest son born 1823 of George & Elizabeth (Chapman) Mte of Worton who m Apr 1823. They had a further four children: Anne 1828, Eleanor 1834, George Chapman 1838 & John b & d 1846. Elizabeth Chapman is connected to the line of the 'butcher' Metcalfes and the family of M410 Mrs Minnitt and Mrs Allen.

# METCALFES IN UPPER WENSLEYDALE 1605/1613


When the Yorebridge Grammar School (between Bainbridge and Askrigg) was founded in 1601 a board of 24 trustees was set up. No fewer than 13 of them were named Metcalfe. When 20 persons all from Askrigg or Hawes were brought up before the magistrates in July 1610 for home brewing without a licence 6 of them were named Metcalfe. The more one thinks about it, the more astounding it is that 30 per cent of individuals in a presumably randon sample from the extensive parish of Askrigg should have the same sumame - let alone 54 per cent of the school trustees.

Turn to the index of almost any published Yorkshire parish register, and you will find upwards of a couple of hundred surnames, occurring with varying frequency. Some will be represented only once or twice, others will be common. But in the nature of the case, the commonest half dozen surnames are unlikely on average to take more than a 2 or 3 per cent share each. At Wensley, for example, for the period 1538-1600, Metcalfe is comfortably among the top twenty surnames in the baptismal entries, and takes 1.3 per cent of the total. At Sedbergh, 1606-49, the corresponding figure is 0.26 per cent, illustrating that the westwards drift was limited. At Grinton in Swaledale, 1640-76, the name was particularly common, and amounted to 2.7 per cent. Spot checks of this kind seem to confirm the pattern which can be demonstrated more systematically from the wills of the Richmond Archdeanery (Mecca News no.31) - a sporadic spread down Wensleydale and Swaledale, from a focus in the parish of Askrigg, but virtually no sign of Metcalfes at an earlier date further east. Mrs.Joan Metcalfe (M63) has written to

say that Index Volume 10 (1457-1680) at Preston (Wills book 2 p.6) was in fact subsequently searched, and she has very kindly double checked, and reports only one Metcalfe, at Pillinge, Amounderness deanery, in 1677.

The very heavy concentration of Metcalfes in upper Wensleydale no doubt led to the implausible assertion that in the sixteenth century we were the most numerous family in England. First though, can we be sure of the facts about Wensleydale? By great good fortune, we can. Although parish register transcripts are available for Askrigg only from 1674 (which is rather late for our purposes), and for Hawes from 1695, we have something even better than the lost registers to enable us to create a complete and reliable view of the population of upper Wensleydale at the beginning of the seventeenth century. There exist two surveys, which happen to be complementary, one describing the manor of Wensleydale or Abbotside (formerly held by the abbey of Jervaulx) north of the River Ure in 1613, and the other the Forest of Wensleydale (as part of the Lordship of Middleham) south of the Ure in 1605. Together they give us a comprehensive list, hamlet by hamlet, of each house and tenancy, with the name of the head of the household. The acreages add up to an appropriate total, and the assessments show us what each holding was worth. The two surveys have been published by the Yorkshire Archaeological Society (Record Series, vol.104).

Thus we can put together a list of some 350 households, located in one or another of 40 named places in upper Wensleydale. These 40 places, mostly consisting of 10 houses or fewer, clustered or scattered, are shown on the accompanying map, with circles proportional in area to the number of households. Not quite all the persons named are the actual tenants. Sir Thomas Metcalfe, for example, is entered as the tenant of 2

houses where he certainly wasn't living. So there seems to have been some sub-letting indicated in the Abbotside survey by the phrase 'or his assignees'. But as far as one can judge, the list is 95 per cent of actual householders. All told, 103 out of 346 are Mercalfes - just on 30 per cent. So it really was the case that the sumame was astoundingly common in upper Wensleydale, compared with any other sumame, in any area of comparable size. How can such a situation

#### have arisen?

In 1301 there was just one Metcalfe recorded at Bainbridge, among 47 names (2 per cent), and no Metcalfes listed under Nappa or Aysgarth. (In Abbotside, the monks' tenants are not named.) From 2 to 30 in about three centuries? Is it statistically possible? The received explanation that the commonness of the name is due 'simply to the birth, survival, and proliferation of numerous males at early

dates' is entirely hypothetical, and in any case it is only a partial explanation: it may explain the numbers, but it does not explain the concentration.

At Bainbridge, the headquarters for Wensleydale Forest, by ancient custom a horn was blown at 10 o'clock each winter's evening, so that any travellers who had been overtaken by darkness in the forest might find their way to safety. (The office of hornblower was in effect hereditary for most of the period for which records exist. - Guess the surname.) People were made to pay three farthings for a guide to lead them through the alledgedly trackless wastes between there and Hawes. (See Whaley's Askrigg, 1891.) This ancient forest was the breeding ground par excellence of Metcalfes - the heartland of Metcalfe family history. At Nappa, on its eastern edge, there was one Metcalfe family: here, there were a hundred. It is almost certain that all our lines of descent go back to upper Wensleydale at some stage - but the diaspora began well before 1600. The meadows and pastures of the dale support only a certain population. Younger sons, with no prospect of inheriting or sharing the family farm, had to leave and seek their liveliehood elsewhere.

What do they know of Metcalfes who only Metcalfes know? One key to exploiting the surveys is to notice how other family names behave too. No other surname in 1605/13 was remotely as plentiful. The commonest, Pratt, runs at 14 per cent at Abbotside but only 4 per cent in the upper dale as a whole. Dinsdale, Rowth, Thwaite and Wynn rank next with about 3 per cent each. These are quite high proportions compared with many parishes but not in the same league as 30 per cent.

Surnames remained concentrated in particular hamlets. Metcalfes were not spread evenly through upper Wensleydale. Thus, at

Dale Grange 7 out of 10 houses were occupied by families of Metcaffes - Peter, Roger, Abraham, Robert, George, Edmund and James. By contrast, nearby at Camshouse, Litherskew, and Sedbusk there were no Metcaffes among 21 households. At Shaw Cote there were 6 households, all with the name Pratt. Similarly we see heavy concentrations of Thwaites in and around Sedbusk, of Thomsons at Marsett, of Dinsdales at Gayle, or Rowths at Hawes. It is a general pattern, not specifically to do with Metcaffes.

Sons may simply have entered on tenancies as close as possible to their parents. Often, however, it seems likely that holdings had been subdivided: and what we see in the early seventeenth century is the end-product of sub-division over several, perhaps many, generations. In the time of Queen Elizabeth, the tenants of the Manor and Forest of Wensleydale 'claimed to be possessed of their respective messuages, lands and tenements within the said Manor, etc., as customary estates of inheritance. In other words they had got into the way of doing more or less as they liked. One can catch a late glimpse of the process in a wonderfully evocative volume publishing Abbotside wills from the late seventeenth century numerous Metcalfes among them (YAS Record Series, vol.130). In 1577 at Fossdale, Thomas Mte records in his will the division of his property between his sons Peter and Richard: 'And as for all my farming and lease I have already given one half to Peter Mte my son and thereof he is quietly possessed'. Similarly Michael Mte of Simonstone in 1628 sells to his son-in-law 'a third part of a tenement', various garths etc., - i.e. he sets him up with a holding, by sub-division. Probably over the centuries, as land was taken in, cleared, or improved, it could support more families, and what had once long before been isolated farmsteads in the 'forest' grew to become little hamlets - where shared surnames reflected family ties in the

male line.

Occasionally, a locality survived as an undivided holding. Yorescote, for example (no.4 on the map) consisted of a single household of Metcalfes. Their house is described as a mansion, one of only three such in the survey. In 1612, in another source, we read that Medcalfe of Yorescote bore arms, argent a fess vert between three calves sable.

The surveys and the published wills make it abundantly clear that a great majority of families were achieving only a very basic prosperity, with maybe 30 acres, summer grazing on the moors, two or three horses, maybe ten or twenty cattle, four or five score sheep. The general context would seem to be pressure of population, and land hunger, mitigated perhaps by a growing demand from further east of the upper dale's staple products.

The Wensleydale WEA History Class in 1976-77 made a special study based on the 1605 survey, of 'Farming and the landscape in seventeenth century Wensleydale', which was published by the North Yorkshire County Records Office in their Journal. It sets out evidence for partible inheritance, and the survival of the open field system. Another NYCRO study which helps to put the 'hundred families' of Metcalfes into perspective was made by the Northallerton WEA History Tutorial Group, and again published in the Journal. It makes clear that the upper dale showed an extremely high rate of population growth from at least 1544/5 to 1672/3.

The proliferation of a particular surname or of a very restricted number of surnames is an upper dale phenomenon (as can be exemplified elsewhere, e.g. Arkengarthdale, or upper Coverdale), taking effect in a period of rapid population growth. The Wensleydale surveys allow us to see (and the map above illustrates) how localized the effect could be.

(Editor: Michael Metcalf works at the Ashmolean Museum, Oxford in the Heberdon Coin Room. He tells me that in March he is lecturing in New York...his opposite number in the American Numismatic Society is also called Metcalf! Perhaps when he returns he will have further interesting articles to write on how that Metcalf arrived in America.)

# CLAIMS TO FORTUNE OF £3,000,000

YORKSHIRE MAN OF 150 YEARS AGO

#### **BRADFORD AND BINGLEY INTERESTS**

It seems probable that blood relationship to the person who made the mysterions fortune of over £3,000,000, now lying in an English bank, can be claimed by one or more people in the Bradford district.

The money has been awaiting claimants for nearly one hundred years, and it is stated that it is now over three million pounds. A Mrs Brown Metcalfe of Springhill, Nova Scotia, is said to be the chief claimant, and there are said to be others, descendants of a man named Metcalfe who went to Canada from Yorkshire 150 years ago.

Mr A.G.Whitehead of 11, Oakdale Terrace, Wibsey, states that his wife is a direct descendant of a man named Metcalfe who is supposed to have left a fortune and who left England for America 150 years ago. This man would be Mrs Whitehead's father's uncle. The Metcalfe family were all in the farming line around Grassington, Kettlewell and Skipton, and most of them were regis-

tered at Linton Church.

Mrs Whitehead has two brothers, Joseph and Beckwith Metcalfe, who live at 20, Allerton Road, Bradford, and 12, Regent Street, Bingley, respectively.

#### **BORN AT KETTLEWELL**

Mrs Whitehead said that her father, John Metcalfe, was born at Kettlewell, and on the certificate his father Robert Metcalfe was described as a 'driver of cattle'. The certificate is dated 1836. Mrs Whitehead, who is the youngest member of the family, lived a long time with her father in his old age, and he often told her of a great fortune that ought to belong to them, but that it had been thrown into Chancery because his aunt would not sign a paper. The money, her father had often told her, was made by his uncle who went away to America.

Mrs Whitehead told a Telegraph and Argus representative that she has two brothers in England and the rest of her relatives are still in America, and she intends to get in touch with them. The Mrs Brown Metcalfe who claims to be the chief heiress can only be a relative by marriage, and if the man who left the fabulous sum is the same man who, over a century ago, found farming so profitless that wanderlust carried him to try his luck over the Atlantic, it seems probable that Mrs Whitehead can substantiate her claim.

Mr Whitehead says that from what he had heard his father-in-law speak about, there is a tangible claim. He died 14 years ago at the age of 85.

# CLAIMANTS TO MANY MILLIONS

## CRAVEN AND BRADFORD PEOPLE CONCERNED

#### FORTUNE MADE IN AMERICA

A paragraph in the 'Telegraph' of 30 April has produced some wonderful results. In short, four people are wondering if they are not potential millionaires.

About 100 years ago there was a Mr Metcalfe, a Yorkshireman, who died after acquiring a fortune of £3,000,000 in America. He was married but had no family. Owing to some dispute between the nieces and nephews the money was placed in Chancery, where it has remained for 100 years.

The four probable claimants are a Mrs Whitehead, of Bradford, who recently wrote to the Bradford Telegraph', and another American lady. Two more people declare they are descendants, at present trying to secure the necessary certificates and proofs before putting in their claims.

Our Settle correspondent interviewed Mr Robert Parker, of Mount View, Belle Hill, Giggleswick, who said he had no proof except statements made by his mother whose maiden name was Metcalfe. "She often said", Mr Parker told our representative," that we ought to have been well off." She once said there was some money in Chancery belonging to her great uncle. Her great aunt had said neither the nephews nor nieces, nor their children can have it, but the children's children. At present we are trying to secure a copy of the will, and are tracing back and securing copies of the birth certifi-

cates of our fore-elders".

The dead millionaire was his (great?) grand-father's brother or his mother's great uncle. Perhaps it is better understood when it is said that Mr Parker's grandfather was a nephew of the millionaire.

#### WELL KNOWN CRAVEN FARMER

Mr George Lund, of Stainforth, a well known Craven farmer, of about 70 years of age, is perhaps a nearer relative, being a generation nearer. His grandfather was a brother of Mr Metcalfe.

Neither Mr Lund nor Mr Parker know Mrs Whitehead, and they understand the American claimant is only claiming through marriage. Of course the chief thing is to obtain a copy of the will.

Mr Parker, who was the eldest of a large family, was born at Ivescar up on the slopes of Whemside, near Ingleton, where his mother died. His father and grandfather had farmed there. He knew they had been tenants on that farm for over 100 years, and a brother said he could trace back to 200 years on that farm. Since then Mr Parker has resided in Langstrothdale, Dursop Bridge, and is now retired at Settle.

He intends writing (to) all his family asking them to assist in the search, and is particularly anxious for any documentary evidence.

Mrs Parker, who was also present at the interview and seemed anxious to assist, said "she had been told that the money was locked up for 100 years and was deposited in a Yorkshire bank.

# THE METCALFES OF THE DALES (By J.F.Boyd)

Since the days of Flodden, when it is said. 300 Metcalfes fought side by side in one regiment, the Metcalfe clan has thrived. Today no less than 650 Metcalfes would be able to defend their country side by side, and would find 650 brothers and sisters waiting for them on their return. They would be welcomed home, too, by over 600 parents, who would proudly exhibit their soldier boys to 600 married sisters.

These estimates are not fictitious. They are based on fact, and are, if anything conservative. A Directory of the County of York has revealed that there are nearly 350 different Metcalfes in the county, and nearly 70 different Metcalfs - without the final "e", but probably related. It may be assumed that the majority of these Metcalfes are married and have approximately four children each. As they are a hardy race, according to the story of their valour at Flodden, few will have died since the Directory was published. So the 350 Metcalfes in the Directory represent, say 1,300 children and 350 wives - in all 2,000 people.

If as history would have us believe, they are all related, they may all claim a share in the Metcalfe Millions", a rumoured capital sum of £3,000,000. This sum, divided amogst so many, would allow each person £1,500. And what is Chancery's share?

#### WHAT THEY DO.

Many Yorkshire Metcalfes could do with some extra money. Picking at random from the Directory I find that one is a tailor's (?), one a commercial traveller, another a foreman, a fourth a marine engineer.

The lucrative trades claim but few; in the whole West Riding there are no more than four employed as fried fish dealers.

These urban Metcalfes, however, have wandered from their home. The Metcalfe who is true to his stock has stayed in the dales of Yorkshire. He abounds in the Richmond district, he thrives near Skipton. Fifty eight of them farm their own land in the West Riding, and sixty farm in the other Ridings.

(Copied form Yvette Dixon's old newspaper cutting by John Horton. The rear of this cutting carries part of an advert. for Smart's Furniture, mentioning Leeds. There is no other clue on it for the newspaper's name or a date, but the type is different to the T & A cutting. Frank Bradley thinks it is from Leeds after those from Bradford.

#### **POSTSCRIPT**

These cuttings (B & C) were sent to me in 1985 by my mother's cousin, whose maiden name was Metcalfe. She says the Parkers of Giggleswick, who are mentioned (in B), went to live at Arkholme and spent a lot contesting the will. They have now been dead over 40 years.

She remembers Grandad Metcalfe, my great grandfather Parkin Metcalfe, telling her when she was a little girl, "I would be well off someday, there was a book missing, which, when found, would entitle us to a lot of money, but it was never found."

Last Christmas, after receiving transcripts of the T & A June 1929 and that by J.F.Boyd, she told me: "The Taylors, farming at Austwick, were claiming, but didn't get very far." When this was, she did not say.

## **Computer Report**

At long last the Card Index is computerised! We now have more than 23,000 individual entries on the computer which occupy some seven million bytes of storage.

The thought of losing all this - the result of many months of hard work - and having to go back to the now out of date card (because of changes made to the data base and not to the cards) keeps me awake at nights.

But of course back up copies are kept in three different places so theoretically we are fairly safe; probably safer that we were with one set of cards!

Fresh entries in the shape of Lists, as detailed in the 'Index to Lists kept by the Metcalfe Society' (copies available from the Secretary at a modest sum) and Family Trees, as submitted by members are still flowing in. The backleg is currently some four inches high and growing.

Help in putting these entries to disk would be appreciated from any member having a computer compatible with the Society's IBM PC/XT (see PS); any disk size is acceptable. It is possible now to go further afield with our request for help as the mailing of foolscap and disks is much easier than the shipment of boxes of cards. Apart from the hardware IBM compatibility requirement there is also one for the program we use to control record storage and retrieval; that is the IBM Filing Assistant - any version. If you feel you would like to help and appreciate that this is not a simple task, but one that requires a great deal of time and attention to detail, please get in touch with me giving details of your hardware. I would like to repeat - this task is very time consuming and not one to be lightly undertaken.

Finally, on the subject of enquiries to the Computer General Index, once again please remember to enclose a SAE and to mention your membership number.

PS: The Society's Computer is an IBM PC XT with a 20 Mb hard disk and both a 360Kb, 5 1/4 inch and a 760Kb, 3 1/2 inch floppy drive. We can also fairly easily convert to these formats from both 1.2Mb and 1.44Mb disks.

# THE METCALFES OF DARNBROOK

Reading John Balderston's contribution about the Dambrook pothole in 'Mecca News' I was reminded of the correspondence in the Craven Herald in 1975. The pothole had been re-discovered after John Moore bought the farm, and there was much speculation as to who the men might be who had carved their names in the rock. It was assumed that J.Metcalfe lived at Middle House.

Yes, there certainly was a family of Metcalfes at Middle House at the time. According to the census for 1851, it was a Christopher and Sarah who lived there with their three small children - Christopher, Sarah and Mary Jane.

The family at Middle House wre first cousins of another family of Metcatfes living nearby that is, the Metcatfes of Dambrook. In 1862 James Metcatfe of Dambrook was a healthy young man of thirty seven, and I would suggest that it was he who went down the pothole at his own back door and chiselled his name in the rockface.

James was born in 1825 at Halton Gill, eldest son of Christopher and Nanny. The family moved to Neil Ing near Stainforth but when James married Jane Petty of Horton-in-Ribblesdale the pair returned to Halton Gill where two of their children were born, Christopher in 1855 and John in 1856.

At this time the tenant of Dambrook was Joseph Myers. In 1859 he died tragically young, only thirty years of age. His young wife and family had to leave and James and Jane and their two small sons took over the tenancy. Two more children were born, Nanny in 1859 and James in 1865.

Dambrook was a hard place to live, especially for the wives. In 1880 Jane became ill. Christopher was despatched across the fields to intercept the doctor on his rounds. Dr Edgar of Townhead, Settle, and his horse Jack, turned towards Dambrook. Snow was falling and was so deep that at one point Jack refused to go any further and the doctor trudged on alone.

When he reached Dambrook Mrs Metcalfe was dead.

Soon after Mary Jane Swinbank from Beecroft Hall joined the family as housekeeper. Christopher was still at home. John had become a butcher in Southport. Nanny was about to marry John Nelson of Lea Gate House where they lived for over 40 years and raised eight children. Young James was at Giggleswick School.

In May, 1882 James married his second wife, a widow, Harriet Dean and they retired to Prospect House, Amcliffe. Three weeks later Christopher and Mary Ann married in Long Preston church. They had a daughter Jane. In 1886 Mary Ann died.

Christopher and young James were farming Dambrook together. In 1889 Christopher married Hannah Greenwood of Rylands, Amcliffe and they moved to Lawkland Green, Austwick where two of their four daughters were born.

A second marriage took place in 1889, that of James and a lovely young girl of twenty four - Jean Ann Coates. Sadly she died within a year of their marriage.

In one decade three Metcalfe wives had died young at Dambrook!

James, now alone on this bleak moorland farm married Ellen Hargreaves and went to live at Hollin Hall. For a period of nearly forty years there had been a family of Metcalfes living at Dambrook.


