

# THE METCALFES AS MILLERS 250 YEARS AS THE MILLERS OF HIPSWELL

from JP Warwick Metcalfe M256

Part of the Metcalfe Family Book is to be given over to 'Metcalfe Occupations' and the articles will be interspersed amongst the chapter on 'Mecca Members Family Trees' (for more details see Mecca News No 50 - January 1997, page 27). As an example of the type of article which will be included is the following from Warwick based upon information supplied by Lynda Simpson (M791) a descendant of the Metcalfes at the Mill at Hipswell. If any members have similar knowledge about a particular occupation followed by their ancestors can they supply a short piece (this one is about 750 words but it can be less) to Warwick direct.

The story of the long Metcalfe association with Hipswell Mill began with George Metcalfe (born 1733) who married Elizabeth Robinson in 1768. At first the couple lived in the village but following the birth of their second child, George took over as miller and their further seven children were born there.

George died in 1829 at the great age of 96. The mill tenancy passed to his son Robert, two older brothers having left home for work elsewhere; but it seems likely Robert had always assisted his father in working in the mill. Robert had married Elizabeth King in 1818 and they had four children. He is still recorded as the miller in the 1841 Census though evidently by now a widower living there with three surviving children, one of whom, Robert II, married Elizabeth Frankland in the same year.

Ten years later the 1851 Census shows Robert is still working in the mill and although Robert continued to live at the mill until his death at the age of 73, his son Robert II had taken over some while before. Robert II and his wife Elizabeth, by now have five children (and were to eventually have eleven) all living at the mill. (It was their second child Mary Metcalfe who became the great grandmother of Elizabeth Simpson to whom we owe this history.) How they all managed in a house which even today only has a kitchen, sitting room or 'Sunday' room, two bedrooms, a two-seater outside loo or 'dunny' and no bathroom, gives some idea how different the view of acceptable living conditions was in those days, bearing in mind a miller was a craftsman not a labourer.

By the 1861 Census Robert II's eldest boy George was 19 and had joined his father but that of 1871 shows a much diminished family at the mill with Robert senior dead and six of his eleven grandchildren elsewhere. George having served his apprenticeship under his father Robert II, had departed with at least one other brother for Kiplin Mill. Although his wife Elizabeth died in 1879 and her grave can be seen in the churchyard of St Johns Hipswell

the 1881 Census shows Robert II is still running the mill assisted by sons William and Thomas with his daughter Isobell as housekeeper.

By 1891 all three children at the mill have evidently left and Robert II has remarried. His wife Harriet is 21 years his junior! They are living at the Mill and he is still running it. It will not be clear until the 1901 Census can be consulted whether or not he had any help with this before his death in 1900, though his second wife Harriet is known to have left following that event. It seems possible that George, Robert II's eldest son, who had helped him as long ago as 1861 at the age of 19 and inherited the tenancy, may have moved back to Hipswell some while before Robert II's death.

George, by now, had a large family of his own comprising two daughters and six sons. He may have brought some back to Hipswell to help, leaving his brother or his other sons to run the mill at Kiplin. Be that as it may, it was during George's occupation with his family that they befriended a Commonwealth soldier stationed at Catterick in 1919, who left a touching poem about the home from home he found at the mill. His eldest son George Herbert Metcalfe had taken over the tenancy and continued milling corn at Hipswell by the time his father died in 1923 aged 81. He had married Lillian Firth and the couple had three children, George Donald and twins, Bertie and Bessie.


In due course the tenancy passed to George Donald Metcalfe who married Olive Hebdon and had nine children. Unwilling to tolerate the cramped conditions accepted by the families of his predecessors, George Donald built a bungalow nearby called Brookside to house them. He was the last Metcalfe miller to the work the mill. Shortly before World War II the army, who became its landlords in the time Lord Baden Powell owned the estate, experienced flooding in property they had built nearby. This was put down to the beck which drove the mill wheel, so the water supply was cut off and the mill machinery came to a halt, where it still stands capable of being put into running order.

Ultimately George Donald and Olive's family settled far and wide, two in Australia and one in South Africa after World War II, whilst his sister Bessie took over the tenancy and lived on in the now silent mill house until she died in January 1996.

But we are still within the range of living memory and it is to Terry Metcalfe, one of the cousins who remembers playing at the mill in the 1930's, that we owe the details of the layout and functions of the mill shown in the accompanying illustration.



# **Rules and Regulations**

The Rev R W Metcalfe was a Master of Arts from Cambridge University and passed his Bachelor of Arts in 1873. He arrived in India towards the end of 1880. He became a master of the grammar school at Ootacmund Madras state. From his arrival to 1883 he was appointed on a series of short term contracts, of a minimum of a month at a time as the chaplain of the second church at Ootacmund. (His daughter Annie Constance Metcalfe died on the 17 May 1882 aged 6 years and 7 months.)

In January of 1884 the Archdeacon of the Madras dioceses unexpectedly died. The Bishop of Madras wished to permanently appoint the Rev R W Metcalfe to the vacancy thereby created. One would presume that as he was already acting temporary chaplain and installed there would not be a problem. Unfortunately for the Rev R W Metcalfe he was born in November 1848, making him 35 years and 2 months when the Bishop wished to appoint him. The age rule of new permanent appointments in India was 34. On the instructions of the Secretary of State for India a more suitable applicant was sought from England .

In 1887 and 1888 Rev R W Metcalfe was listed as Clergyman (there not being Chaplain or Missionary) in Berara for the Society for Promoting Christian Knowledge.

# **Rules and Regulations (2)**

Edward Parr Metcalfe M A was born on the 8 March 1842. In 1872 he was an assistant master at Malvern College in Worcestershire. In February of that year he was appointed to be the head master at Rajahhmundry College Madras. As he was required to give notice to Malvern College he did not arrive in India until 19 November 1872. For the years 1876 to 1878 he was also Lay Trustee and church warden at Rajahhmundry. In 1880 he served on the committee regarding ecclesiastical fees. From 1881 to 1884 he was Fellow of Senate of the University of Madras Faculty of Art.

As he neared retirement age he calculated that he would have completed 24 years 3 months before returning home. Civil Service Regulation 441 stated that with 25 or more continuous years service he would be able to claim 3 years furlough (paid leave counting towards his pension). With under 25 years continuous service he would only be entitled to 1 year furlough thereby losing out on two years furlough for the want of 9 months service.

In 1893 and 1894 he wrote to the Secretary of State for India in an effort to change the regulation to include the period from his appointment and his arrival in India. The government did not appreciate his efforts and refused to comply with his request. He tried again in 1897 without result. He died 31st January 1916 in Upper Norwood. His brother was Rev Robert Weston Metcalfe who in 1891 was vicar of Ravenstonedale. He and his wife Eliza Ann had a son called Edward Parr Metcalfe. His son was a BSc. London, Professor of Physics at the Central College Bangalore.

### PROPOSED STAMP BANK

Do you realise that one IRC is insufficient for return postage from one country to another? For an airmail reply at least 4 coupons are necessary. These make overseas postage very expensive and for this reason we are working on the idea of a **POSTAGE STAMP BANK** for use by members.

The Stamp Bank could be operated from a central point based in one country or from three points such as Australia and New Zealand, Canada and the USA and UK, or even all five countries

The suggested operation is for the bank(s) to hold stamps for the five countries and "sell" them to members who would pay using stamps to the equivalent value in their own currency including the postage to send the stamp from the bank to the member. For example, say an Australian member wants one UK stamp (43 pence) from a stamp bank in New Zealand the cost would be \$A1.80, with exchange rate this covers \$NZ1.00 for 43pence UK stamp plus \$NZ1.00 for return postage.

# How I Found My Metcalfes and the Consequences

# Part 2: The Consequences

(Continued from Issue No 50 - January 1997)

As I related in my first article my great x 3 grandmother Margaret (nee Metcalfe) Raw's younger brother Lister Washington Mte was, 150 years later, to play a part in my family story.

Some time after I had found there were Calvert descendants actually still living in Guisborough, where I now live, I was introduced to a Calvert cousin who was about 80 years old and had a fund of strange tales to tell. One of these was about my greatgrandmother x 2 Alice (nee Raw) Calvert who was very conscious of being the granddaughter of the Rev. Lister Mte. and was treated as a bit of a celebrity amongst the mining community, not least because she took tea with the then Vicar of Guisborough! Apparently she sat there in her cottage, in great state, with a bottle of 'medicinal' whisky on one side of her armchair and a big handbag at the other in which she kept all her money. Like lots of Dales people she did not trust banks. However, the next story she told me was more of a family legend which I'm afraid I was able to put paid to, having researched our Family History.

In the 1920's one of the Calverts recalled grandmother Alice telling of the fortune which her mother's brother Lister Washington Mte. had amassed in Liverpool at the end of the 18th and early 19th centuries and supposedly should have come to her and her siblings but she had no idea what had become of it. This prompted old Frank's mother and one of his aunts to go to Muker to see if they could find out where it had gone. Needless to say they came home empty handed, after all it was some 80 years after Lister had died in 1846! Then, I was shown part of an old letter which one of old Frank's uncles had written to one of his brothers asking for financial help to employ a solicitor to trace the missing Metcalfe money. The very sensible reply to this request was -- "You fund the search yourself and when you get the money you can share it with the rest of us!". It never happened of course, and it's just as well because it would have been money wasted.

The truth was, as I was able to explain, that Lister Washington Mte. married late in life and his considerable estate naturally went to the only one of his six children to survive him. However, during the course of my research I was often to come across Lister W's name in connection with transactions connected with his Calvert and Raw relatives through marriage. In the course of time, through the Metcalfe Society I met Lister W's greatgrandson Warwick (M256), and discovered a whole lot more about my ancestors.

One thing that has always puzzled me, was where the Christian names Simm,

Washington and Lister had come from and once again a Metcalfe Society member was able to supply the answers. John Holden, himself a descendant of Anthony and Alice Metcalfe of Gayle, had been writing a paper on Church Fabric and in the course of his research had read a lot about the Rev. Lister W. Mte. and so we were able to follow up his history. We found Lister's wife, from Howgill near Sedbergh, was a Simm before marriage and her mother was a Washington.

We spent a lot of time trying to find where the Lister came into the family and eventually Warwick found amongst all the papers he had inherited a letter which gave the information that Anthony b. c1700 was the son of Cuthbert and Barbary. We guessed she had been a Lister before marriage but that proved not to be so. The letter had said she was of Starbotton in Wharfedale and so it was back to the Record Office at York where I found her baptism in 1664, the daughter of Lister and Mary (Snell) Simondstone, so now we had all the answers.

Following on from this John Holden traced back to a Lister / Simondstone marriage in c1450 which probably explains the use of those surnames as Christian names which have been used in the Metcalfe, Raw and Calvert families right down to the present day. I still haven't found Robert Moore - anyone got any answers?

The icing on the cake for me was, when in early August (1996), I spent three days at Low Oxnop Hall Guest House, one of the properties which had, over a century ago, belonged to my Great x 3 Uncle and Warwick Metcalfe's Great Grandfather Lister Washington Metcalfe. Oxnop Hall Farm was only one of the many estates Lister W. owned in Swaledale and it is this, that would eventually, through my Calverts, lead me full circle back to the Metcalfes.

My stay in Oxnop Hall was a strange experience, the house is basically as it was when it was first built in 1685 for the Alderson family and was it my imagination that I felt my Metcalfe cousin's ghosts were with me? It is still very much a working farm and the present owner has many awards for his prize winning Swaledale sheep. John Porter's wife had asked me to take my family tree with me and she showed great interest in it all, even giving me some stories connected with our line which had been passed down to her. My Raw line is the only one now to still have descendants in Muker but our Metcalfe legend still lives on in memory there.

The outcome of all of this is that through the Metcalfe Society, the great help of Nina and the members, not only have I been able to discover part of my own history but also made many good friends, to say nothing of a whole new set of cousins with the same interest in Family History as myself. My grateful thanks and I wish the Society a successful future and many more new members.



# THE METCALFES OF HULL

Thomas Butler, the only son of John Butler of Butler House Baildon was born in 1773 and died in 1831. He kept a diary between 1796 and 1799 from which the following extracts have been supplied by Colin J Butler a descendant.

**Dimanche 13th Mars 1796**. I delighted in travelling, now I am always the happiest at home - my late disappointment at Hull makes all my occupations irksome. To me business has lost its pleasures, reading its joys and amusements of every kind their charms. In brooding over my unfortunate attachment to **Jane Metcalf**. Really I love her more sincerely (tho perhaps less passionately) every day.

**Dimanche 27 Mars 1796 -Easter Sunday. Michael Metcalf** is not yet come. Mrs Horner (*a confidant*) says he is an unfeeling young man; to raise my expectations of seeing by writing so often and as often to disappoint me, he knows of my attachment to his sister and must suppose I must be anxious to hear of her. But I excused him to her and showed her his letter. She immediately answered "Why! you little nonsense; how can you expect him till you have informed him you are at home to receive him. His letter requires an answer. I beg his pardon for judging hardly of him." I did not think his letter required an answer but on perusing it a second time I found it did and immediately wrote him.

**Jeudi 31 Mars 1796.** My father went to Leeds. He returned to dine. Came with **M Metcalf Junr.** I had long expected him. I was much agitated at seeing him. Immediately all my sufferings in that I had experienced from being disappointed of the love of his sister rushed fresh into my mind.

**Vendredi 1 Avril 1796. M Metcalfe** accompanied me to Low Moor Iron works. He was much pleased with looking over them. We came back to dine with Mr Balme. I had determined this night to have spoke to Michael about my unfortunate attachment to his sister but I had not courage.

**Jeudi 14**. A letter from Mrs Horner saying that Lydia (*his sister*) had informed her I was in famous spirits and that she (Lydia) supposed it might arise from my expectation of soon seeing **Jane Metcalf**. But Mrs H knows better she knows that I fear seeing Jane Metcalf well knowing that another interview would kindle a flame in my breast which I am now endeavouring as much as in me lays to extinguish. She further adds "If she does come fly the Syren who bewitches, but to destroy fly hasten here and forget your sorrows in the arms of Friendship." Blessings on you my dear Mrs H.

**Mardi 4.** I gained a compleat victory over my inclination this morning; I had an account in my pocket against Joshua Green, Apperley Lane on whom I was going to call to have it settled but as I approached the house it occurred to me that **Jane Metcalf** might possibly be there (which was probable). I stopped short, hesitated. Shall I go in? Shall I

risk an interview with that lovely girl? Yes said I to my self she can do thee no harm. So I pushed forwards and again hesitated and said perhaps an interview may rob me of my peace. Well then said reason do it - I will not go in - clapped spurs to my horse and galloped off.

**Mardi 12**. I went to Leeds. I had purposed seeing **M Metcalf** to apologize the abrupt manner in which I had left him on Sunday night. My heart was so full did not know what I did

17 December 1797. Letter to Michl. Metcalf at Batton's Coffee House. Cornhill. London. By Jove, Michael, I have a very good mind to insist upon you asking my pardon for saying you recd. my short letter which was really more than you expected after a silence for 2 or 3 months. Does my friend mean to hint by this that I care little about him, his letters; if he does he I do assure him, he does me great Injustice; for I do now protest that I value his friendship at a very high rate; and his letters are always very welcome. Tho by the bye I do now confess that I was rather dilatory in answering your last;...... I hope you will be a good boy whilst you are in London, keep good hours, keep good company. I wish I was with you to take care of you for you know I am a good lad; very steady and serious... tho of late I have rather got into a bad name - I am blamed for having too fond a partiality for the Fair Dear Little Creatures ..... I was once a strenuous supporter of Matrimony..... but alas I am destined to pass through this wicked world without a helpmate - I have met another disappointment; a cruel disappointment the Little Brunette has proved unfaithful to all her vows..... and cruelly forsakes me.... to think I have been the dupe of a girl of nineteen. You may write what you please to me on this subject. You ask me if you can do anything for me in London - there is a scoundrel called J B Guianelli to whom my sister paid one guinea for two busts and which I never received. I have wrote four times .. without receiving an answer.... call upon him and say .. you have orders to proceed against him rigorously.

**Thursday 11 Jany 1798**. I heard from **M Metcalf** he informed me he has procured the two busts. I wrote very saucily to him (Guianelli) I am now sorry for he has all the time been in Italy.

**Saturday 27th Jany. 1798**. I wrote a long hasty letter to **M Metcalf Junr.**, Hull in answer to his of the 9th & 23 inst.

**Wednesday 16 May 1798**. I met with old **Mr Metcalf** of Hull at Leeds today. He desired to know why I did not come to Hull more frequently.

**Friday 13 Sept. 1799**. In the afternoon **M Metcalf** came - he is a pleasant well informed young man - my father is highly pleased with him.

Thomas Butler married his cousin Anne Beecroft in 1801 by whom he had ten children, only five of them reaching a mature age.

There appears to be more than one family of Michael Metcalfes in the Hull area. It seems that as far as the Society is able to trace Michael Metcalfe had Jane chr 26 Nov 1774 and Michael chr 7 Oct 1776 both at Holy Trinity Hull. Perhaps one of our members can add more. There is a marriage for a Michael Metcalf on 1 Jan 1808 at Holy Trinity to Hannah Turner / Turnel and a mge on 10 May 1804 at St Mary's Hull of a Jane Metcalfe to James Findlay... but whether these are the brother and sister mentioned in the diary is anybodys guess.

# **COMPUTER NOTES**

### **David Metcalfe**

February 1997

With winter hardly over, the task of entering data from members continues. The database currently at about 62,800 records. Not a lot more than last year but at last I am beginning to put together chronologically multiple records for individuals, especially for our 19th century ancestors.

To this aim, on a recent visit to London, I obtained for the Society, the 1881 surname index for Metcalfe and its variations for County Durham, Lancashire, Cumberland, Cheshire, Derbyshire, Lincolnshire, Warwickshire, Bedfordshire, Staffordshire, Shropshire and Sussex. Together with Yorkshire, Nottinghamshire, Northumberland, Westmorland, Norfolk, Suffolk and Middlesex, the Society now has a large proportion of the index for Great Britain. Watch this space for further acquisitions.

Whilst Visiting the capital I was surprised to learn of the imminent demise of the index search rooms at St Catherines House in the Aldwych and the census room at the Public Record Office in Chancery Lane. According to a published leaflet the census room will relocate to a new Family Records Centre in Myddelton Street, EC1 (near the Angel tube station on the Northern Line) on 10 March 1997 and St Catherines House, now called the Office for National Statistics will relocate to the same site on the 1 April 1997. However it is not intended to relocate the probate records currently held at Somerset House.

Planned opening times are to be 9 - 5 Monday, Wednesday and Friday, 10 - 7 Tuesday, 9 - 7 Thursday and 9.30 - 5 Saturday. If any members are intending to make a visit please check first, as these are just planned timings, but good luck with your searches.

We have been able to eliminate him from being the son of William & Elizabeth (neé Simpson) who married in 1734 at Penrith - a copy of William's Will (died 1763) reveals that he had only two surviving daughters (Ruth and Ann) at that time. Could he be the son of William & Elizabeth (neé Cansfield) Metcalfe who married at Hawes, Yks on 30th May 1750?

The following issue baptised at Hawes may belong to them. It is confusing as there are two Williams having children baptised during this period but this family always mention the name of their farm:-

21.07.1751 Alice of William of Brown Moor

11.02.1753 Ann

05.12.1754 Elizabeth

14.06.1756 William "

"Brown Moor" is on the east side of the road between Hawes and Hardrow.

There is no further mention of this family in the Hawes Parish Registers so they COULD move away to Ravenstonedale.

# Ralph Tiplady Metcalfe

The article in Mecca News No 49 (August 1996) about St Margaret's Church, Hawes contained a surprise for me - I have visited Hawes and spent time wandering around the churchyard looking for Metcalfes and other ancestors but had not looked **inside** the Church! Next time I shall certainly go inside to see the war memorial screen which I now know mentions "John Chaytor Mte, John Moore Mte and **Ralph Tiplady Mte**, who fell in the Great War of 1914 - 1918".

Ralph Tiplady Metcalfe was my father's cousin. His parents are buried at Hardraw and Ralph is also remembered on their headstone :

"In Loving Memory of
Jane wife of John Metcalfe of Bainbridge Ings Hawes
who died 17th September 1884 aged 34 years
also of their son Ralph Tiplady Metcalfe
who died on active service in Italy
22nd November 1917 aged 33 years
Also of the above John Metcalfe
who died on 1st April 1926 aged 76 years."

The name Ralph Tiplady Metcalfe does not appear on the war memorial list inscribed on the Hardraw lynchgate. I had thought that was because of the circumstances in which, according to family tradition, he "died in active service" but was not actually "killed in action". Now I realise that it was because he lived in the Parish of Hawes and was included in the Hawes memorial.

The story passed down in my family is as follows:

Ralph was the only child of John Metcalfe, farmer of Bainbridge Ings near Hawes and his wife Jane. (The baby was called after John's father, who was also Ralph Tiplady Metcalfe.) About a week after the birth Jane Metcalfe caught a chill crossing the yard and died. John never remarried and young Ralph was reared by his maiden Aunt Belle (Isabella Blyth Mte) who was stone deaf. He grew up a shy recluse who suffered dreadfully from travel sickness on the shortest of journeys and rarely went beyond the farm, although he loved reading travel books. At the age of 32, still unmarried, he was moved by the war-time recruitment campaign and joined the army. After initial training, his unit was sent to the Middle East (Palestine?) but Ralph never reached the destination. The journey made him very ill and he died in Italy of travel sickness (?!).

From my own researches, I can add that Bainbridge Ings near Hawes had been farmed by Mtes since before 1841, when it was occupied by John Metcalfe, his wife Jane (nee Tiplady) and his father, another John. In the mid 1840's the two Johns moved to Bridge End at Gayle (where the elder one died in 1848 aged 99). This move probably

coincided with the marriage in 1845 of John's son Ralph Tiplady Mte, senior (1813 - 1880) to Mary Blyth, daughter of a Hawes mill-owner. The couple remained at Bainbridge Ings throughout their lives and were both buried in the Friends Burial Ground at Hawes, where there is a headstone to them . They had five daughters (from one of whom I am descended) but only one son, John. After the death of Ralph Tiplady Mte, junior, John continued to farm alone at Bainbridge Ings but when he died in 1926 this male line of Mtes died out and Bainbridge Ings passed out of the family.

I do not know whether it is really medically possible to die of travel sickness but I do feel that cousin Ralph did give his life for his King and Country and I am pleased to know that he is included in the Hawes War Memorial.

# **My Earliest Metcalfe**

During my researchinto my family in Carlton Husthwaite & Coxwold, N. Yorks a researcher Christine Chapple found a **Vincent Metcalff** in the printed account of the Monastic Chancery Proceedings under the section of Newburgh Priory. (Ref page 94 ECP 796 29 (after AD 1536) Borthwick Inst York.)

In short Vincent Metff. was able to rent the farm and parsonage & appurtenances for a term of 15 years at Thirkylby, after the destruction of the Abbey. Newburgh was also connected to Byland. As this area is very near to my ancestors home is he the patriach of my Mtes or was he a monk? Not the latter I think as there are references to monks who hold the prefix Bro. Mrs Chapple was also able to provide me with 4 surveys of Wildon Hill, Coxwold showingthe names of the fields, their acreage & rental worth. Through wills and other documents I know for certain my lineage to 1630 and a possible of 1584 - nearly there! Perhaps someone else can fill in the gaps. **Mrs D McDonnell M497**
