Ron Metcalfe (M13)

It is with great sadness that we have to report the death of one of our original members, Ron Metcalfe (M13) who died suddenly of heart failure on 14th January 1999.

Together with his wife Gwen, they distributed the Mecca News to all our members for a number of years. Being married for over forty years, they were able to enjoy fourteen years of retirement, when they travelled frequently. The society did manage to catch them in three times a year for them to receive boxes full of Mecca News, and various inserts, so that they could eagerly assemble and post the 450 packages. No matter what time we arranged for the courier to deliver them, they always seemed to arrive before 7.30am each time - an ungodly hour to retired folk! It took us some time to realise that the depot was just around the corner and so they would always be the first delivery!

Our secretary, Diane Howarth (M409) and Pat Malham represented the society at Ron's funeral in Solihull. Led by a standard bearer of the Royal Air Forces Association, the family gave Ron a truly splendid send off. He really would be so very proud of them - something that was so very apparent through the tribute given by his son, Ian. There was certainly something that every single one of the 200+ people attending the funeral could relate to. We send our fondest regards and very best wishes to Gwen, their two sons Ian and Mark, and their families. God bless.

We dedicate this issue of the Mecca News to the memory of Ron Metcalfe.

Committee member Pat Malham (M444) first met Ron and Gwen five years ago when he was looking for volunteers to copy the births, marriages and deaths from the GRO. Ron, in his quiet way, said that he and Gwen would help out and it was not long before an envelope landed on his doorstep bringing their contributions. Since then, it was an annual occurrence that when Pat was looking for volunteers, Ron and Gwen would always offer their services. Often, having done a batch of five years, Ron would indicate that they might be able to fit in a few more if needed, and sure enough, the ones that were needed would soon be winging their way. There was no fuss, just a desire to help the Society. The main thing about it was that you knew that there would be no need to check the lists - they would be as accurate as it was possible to be. Since then, along with many other members of the society, Pat always looked forward to seeing them both at the Muster. It will be a great disappointment that Ron will not be there this coming October.

It was 1981 when I joined the Metcalfe Society and my very first Mecca News showed me that Ron's family line and mine stemmed from the same village of Hipswell in Yorkshire. Naturally I made immediate contact and we quickly

established proof of our common descent but no matter how hard we tried, the birth of George Metcalfe c1733 had us beaten. Over the years we have enjoyed many meetings and exchanged numerous letters and nearly all Ron's end (as did that first letter in April 1981) with the words "May the bluebird of happiness fly with you" I would like to think that when we finally find "our" George, the bluebird will let him know. SEVEN YEARS PENAL SERVITUDE

From The Times 3 January 1879

Middlesex Sessions 2 January. Edward William Metcalf, 34, describing himself as a general merchant was charged with obtaining by false pretences a roll of cloth, value £6 18s 6d and a horse, cart and harness value £34. Mr Besley and Mr Grant prosecuted. Mr Fulton defended.

On 31 October, the prisoner, by paying £7 5s, half a quarter's rent, obtained possession, as tenant for three years, of a house stable and garden - 120 Forest Road, Dalston. He issued cards and memorandum forms as Elton & Co., general merchants and opened an account at the Birbeck Bank with £32. Before November 26 he drew out £31 15s and after that day there was only 5s to his account. He bought the roll of cloth for cash on 5th December and gave a cheque which of course was dishonoured; and on 7th December he induced Mr Richard Relf to sell him a horse, cart and harness for £34 giving a cheque for the amount which was quite worthless. On December 15 he was using the cart and horse to remove the fittings of the stable when Detective Armstrong took him into custody. He said "I am done." In his possession were found a number of pawn-tickets relating to pledges for small sums.

The jury found the prisoner Guilty and he then admitted a previous conviction for burglary, under which he had suffered five year's penal servitude. Mr Serjeant Cox sentenced him to seven year's penal servitude.

THE METCALF HOUSE

Lewis Delaware USA

The three houses that comprise the Metcalf House are fine examples of both the Colonial and Revolutionary periods. John Metcalf purchased the property (part of the original four acre grant set aside by Sir Edmund Andross in 1680 for St. Peter's Church) in 1838 from the vestry. John Metcalf was the draysman for Lewis, providing the "taxi service" and horse and hack rental for the local area. Extensive stables were located behind the house and to the right side.

Two small houses and a two storey house were consolidated into one residence sometime after 1868. The main house (202 West Third Street) originally faced Market Street, approximately 40 feet behind its present location. The small portion of the current house nearest Market Street was originally located on the right side of the property. This side was used by Mr Metcalf as a blacksmith's shop for his business and occupies its original position at 204 West Third Street.

John Metcalf died in 1882, his wife Hettie Maull Metcalf having died in 1877. They are both buried in St Peter's cemetery across the street. Their daughter Annie Elizabeth, lived in the house until her death in 1934. In 1950 the house was purchased from the Metcalf estate by Lester Web, who began major restoration. In 1960 the property was divided and the Metcalf House purchased by Gordon and Laura Bryan. Wayne and Margaret Ehlerind purchased the House in 1885 and continued the restoration.

METCALFE RESEARCH OVERSEAS

For some time now, the Society has been gathering the English and Welsh Births Marriages and Deaths, as found in the General Register Office Indexes, kept at Myddleton Street with copies in many local archives and LDS Family History Centres. What would be extremely useful, would be to extend this collection to include the overseas registers. Many British people emigrated overseas in particular to Australia, New Zealand Canada, South Africa and the United States but in the Society archives we have few Births Marriages and Deaths as yet, from most of these countries apart from Australia. What I am hoping to do is to prod a few of our overseas members into helping to remedy the situation. I do not know how easy it is to get hold of these records or what facilities there are for copying them. Are they available electronically? Are they on fiche? Can one photocopy them? When did they start? What information is given? Are they listed according to State Region or County or as a whole country? Can we access them in the near future? Is it something you could do to help the Society?

On a recent holiday, I met one of our New Zealand members Gary Medcalf (M278) and had an interesting conversation with him, the result of which is that he has volunteered to note all the Births Marriages and Deaths in the New Zealand registers. He has within just over a month, already copied the Births as far as 1967 onto a database, currently a total of 800 entries and he is hoping to have all the BMD's completed by April this year. This an excellent beginning. Is there anybody in the far flung countries who is willing to tackle some, at least, of the entries for their own country? If so please let me know and if there is more than one person from the same country, I will arrange some form of co-operation so that work is not duplicated. Write to me in the first instance and let me know what is available, how and what you can do. This information will help to build up the picture of the Metcalfe Clan. My address is on the inside of the front cover of this magazine.

We also know that Metcalfes are to be found in other parts of the world so if you are in another country apart from those mentioned above and are willing to help, please do your part, however small it may seem. Negative information is also helpful. It might just trigger someone else later on. I do not imagine that in many other countries there will be prolific entries, nor that it will always be easy to note them down but for anyone based overseas try a sample -a year or five- and see what you come up with. It may be that your research helps someone else to discover what happened to that elusive younger brother in their great-grandfather's family or why Great Aunt Jane's birth was not listed with the rest of her brothers and sisters in Much Snoring.

RAILWAY HERO

John Metcalfe was hailed as a hero when he dashed out from his derailed train to warn an on coming goods train of the blocked line and thereby prevented a more serious accident occurring.

John from Carlisle (an ex -mayor of the City) was the driver of the Huddersfield to Carlisle passenger train on the wind and rain swept night of January 15th 1999. Just to the north of Kirkby Stephen on the wild Settle to Carlisle railway line the diesel passenger train was derailed by a landslip near a tunnel. Some 37 passengers suffered mainly minor injuries. Whilst they were seeing to the passengers, John realising that a southbound goods train was heading in their direction, went out into the stormy night to lay the detonating shells on the line to warn the onrushing train.

His action meant that the driver of the goods train was able to slow his train sufficiently to only cause some minor damage to the derailed train and undoubtedly saved his passengers from greater injury. John was very modest when commended on his actions and played down his part in the accident.

Goldsmith

Heselrigg Metcalf son of Richard Metcalf of Newcastle apprenticed 1 August 1728 to James Kirkup for the term of seven years, the premium paid being £30.

He was the only surviving son of Richard Metcalf of Newcastle, tinman, by his wife Dorothy dughter of Matthew Curry of Bedlington by his marriage with Hannah Ewbank; which Hannah married secondly Robert Hesilrigg the last male survivor of the ancient family of Hesilrigg of Swarland.

Hesilrigg Mt had property in the chapelry of Longframlington, Northumberland which he sold in 1736. He was stated to have emigrated to Jamaica dying there c1760. From An alphabetical catalogue of the Goldsmiths of Newcastle.

Secretary's Report

After a few months in the secretary's job, I am slowly putting together the many pieces of the jigsaw so I can hopefully see the full picture in the near future. The telephone and postal connections between Boroughbridge and Mortimer don't get a chance to cool down as Nina guides me along, prompting me about forthcoming external and internal deadlines, such as equipment log and insurance to the Federation, or agenda items to Margaret Hodgson so that she can update and distribute the detailed agenda in plenty of time for our next committee meeting. So my new secretary's diary that prompts me, and others(!), into action is growing daily. I really am beginning to truly appreciate the work that Nina did for so long and how she made it look so easy. Perhaps I shall have to learn to curb my enthusiasm for volunteering in the future!

As part of the secretary's role, I am fielding many queries from people wanting to know more about the society - most of whom have heard about us via the book or our new internet site. As a result, the society membership increased quite dramatically over the last few months. In the last few years, we have seen a trend where we have lost about 50 members each year and gained 50-55 members. So our current membership has remained constant at around 450. You will see in this issue alone, that we have 40 new members just since the last issue. This is indeed a record for the society. I cannot yet update you on how many members we have lost as we are just starting our annual subscription reminder process. We usually have to send out about 150 reminders of which 100 forgetful people do actually respond. Hopefully the additional methods of subscription payments that were sent out in the December Mecca News (standing order for UK members, and paying for future years a current rates for all members) will ease this recurring problem. We know it will not disappear due totally to human nature.

If you are planning to go to the Federation Family History Conference in Winchester on 10th April, please do let me know because I will be there representing the society (and hopefully selling a few books). I would dearly like to meet more of our members, especially if you don't get the chance to go to the Muster each year.

For those of you who have sent me a query - be it via e-mail or post, I do try to respond as quickly as possible, as do all our committee. But as we are all volunteers, doing all that we do in our spare time, please bear with us if the response is not totally immediate! As we get nearer the end of the century, I am sure time is speeding up ... 1998 went by so quickly, and 1999 appears to going at a galloping pace.

I am sure many of you find life is operating at a much faster pace these days. But I do hope you find time for yourself, your family, and your family history.

METCALFE RECORDS

These were written and published privately in 1891 by Walter C and Gilbert Metcalfe. They were father and son, both in the law and Fellows of the Society of Antiquaries of London and traced their ancestry back to James Metcalfe (1389-c1471) founder of the Nappa Hall branch, through Ottiwell second son of Thomas (Chancellor of the Duchy of Lancaster to Richard III) who was in turn second son of James. Several members of the Metcalfe Society today can trace their connection with James through this route though the direct line died out in 1756.

Only fifty copies of the Records were printed, so they were rare from the start. My own copy (no 6) which I used as one of the chief sources of our new 'History of the Clan' (recently published by the Society in an edition of 750 copies to mark the millennium), came down to me through my uncle or grandfather, who somehow acquired it from a Dr Henry Collins MD, to whom it was originally given.

Another copy (no 24), in good condition, I have passed to Dorothy Pope (M55) in gratitude for her extensive research into our own branch. It was given to me by a colleague who found it quite by chance in the attic of a house he had recently moved into! This gives an idea of the challenge we would face locating them - it may never be possible to find them all. Nevertheless, their rarity and relevance to our recent book about the family surely justifies making some attempt. The nub of this article is an appeal to members to keep their eyes and ears open for any hint or clue of a copy's whereabouts and to let myself, the editor or the Society's secretary know if anything comes to light. Meanwhile a bit more information about the few we have located to date.

Nina Benson (M29) has come across a copy in the Harrogate Reference Library but its condition is too fragile for photocopying. However at the same venue she also chanced upon a most useful list of the original recipients, shown overleaf. This means we do at least know for whom they were destined, as well as the dates they were apparently sent, noted alongside. Tracing some should therefore be relatively easy, the Inner Temple and Bodlean Libraries for example received copies 21 and 22, whilst Downside (either the Abbey or the School) received no 19. There are also several titled recipients whose descendants should not be too difficult to trace and if the Bodlean has a copy it seems likely the Library of Cambridge University and the British Library are fairly certain to have copies.

Meanwhile three other copies have come to light thanks to John Harker (M192) who reported having seen a copy in the Brighton Municipal Library some time ago and Dr Christopher Metcalfe (M590) who has no 50 and put me in touch with a relative Mr John Metcalfe Wood. The latter has written confirming he has a copy though it is apparently not numbered - and therefore presumably not on the Harrogate list. Evidently Mr Metcalfe Wood's father obtained it from a second-hand book shop in Leeds in the 1920's after hearing about it from a fellow 'gun' on a shoot he

was attending. At the time he complained of having to pay too much for the book - it would have been interesting to know its price! There has also been one other important development thanks to the industry of out president Charles Metcalfe, who borrowed my copy of the 'Metcalfe Records' and has typed the whole into his word processor and printed it so that the Society now has its own master copy on disc of this invaluable Victorian research. The page size is A4 rather than that of the original but this is likely to be a more useful dimension to handle today. The question is how to make the best use of it? The topic will certainly be discussed at the March committee meeting, so I will end by quoting one of two letters written by Walter Metcalfe to Dr Collins, the recipient of my copy, which have been stuck into it.

'Having at last completed my 'Records' I beg your acceptance of the enclosed copy which I hope will interest you. I hope you will not hand it to Mr JH Metcalfe or anyone else who is likely to fritter away its contents in a local newspaper, a thing I have a great objection to. I will send a copy to Mr Sykes who like yourself will appreciate the various subjects and bygone subjects of interest which it has been my object to place on record, particularly as to the old forms of litigation.'

The underlining is mine. The books contain an amount of Latin (or Clerk's Latin) plus long passages describing court cases and arguments over property and descent, in amongst its material of interest to the ordinary person. It should certainly be valuable for the historian or scholar with an interest in law, though I suspect from this letter the way I have shortened and re-written his erudite work for the general reader of the new Metcalfe book would be unlikely to meet with Walter's approval. Fortunately my initials are not JH! (J P Warwick Metcalfe M256)

Metcalfe - History of the Clan -a best seller!

We reported last December about the highly successful launch of the book at the Muster, the fulfilment of all advance orders and the flow of new orders coming in. I am more than pleased to report that this flow became an absolute waterfall through my letterbox every single day leading up to Christmas. In the 18 days of December prior to me going away on holiday, 121 books had been processed and distributed, of which every single one arrived at their destination in time for Christmas (didn't they Stuart Metcalfe M273!!). That is an average of almost 7 books each and every day!!! Since the New Year, it has obviously slowed down from this mad frenzy to a regular average of 10 books per week. To my knowledge, all books despatched have reached their destination - not one lost - although some did take longer than others due to such things as random searches by Canadian customs.

As I write this report in the middle of February, we have sold just over 600 of the 750 books printed. In both our early planning and our wildest dreams, we did not expect to sell this private publication so quickly and in such volumes. Hence, the subject of a potential reprint is looming far earlier than expected, and is a subject for discussion at our spring committee meeting. Full details will follow.

Who is buying the book?

So who is actually buying this best seller? Obviously we have hit our main market - you as members of the society. But as we discuss the feasibility of a reprint - the financial cost, the potential market, short versus long term view etc, here are a few facts and figures to show you where these sales have come from.

- * Of the 600 sold, 409 of these were advance orders and sales at the Muster all of which were to society members.
- * Since the Muster, only 28 of the remaining 191 copies sold have been to existing members an equal combination of repeat and new orders.
- * The remaining 163 copies sold since October have been to non-members or newly-joined members. These people have heard about the book from the following sources:

To the Manor Born

In the TV series of the 1980's Penelope Keith and Peter Bowles clashed and sparked over the traditions of the Manor House. Penelope thought that foreign blood could not provide the expertise nor understand the traditions of manorial rule. One had to be "To the Manor Born". It made for entertaining TV.

As with all things the manor had its time and place, now you see the lordship of manors regularly available for sale. In a recent article in Night and Day (Sunday Mail - 7 February 1999) an ex-journalist auctions "titles" "largely to foreigners or rampant social climbers". All the purchasers usually got for their money was the legal right to use "Lord of the Manor" after their names. They have no rights to the old manorial holdings. Yet earlier it was different.

In Anglo-Saxon times many of the villages were controlled by leaders often descendants of the war band chiefs who came in the 5th to 8th centuries. There was a distinct family orientation to these groups. The Norman invasion created a new system which used the Anglo-Saxon estates as the base. Over 90% of pre-conquest owners were summarily disposed of their lands in the twenty years after 1066. This new system was the manor. Manor land was either for the support of the lord and his personal household (his demesne) or land tenanted to villeins in return for services to the lord. Each villein normally had thirty acres, for which they had to give ten days of work a month to the manor. Free men could leave the lord's service whenever they chose but the serfs working directly for the manor were little better than slaves. As the lord controlled all aspects of their life (and death) the statement "To the Manor Born" was apt. Every time land was transferred, for example on the death of a tenant the lord would receive a payment (a fine) and when the heirs took over the land a further fine was imposed.

The system was not particularly popular given the imposition of a largely foreign aristocracy on the majority of the population. Over the years this led to disturbances but the system was strong enough to weather the problems for nearly three hundred years. In the middle of the 14th century the Black Death reduced the number of workers for the land and the law of supply and demand came into play. The serfs used the opportunity to exact changes from the system. This was primarily greater security of tenure including full hereditary rights and fixed rents. Details of the arrangements were entered into the manor court roll and a copy of the title given to the tenant. The record became known as the copyhold. This was the beginning of the end of the manorial system but it survived fairly vigorously until the Enclosure Acts of the 17th and 18th centuries before finally expiring in this century.

Over time the lord often sold his manorial rights to raise cash, either to the sitting tenants or to the new rich of the growing towns. As a result manorial control was reduced. The effective end of the manorial system occurred in 1922 when copyhold

tenure was abolished and made into freehold. Nowadays the lordship is conveyable in name only with few manors retaining their original land rights.

Manorial records are an important source for family historians as they hold details of land tenure down many centuries. They also recorded other day to day activities of the manor and its inhabitants including rights to extract minerals and the treatment of misdemeanours. The manorial court, presided over by the lords steward administered the regulations and dealt with any offences. The court proceedings were first recorded on rolls then later in volume form. Written in Latin until 1733 the rolls or books may be supplemented by draft rolls, minutes and other steward rolls. Records may have started shortly after the introduction of the manorial system but much of any early information has been lost and the remaining records tend to start in the 15th century with documentation often through to this century

After the abolition of copyhold tenure in 1922, manorial records were placed under the supervision of the Master of the Rolls. Any changes in ownership of the records should be notified to the Royal Commission on Historical Manuscripts who administer the rules on behalf of the Master of the Rolls. The Manorial Documents Register contains details of surviving documents and where they are located. Manorial records are not held by the Master of the Rolls or the Commission but are normally to be found in record offices, the PRO, and national/local libraries. Some still remain in private hands and may not be readily available. Buying a lordship does not automatically entitle the purchaser to the manorial documents nor to copies of the documents.

A manor could cover more than one village and a village could be covered by more than one manor. Thus identifying the appropriate manor is not always straightforward. The first thing to do is identify the manor covering the place you are interested in. Published County histories should provide lists. County Record Offices also hold manorial details.

Manorial records are a much under utilised source of information and whilst not the easiest to use can add details where parish records (or the lack of them) fail to do so. If you have not looked at this source why not give it a go. Essential reading *How to Locate and Use Manorial Records* by Patrick Palgrave-Moore.

In the preparation of this article a list of the location of manorial records for the Arkengarthdale, Swaledale and Wensleydale areas was compiled and is to be lodged with our archivist Nina Benson, together with sample extracts from the Bainbridge (Bainbrigg) manor of Wensleydale for the period 1614-1620 which mentions John Edmund James Richard and Joshua Metcalfeamongst others.

My thanks to **George Buxton M003** for his hard work in producing the lists, obtaining the extracts mentioned above and providing some of the background information.

1861 CENSUS

Member J M Dobson (M442) was searching for an elusive ancestor in North Yorkshire and had cause to examine the 1861 Census for the Bedale Registration District. The area consists of some 56 parishes/locations extending from around Northallerton in the east to Castle Bolton in the west and from Danby Wiske in the north to Masham Moor in the south. Here are some of his findings.

There are some fifty six Metcalf(e) families of about 270 individuals scattered in 29 parishes recorded in the Census. The largest congregations were in Bedale, Fearby, Masham and Kirkby Fleetham (six families in each), Crakenhall (4) and Aiskew, Exelby and Ilton (3). The remainder were spread across twenty one of the remaining parishes/locations which include Theakston, Burneston, Carthorpe, Swinton, West Witton, Ellerstring, Thirn, Thornton Steward, Romanby, Danby Wiske, Ainderby Steeple, Morton on Swale, Little Langton, Great Langton, Anderby Myers, Langthorn, Gatenby, Redmire, Preston and Wensley.

The occupations of the head of the families were a surprise in that only 8 were described as farmers (farming 8 to 200 acres) whilst twenty seven heads were listed as agricultural labourers (a term which covers a great deal more than its present day significance). In four villages the Metcalf(e)s were blacksmiths but there was only one leadminer in the whole of the area despite the fact that leadmining was still carried on in the northern part of the registration district. The occupations of the others included rural postman, gardener, vermin destroyer, woodman, wood cutter, grooms (at Agglethorpe and Middleham where there were horse training facilities) and the usual village calling of butcher, baker, joiner, carpenter, shoemaker, tailor and cartwright. There was also one tile maker one milliner and one hairdresser. All in all a versatile and vibrant society.

1881 Census Returns Index "National Sort", a complete alphabetical arrangement by forenames for all Metcalfes (& variants) has been purchased by the Society and enquiries are welcome (with return postage) but NO we cannot copy sections!

M943 has donated copies of a book by her ancestor Henry Ernest Metcalf, M.I.Mech.E., M.I.N.A. born 1868 in Bradford YKS & whose father was born in Hovingham, Yorkshire. Henry, in the course of his business life travelled widely and his accounts of the life & times in Russia and in Japan are enlightening. In this book and an accompanying diary his wife adds her own comments on Russian & Japanese life and gives a wonderful account of a trip to visit relatives in Canada. Now in our Library. M980 has sent in Census Returns covering Withersfield, Suffolk 1841-91 and Parish Registers covering Births 1558-1853; Mges 1558-1842 & 1859-1909; Burials 1558-1880; & MIs. Also Boyds Marriage Index 1500-1837 for Suffolk Metcalfes. M951 provided us with MIs from Hutton Rudby, Crathorne, Kirklevington and Stainton in Cleveland, M866 sent in parish register entries from various parishes in Lincolnshire c1500-1720. M930 has recorded the Metcalfes in the 1851 CR for Lancaster and maybe worthy of a mention is John Metcalfe 62 b Cockerham Lancs a grocer & East India Company Pensioner, wf Jane 59,s Thomas 15, s John Edward 12 & mother in law Mary Cornthwaite aged 90!

LT. EDMUND WHITEFORD METCALFE

The following incident was found in the East India Company records (Ref E/4/195 Pages 976-981) by George Buxton (M003). It is dated 25 November 1840 and relates to complaints forwarded by the commission in Gauyain regarding improper conduct by Lieutenants Richardson and Metcalfe of the 43rd Native Infantry during the celebration of the Desserah festival at Kimnedy, India.

Lt Richardson whilst in command of a detachment of his regiment at Kimnedy went to the Desserah festival on the evening of 18 October 1839 where he stopped and spoke with the Rajah. The crush around the Rajah and his Planquin was so great and the noise so loud that the lieutenant found he could not carry out a conversation with the ruler and finding difficulty in extracting himself from the throng took a sword, waved it over the heads of the crowd and cleared a way back to his horse. The complaint was that he caused an insult to the ruler and offended the Hindu's at the festival by waving the sword during a religious procession. The findings were that he was somewhat improper and inappropriate in his conduct by talking to the Rajah in the middle of a religious festival and then flourishing a drawn sword at a sensitive time.

Lt Edmund Whiteford Metcalfe went to the town on the same evening and after the procession was over entered one of the Hindu temples against the wishes of the priest and touched the idols. Although this was denied by the sepoy accompanying the lieutenant who said the priest did not object. He then went to the house of a dancing girl where he was violently attacked by a gang of men and beaten. He sent his sepoy back to camp for help and a number of sepoys and a Hindu came to his aid. Another message reached the camp that an officer was being murdered by ruffians and the rest of the detachment was called to arms and marched on the town. The infantry rescued Lt Metcalfe but the attackers had fled although an assailant was seized shortly afterwards. The lieutenant was accused of threatening the peace of the district by his conduct and compromised his position and that of his fellow British officers by interfering with the religious beliefs of the local populace and placing himself in a situation which resulted in him being beaten and generally ill treated.

The Major General of the East India Company Army Sir H Gough thought it necessary for both officers to be brought before a Court Martial to answer the charges but the Governor requested that they be severely reprimanded for their improper conduct and that neither of them should be employed in a similar role until they had gained sufficient experience so as to avoid future incidents. The recommendation was adopted and the hope was that the leniency would lead to an improvement in the officers future conduct. If it did not they were to be dismissed from the service.

Governor Metcalf of the Know-Nothing Party

Residing in great state of New Hampshire, USA, myself, I have a small collection of old books, one of which is the "History of New Hampshire" by John N. McClintlock Copyright 1888. It quotes

"In 1852 the Democratic party seemed strongly entrenched in power in New Hampshire, and were arrogant and overbearing. The Know-Nothing movement was introduced to break their solid front; and well it succeeded.

At the spring election in 1855 Ralph Metcalf was elected by the Know-Nothing party. Governor Metcalf was born in Charlestown in November 1798, passed his youth on the farm of his father... veteran of the Revolution, graduated Dartmouth College... elected Secretary of state in 1831 (state of NH). He was re-elected for a second term and died in 1858.

Governor Metcalf was a great lover of romance... and wielded a ready and humorous pen. He was fond of social life, and contributed freely to its promotion."

He was only two paragraphs in the entire book, and only a footnote twice as the Governor who appointed men to the bench, who later themselves became famous. It sounds as if he just was a man who knew how to have a party and that's all. As an aside, the author's partner and contributor of many of the pictures in the book was Henry H. Metcalf, no other information given.






