

"A TORTUOUS AND UNGODLY JUMBLE"

The title to this Article might suggest your family history research into the Metcalfe family. It is certainly an apt description of mine prior to 1800! However, that is not what this series of articles will be about.

On the 17th June 1880 my Great Grandmother MARY METCALFE married my Great Grandfather THOMAS LAMBERT at Linton-in-Craven Parish Church, in the West Riding of Yorkshire. After various adventures which need not concern us here, including emigration to Texas where my Grandfather CECIL WILLIAM LAMBERT was born, they settled in Cheshire. In May 1903, Thomas bought Ashton Old Hall Farm at Ashton-upon-Mersey for £7,700.





Seventy years later, in 1972 a colleague, at the firm of solicitors where I was articled, was acting for a client who was buying a house on Lambert Drive in Ashton-upon-Mersey. He showed me an Abstract of Title which was amongst the deeds.

An Abstract, as its name suggests, is a document which the seller's solicitor would prepare in the form of a precis of the relevant title deeds required to "deduce" (that is prove or establish) ownership of the premises to be sold. The purchaser's solicitor would eventually check it with the original deeds. The Abstract which I saw included references to one Thomas Lambert. It extracted the description of the Farm and referred to a plan, which was traced onto the Abstract. It contained in addition references to Thomas buying the fee simple estate and being subject to the payment of a yearly rent of £1. 16s.6d. created by a deed of 1749 and subject also to "suit and service at the Court Baron of Ashton -upon -Mersey" and attendance at the Manor of Ashton -upon-Mersey.

My colleague wondered if there was any connection with my family. I was intrigued as a boy to be told that there was a road named after the Lambert family in Ashton and after looking at the abstracted Will and codicils of Thomas Lambert and the references in it to his children, I realised it was indeed my Great Grandfather and his widow Mary, who died in 1921 and 1926 respectively. I discovered shortly after that Mary Lambert's maiden name was Metcalfe. Thus started my "gravedigging" (as my younger brother calls our hobby!) and my interest in the Metcalfe family.

As I started to do my family history I soon realised that the majority of documents which we use, when researching our family's antecedents, were prepared by lawyers or civil servants for legal purposes, not with family historians in mind. None more so than title deeds to land, as you will gather above from the brief extracts of the 1903 Abstract of Title. What is a fee simple? What was "suit and service" and what sort of Court was the Court Baron?

Very few articles seem to have been written about title deeds or the legal system which created them. It was the latter that Oliver Cromwell allegedly called "a tortuous and ungodly jumble", hence the title of the article. I intend to try to unravel some of the "jumble" below.

In this first article, I will concentrate on how land ownership in England (and Wales) developed. I should say at the outset that I will not deal with Scottish law, which has its own different system.

LAND OWNERSHIP

Most of us will I am sure remember from our school history lessons something called "the feudal system". It was something that the Normans brought when they invaded us in 1066 was it not? Something to do with the King and his Barons, Lords of the Manor, Common Land, Serfs and Villeins. It rings a bell does it? If it does it will stand you in good stead when

reading this article.

The basis of land ownership in England and Wales is what might seem, at first, an odd concept namely that there is only one person who can own land and that is the Sovereign. He or She does not of course physically occupy that land. The rest of it is held by tenants who hold directly from the Crown or, more likely, indirectly from the Crown.

This is the first, fundamental, principle of English Land Law. It is crucial to an understanding of the subject. None of us "owns" our house but instead we hold what is called a tenure. The ability to grant rights over the land lay, at the top, i.e. with the Crown. After the Norman Conquest, William the Conqueror granted large areas of the country to his supporters. They did not "own" the land given to them but held it. The word "tenant" is derived from the Latin word "teneo", which those of you who learnt that subject at school might recollect means "to hold". All subjects of the Sovereign who were "landowners" were in fact "holding " their land and did not own it.

The feudal system was a very ordered structure. It has been likened to a pyramid, with the Crown at the top. On the next level below the King were his Tenants, who held directly from him. They were called "Tenants in Chief". They were granted their tenure in return for them giving their Sovereign some service (as to which see below). The Tenants in Chief were in turn able to grant tenures to their tenants, who were called "mesne tenants" (that is intermediate tenants). So, beneath the Crown were the Tenants in Chief and below them, in effect on the third level of our pyramid, were the mesne tenants, who could in turn grant tenures below them and so on, in theory, ad infinitum. The person who granted the tenure was called the lord.

Each granting of a tenure was made in return for a service to the lord who granted the tenure. A Tenant in Chief could therefore be a tenant of the King and at the same time a lord of a mesne tenant. (See fig. 1)

This method of creating new tenures by a lord to another, below him, was the method by which land was transferred or in modern terms "sold" or "conveyed". It was called subinfeudation, a good word for those who delight

in Scrabble! The ability to subinfeudate was stopped in 1290 and thereafter it was impossible to create new tenures (unless the Crown did so).

TENURES AND SERVICES

A tenure would be granted as stated above until 1290 in return for services. There was no monetary payment made. The types of services which had to be rendered to one's Sovereign or lord were many and varied. There were two kinds of tenure: either "Free" or "Unfree".

I propose to deal with "Free" tenures first, which were so called because the tenant only had to carry out the obligation or service to his lord prescribed when the grant of land was made. If he rendered the service, he was free from all other services, although he did need to comply with a number of other obligations called "incidents", as to which see below. He was given protection by his lord and the King's Courts would uphold his right to possess the land.

Broadly the services of a free tenant can be divided into three types: Grand Serjeanty, Petty Serjeanty and Socage. Grand Serjeanty was a type of service given directly and personally to the Sovereign. The honour of bearing the Royal standard in front of the army, whenever the King was in Montgomeryshire, was the service required of the tenant of the Manor of More in Shropshire. Not too onerous unless there was a war in that part of the Kingdom!

The obligation of purchasing and carrying at the Coronation Ceremony certain vestments of the King was the service required from occupier of the office of Lord Great Chamberlain, which entitled the office holder to enjoy the "ownership" of several manors. Less pleasant might have been the service required from one hapless tenant who was required to hold the Sovereign's head "as often as he shall pass over the seas between Dover and Whitsand". Presumably he prayed for calm seas or a Sovereign who was not sea sick!

There were certain "rude" or downright crude services but I am going to disappoint you and refer only to one! This was the service of keeping and taking care of the King's "whores, launderesses and women" which was the obligation of Robert Testard of Guildford.

Petty Serjeanty was another type of personal service. It was rendered to the lord, not just the Crown. One example of the type of service was the obligation of the tenant to provide a number of armed horsemen and horses, for forty days to the lord. The feudal army of the King depended upon this service to raise his army. A lord could pass this obligation on to his tenant,

who in turn could do so to his tenant. It became known as Knight service but by 1200 because of the difficulty in raising an army in this way it had been replaced by a monetary payment called "scutage". This was fixed at 20 shillings (i.e.£1) per Knights fee.

Socage was the more common type of service, particularly in Manors, and it is from this that what we call freehold land is derived. The tenant who held land in "common socage" would perform non-military obligations. He would plough a certain number of fields for the lord of the Manor or cultivate the lord's land on a specified number of days in the year, those to be chosen by him and not as ordered by his lord. By the 15th century this manual labour was ,like knights service commuted to a monetary payment or rent called a "quit rent". The lord would use the rent collected to pay for the land to be cultivated.

INCIDENTS

As stated above, the free tenant was free from carrying out other services, if he complied with those imposed upon him but he was subject to certain "incidents". It was one of these to which I refer at the beginning of this Article, namely the "suit and service" of Thomas Lambert at the Court Baron of the Manor of Ashton.

The most important incident so far as the feudal system was concerned was the incident of "fealty and homage". A breach of this was a "felony" which, as an aside, eventually was the word used to describe serious criminal offences. The act of fealty and homage was a public ceremony at which the tenant swore faithfulness to his lord and acknowledged that he held the land from the lord. In return for this, the lord would uphold the tenant's right to occupy the land. As will be seen it formed part of the land transfer procedures too.

The next most important incident was attendance at the Manor Court for free tenants which was originally called the Court Baron. This was perpetuated until the 20th Century although in virtually all cases fell into disuse, by the 19th century if not earlier. There does not appear to have been any Court at Ashton-upon-Mersey for several years prior to 1903 in my Great Grandfather's case.

I propose to write about the Court records that might exist and their whereabouts in a later Article. Also to refer to the incidents of "wardship". "marriage" and "death". I will also explain about the "unfree" tenures and how land was conveyed until the present day. I intend to give a book list and references to Websites which you might find useful too.

From the Whitby Gazette 17 March 1866. An accident happened at Port Mulgrave Ironstone Mines of Messrs Palmer and Company a few days ago. **Christopher Metcalf**, a miner, had fired a shot as he was returning to his work a quantity of roof fell upon him. Assistance was obtained and when extricated it was found that his thigh was broken and that he was severely bruised about his body. The bone was set by Dr Williams under whose care we are glad to hear he is going on favourably.

From the Daily Exchange 16 March 1881. Four deputies George Winter, George Johnson, **Christopher Metcalf** and a Cumberland man were engaged "drawing a place in the brokens" in the Loftus Mines. They had almost got their work completed, the workings being perfectly "quiet" and apparently safe, when about to remove the last piece of timber the place "came in". Winter was buried with timber and fallen stone and when extricated was dead. Johnson was knocked down but escaped with bruises. Both from **Dorothy Pope M55**

Chairman's Report

Last year we celebrated the 21st. Anniversary of the foundation of the Society. This year the nation will celebrate the Golden Jubilee of the Accession of the Queen to the Throne.

I find it remarkable to think that 25 years ago, when we celebrated the Queen's Silver Jubilee, the Metcalfe Society had not been founded. Indeed, how many of you were interested in family history or tracing your Metcalfe family ancestors? Many of you will be using computers at home, for your family history research and probably regularly "surf the net" on the Internet. The explosion in pamphlets and booklets on the subject of family history and the establishment of and growth in the number of Family History Fairs have all contributed to the unprecedented popularity of the hobby.

It demonstrates how, within a generation, the world we know can change beyond our wildest dreams. What may lie ahead for the Metcalfe Society I am not going to foretell, save to predict that the family history world will continue to make use of computers and that "pay for view" services are likely to become the norm for researchers of Public and Family History Society records. You only need to look at the Society of Genealogists arrangements with Origins and those of the Public Record Office with Qinetiq to see the way in which matters are moving. The Government has produced a White Paper on: Birth Marriage and Death Registration in the 21st Century, with some far reaching proposals, which deserves to be considered urgently by you all. I intend to ask the Committee to consider it so we can comment.

Whether our Society moves down the "pay for view" route and how, is something that will be discussed in the coming months. A great financial threat to Societies generally lies in the ability of commercial businesses to replicate their project work onto CD ROM's, for financial gain. Societies such as our own might be safe for the time being because we are only interested in one family but the warning signs are there and we will ignore them at our peril.

Last year, the society had to move our main bank account to Skipton because the Barclays Branch in Earby closed. 

I recently had the privilege and the pleasure of being invited to attend the wedding of my cousin. Barbara Burtt is d.o. Phillip & Ilene (Mte) Burtt; g.d.o. James Thurnston Mte (b 1907);g.g.d.o. James Mte (b 1866); g.g.g.d.o. Thomas Mte (b 1838);g.g.g.g.d.o. George Thompson Mte (b 1803); g.g.g.g.g.d.o. Thomas Mte (b circa 1780). The groom was Martin (or Marty) Bercic, a Maori and member of the Nga Puhi tribe. The wedding took place on the Marae at Omapere which is situated near Kaikohe in the upper North Island of New Zealand.

Before the ceremony we were each given a hand-out explaining the Marae Protocols In addition we had a gentleman with us who enlarged upon them, giving a good outline of what was being said and we found this most helpful. Most of us were quite moved and I personally felt a sense of great awe. As we entered the Meeting House we removed our shoes and found a seat. You are not allowed to eat or drink in the House. The women are normally seated apart from the men and have no communication with them during this part of the ceremony.

To explain the ceremony I cannot do better than quote from the official handout-

The "Powhiri" is the Welcoming ceremony when visiting the Marae. It is a "Sacred Encounter" for visitors, who are considered "Sacred Life Forms" bringing spiritual and physical attributes. Both need to be addressed and it is the Powhiri ceremony that recognises this status. On its completion, visitors then become members of the extended "Whanau" (family) of the Marae.

There are six major components of the Powhiri. These are:

- Huihuinga The gathering of the party at the gateway to the Marae;
- Wero The Challenge;
- Karanga The call onto the Marae;
- Whaikorero The speeches;
- Hongi Traditional speeches;
- Kai/Hakari Food/feast

There are two groups required for a Powhiri; "Tangata Whenua" (hosts) and "Manuhiri" (visitors)

When Marae visits occur, Manuhiri Huihuinga (gather) at the gateway and greet one another prior to being welcomed onto the Marae. It is also at the gateway that speakers for the visiting party are selected. Here too. The "Koha"

"Wero" (Challenge) is normally made to gauge whether the Manhuri intentions are peaceful or not. (On this occasion there was no Wero as the peaceful intentions of the bride and groom had already been established.)

When the local people are organised, the visiting party will be notified to enter the Marae by a "Karanga". The purpose of a Karanga is to weave a spitual rope allowing safe passage for the Manuhiri to enter onto "Te Marae Nui Area o Tumatauenga" (Domain of the God of War), which is the courtyard in front of the "Whare Tupuna" (Ancestral House – the domain of the God of Peace). The Karanga is the first voice to be heard in the Powhiri. Traditionally it is the women who do the Karanga; however, in "Taitokerau" (Northland) it is also common for men to participate.

The party should proceed on to the Marae with their women in front and the men behind. At the half-way point between the gateway and the Whare Tupuna (Ancestral House) it is appropriate to stand briefly in silence. This is a mark of deep respect and honour to the Ancestors, the local people and the Marae. Everyone is then led into the Whare Tupuna (Meeting House)

Shoes should be removed before entering the Whare Tupuna (although the bridal party has been granted dispensation). The Manhuri stand for a moment's silence at the end of the Whare Tupuna to honour those who have passed away and then they are seated on the right hand side of the Whare Tupuna. Men are usually seated at the front with the women behind. The speakers will be seated nearest the door in front.

Traditionally, only the experts in the art of "Whaikorero" (Oratory) stand to speak to the opposite group. The purpose of the "Mihi" (Historical speech) is to acknowledge and weave together the past, present and future by acknowledging the creator, guardians, the "Hunga Mate" (the Dead), the "Hunga Ora" (the Living those present at the Powhiri) and laying down the "Take" or "Kaupapa" (the Reason) for the Powhiri or event that will take place.

At this Marae and in Taitokerau (Northland), the custom is "Paeke", where the Tangata Whenua speak first and then the Manuhiri speak. Speakers will have "Oriori/Waiata" (Chant/Song). The purpose of the Oriori/Waiata is to show that the people support the speaker and what he has said. Oriori often complement what has been said, the occasion surrounding the Powhiri, acknowledge the speaker's "Whakapapa" (genealogy) or the group itself. The "Koha" (Gift) is laid by the last speaker of the Manhuri to indicate they have no more speakers and have finished.

On completion of the Whaikorero, the Tangata Whenua will indicate to the Manuhiri to come in a certain direction, in line, to shake hands and to "Hongi" (Traditional form of Greeting). The "Hongi" is the first physical contact between the two groups. It is not the widely popularised "Rubbing of Noses" but the gentle pressing of nose and forehead. Variations include a peck on the cheek of women as well. This practice originates from Maori history and is a symbolic reference to the first breath of life that was issued to "Hineahuone" (First Maori Women) and shows the "coming together" of the two groups to be united as one under the umbrella of the Powhiri. It is the mixing of the "mauri" (Life Force) of both the Tangata Whenua and the Manhuri; it is the first physical contact.

After the Hongi, the seating will be hastily rearranged for the wedding ceremony. The bridal party, who have already had the Powhiri ritual the previous day, will then be called on to the Marae by a Karanga. The wedding cer-

emony will be conducted by Father Brian Prendeville after a mihi by the Kaumatua to "Whakatau" (acknowledge) the bridal party. A hand-out will be given to all at the ceremony.

On completion of the ceremony a light Kai of sandwiches and tea will be held in the "Whare Kai" (Dining hall), the final stage of the Powhiri, the "Tapu" (Sacredness) of the Powhiri ritual is balanced by the sharing of "Kai" (Food). The Tangata Whenua and the Manuhiri are now one. The sharing and partaking of food lifts the final Tapu of the ritual. During this time there will be a brief period for group family photographs with the bride and groom before they depart for more formal photographs.

At 5.30pm a "Hakari" (Feast) will be held at Omapere Tourist Lodge in the reception hall. As usual, speeches will take place during the Hakari.

KIA ORA

"Speeches will take place during the hakari." This is an understatement. Today's proud and peaceful Maori descendants of early fearsome native warriors prefer to believe, in the words of the late Sir Winston Churchill, that "Jaw, Jaw is better than War, War" and all seemingly are Past Masters in the noble art of Rhetoric. Speaking with equal ease in either the Maori tongue or in English with apparent impartiality and equanimity, the sympathy of the crowd is quickly captured by their garrulous and sonorous oratory, the force of which is matched only by the vociferous enthusiasm given to the melodious and harmonious song of approval traditionally sung after any speech that pleases the assembled company. The success of the speechmaking can be measured by the fact that it continued for two hours, during which time the champagne continued to flow.

Metcalfe Clan members worldwide, on reading this account, will wish the marriage every success.



A WARNING!

Alan Vickers M843 writes "I have been running anti virus software for some considerable time now. Three weeks ago I was infected for the second time from a source who I trusted with quite disastrous results. I was using software which was not quite up to date and failed to stop the virus and, when updated, also completely failed to locate infected files or to remove files which were reported to be causing the problem. The software also failed to stop the computer sending out infected files. I then realised that the software had been crippled by the virus.

My computer actually tried to send the infections to two universities and two government departments. One of these was MAFF where I had attempted to access their website during the first two weeks of the foot & mouth epidemic but had failed to do so because the website was so busy. These experiences are at variance with what was reported to be the practice with the virus. As a result of the above I have bought Norton AntiVirus (£49.99) which gives me much more comfort. It has updated itself (automatically) three times in the last two weeks. It located files which the previous software did not find and also removed all the problem files without any trouble at all. Recently I accessed my emails and a message came on the screen to say 'software updated'. I downloaded 11 emails, the software was updated and the files re-configured, all within a 5 minute telephone call. All incoming and outgoing emails to and from me are checked as virus free. Ironically, emails from the source of my infections now carry a message that they are 'virus free' so the sender has learned his lesson also."

Diane Howarth our Secretary comments - "As you can see, Alan is one of the unlucky ones who has experienced virus problems. I think his experience highlights:

- -the kind of problems you can find with your system
- -what to watch out for in your incoming e-mails especially attachments (these are where the damage occurs)
 - -the products that are on the market
- -the importance of regularly getting updates to your virus software and running it automatically

For those of you who are used to working with computers everyday and having to deal with anti-virus, I know you know all about it, but won't mind me banging on about the subject. But for those who use their computers for enjoyment and light use, I can't stress enough the importance of buying one of the market leaders such as Norton Anti-Virus and then getting regular updates from Norton (as new viruses are known) and then running the software every time the computer is switched on. As Alan says, it is the attachments

which do the damage, so if you ever send an attachment do refer to it in the text of your note so that the recipient knows it is valid. If you receive any file which has an attachment and the text does not refer to it, do not open it delete it immediately no matter how valid it looks. Given how the society uses e-mail more and more to communicate between members and the committee, it is a general subject which can affect all computer user members."

Book Review

Memories of Upper Wharfedale by Thomas Hebden Metcalfe, first published 1999. Available from (cheques payable to) the Wharfedale Family History Group, Mr S Merridew, 206 Moseley Wood Gardens, Leeds LS16 7JE. Cost £3.75 plus p&p (UK) 50p, (Airmail) £1.35.

The author, born at Buckden in 1917, lived for several years from the age of six at Beckermonds in Upper Wharfedale and the first section of the book recalls that period. It opens with a map of Langstrothdale and Upper Wharfedale, marking villages, hamlets and farms from Cam Houses and High Greenfield at the farthest end of the dale down to Kettlewell. This is followed by a systematic brief account of those who were the Metcalfes' "Friends and Neighbours"; every farm is listed with details of successive occupants and their families together with many snippets of additional information, such as "Jimmy Beresford died in that bad 'flu epidemic in 1928 or 1929". Anyone with ancestors or just a general interest in this part of the Dales will find Mr Metcalfe's memories fascinating, particularly as the period he covers falls into that currently awkward gap between available census returns and personal recollection.

Part 2 depicts "Life on Buckden Estate" up to World War II - the deer, the grouse, the entertainment, the trades people and the part played by Hubberholme Church. Mr Metcalfe also describes the work he himself did in farming on land drainage during the war and as a council employee on road widening and other projects - an impressive account as is that of his many spare time interests. Three short appendix sections include "The Dales' Song" and a 1938 extract from The Craven Herald reporting on the £84,000 estate left by the lady of the manor of Buckden, Miss Compton-Stansfield.

This gem of a booklet paints a vivid picture of life in the early 20th century as seen through the eyes and mind of a remarkable man and is thoroughly recommended.

29 Michael Tirry, a lay schoolmaster of Aysgarth, first [1569] got into trouble through the rebellion. In two autobiographical documents he has left us a very complete picture. He was a native of Ripgarth, Aysgarth and left school at the age of eighteen. His account of the courses which were then open to him should dispel any prejudices that Wensleydale was then a totally remote backwater. On the one hand he was offered a job in London with a haberdasher-clearly a connection; Sir Christopher Metcalfe of Nappa offered him a benefice if he would get ordained. Back in Aysgarth-apparently very shortly before the Rising (though here his rough dates are hard to follow) he acted as a private, unlicensed tutor in the house of Leonard Metcalfe of Bear Park-who was attainted for his part in the rising, but pardoned.

41 The two other notabilities amongst the nonconformist 'old priests' were 'Mr Copley' and Dr Thomas Marshall. Marshall was deprived in 1560 of the deanery of Christchurch, Oxford, and the following year thought to be a dangerous papist, lurking in the houses of the Earl of Cumberland and his brother-in-law, Metcalfe of Nappa, Aysgarth.

54 Then in 1569 a small contingent of North Riding Catholic rebels fled abroad to Flanders- the Nortons, John and Ingram Thwing of Over Helmsley, Robert Heighington and John Gower of Richmond, Leonard Metcalfe of Aysgarth and an unidentified 'Mr Rokeby'.

77 In 1563 a new Statute imposed the penalties of *Praemunire* on attorneys or administrators of the law who refused the Oath of Supremacy..... The Archbishop [Young] proposed six to replace the suspects. One of these was Sir Christopher Metcalfe of Nappa, who had just been reported as harbouring Dr Marshall, a runagate popish priest.

82 .. the great majority of the gentry ... sympathised with the rebels and only held aloof out of prudence ... There seems to be no doubt about the independent standing of men like , Leonard, John and William Metcalfe of Bear Park, Aysgarth, Oswald Metcalfe of Wildon Grange, , William Metcalfe of Hemming.

84 the rebel lists contain no Metcalfes of Nappa, and probably Leonard Metcalfe of Bear Park Aysgarth made good their escape to Flanders.

85 We certainly hear of a few rebels who refused pardons proffered (John Gower of Richmond, Leonard Metcalfe of Bear Park, Oswald Metcalfe of Wildon Grange, Anthony King of Masham)....

87 Leonard Metcalfe's undoubted recovery of Bear Park, Aysgarth, is a mystery. He seems to have gone into exile and then returned home. We are uncertain whether to include in this list the ninth case, of Oswald Metcalfe of Wildon Grange. He was a younger brother of Sir Christopher Metcalfe of Nappa, and, as a rebel refusing pardon, was due to lose his property in 1570. That property then consisted only of a Crown lease of Wildon grange (ex-monastic) and the reversion of lands in Skelton, Overton, bought from the Nelson family. He may well have lost these, but by 1577 he was again a landowner in the Riding, prospering and buying a third of the Conyers manor of Hornby Castle.

89 In Aysgarth there were eight offenders; one, Roger Metcalfe, was a determined recusant who defied the High Commission, Leonard Metcalfe (the returned rebel) of Bear Park was a complete recusant but at least told the Commissioners he was willing to swear he would conform (in the event he did not); Henry Metcalfe of Bear Park was a recusant but excused himself as having no certain home; the rest were at least occasional conformists suspect of popery.

A GENEALOGICAL JOURNEY

My story begins in Bedale, Yorkshire, passes through Stockton and Leeds and ends in New Zealand. It is a story which arose from my curiosity about the name Audaer which was the married name of my aunt, Alice.

My Grandfather, Henry Metcalfe, was born in Burneston to George and Elizabeth (Gatenby) in 1863. George was born in Bedale and his family had lived there for many decades. George died at the age of 38 years and it appears that Elizabeth remarried to a Thomas Banks who shifted the family to Stockton-on-Tees in the late 1870s.

Young Henry met and married Patience Barratt in 1886 and they moved to Leeds where he is recorded as a fried fish dealer in the census of 1891. By the time my father was born in 1896 Henry was the owner of the New Inn in Woodhouse Lane. Henry and Patience had 13 children altogether but it is Alice, the eldest, who fascinated me. In 1907, at the age of 21, Alice married Walter Audaer, born in Scarborough in 1887. They had seven children, five of whom lived to adulthood, and it is the search for these five children that was to occupy some of my research time.

Henry and Patience immigrated to New Zealand in 1911/12 bringing twelve children with them. Alice and Walter stayed in Leeds. During World War 1 Walter served in France in the King's Own Scottish Borderers. I have postcards written by Alice at that time and they describe the terrible conditions, with shortages of staple foods and the queues which formed in order to get such items as potatoes. Her health was not good and she worried about the children. She was always grateful for the postal orders which were sent from New Zealand.

In October, 1918, Alice died of lobar pneumonia and heart failure, so Walter was left with 5 children aged from 10 years to two weeks. It appears that the children were put into an orphanage in Bristol and we hear no more of Walter at this stage. When Edith, the eldest, reached the age of 13 or 14 she was sent out to New Zealand to our family, while the others stayed in England and never heard from, or saw their sister again. Edith married here in Christchurch in the late 1920s and then lost contact with her New Zealand family, although she lived in the same city. I grew up knowing about her, but I never met her.

About 6 years ago I read a query in the NZ Genealogical Magazine that included the name Audaer. Promptly I was on the phone as the person lived near my place of work. At last I would find out what had happened to Edith. It turned out that June is the daughter of Edith and that her mother had only died only about 4 years before. We were able to share our family research and we've kept in touch ever since. I've also met her sister who was born in the same year as me. This prompted me to turn to the Internet so in November 3 years ago I posted a query on a genealogical chat page and — within days there was a reply from Alan who lives in Canada. His mother was

Dorothy Audaer, one of the girls left in Bristol. Alan then told me about Val, who still lives in Bristol, and whose mother was Patience Audaer. He also mentioned Harry, the only son, who remained a bachelor, and who died in 1979 in Portsmouth, aged 66 years. Only one child remained a mystery and she was only found because in 2000 I received a letter from Leeds enclosing a copy of a letter to the Editor of the Leeds evening paper which I had written years ago in my pursuit of the Audaers. It appears the Alice, the mystery child, had seen my letter, cut it out and then put it away, and it only came to light when her son, Malcolm ,found it after her death.

The result of my contact with him was that Malcolm and his wife came out in January last year to celebrate his 60th birthday and they were able to meet the relatives here in New Zealand. Alice, his mother, had been brought up by a neighbour, in Leeds, and although she was adopted when in her teens, she knew about her natural parents. She obviously never met her siblings.

So now the mystery has been solved and the Audaer cousins are in contact with each other. Walter apparently married again and had one more child, Dennis. A happy ending to my story but we regret the fact that Alice's children were not able to see the completed "jigsaw". Alison Hutton M81

Tom Metcalfe of Hawes

In Issue 62 we included a small snippett on the fell runner Tom Metcalfe which involved some kind of controversy which, was not given. Later **Hilda Lunn M769** wrote in and said that Tom was her mothers cousin but unfortunately she had no news of what the controversy was. She did however provide a newspaper cutting from the Telegraph and Argus of 7 September 1956 which read as follows:

"Mr T Metcalfe of Manningham who was among the first to congratulate Keith Clements on his notable victory, knows the route (the Kilnsey Crag race) well, for he won the race on seven successive occasions, his first win being in 1902. Mr Metcalfe also won at Burnsall four years in succession.

A correspondent recalls meeting Mr Metcalfe in the home of a relative at Appersett, Upper Wensleydale when he declared "We used to live on oatmeal porridge and plenty of black treacle which was 1d a jar. We'd get a bucketful of blue (skimmed) milk for 1d and use it on the porridge."

Mr Metcalfe's early life in the Dales before he moved to Bradford was guaranteed to expand the lungs and strengthen muscles for he worked in Turner Fell Pit, six miles from Hawes, which had been worked by the Metcalfes ever since it was opened and supplied coal to the greater part of Wensleydale. His wages were 15s (75p) a week.

"Coal was 8d (3p)a cwt and the carriage was the same price as the coal." he recalls. "I've sometimes walked to walk over 6ft of frozen snow and very often I'd dig out sheep I came across during my journey. Local farmers paid 2s (10p) for every animal recovered."" 12-14 April 2002. The Yorkshire Family History Fair will be held on **Saturday 29 June 2002** from 10am to 4.30pm at York Racecourse, Knavesmire Stand. The North West Family History Fair has moved its date and its location for this year's event. It will be held on **Sunday 27 October 2002** from 10.30am to 4.30pm at Manchester Town Hall.

For the last three years it has been held on a Saturday at Preston Guildhall. But as it is in a city centre this year it makes sense to move it to a Sunday. Transport by Metro and Bus will also be easily available. Admission is £2, free street parking as it is a Sunday, refreshments, licensed bar.

You may be looking for a particular birth in a particular parish and so need to do some research? STOP! Before you get started.... someone may have already done the research and sent it to the Society, and therefore completed the work for you!!!

What is a 'List'? A List comprises of the FULL details of those individuals recorded by our members from any one source. This can be from parish registers, census returns and members' own family pedigrees etc: For example: "Ripon, North Yorkshire, Cathedral baptisms 1821 to 1900"..... means that details of all Metcalfes baptised at Ripon Cathedral between those years have been recorded.

Sending research results to the society. Whenever a member has completed some research, we request they send a copy of these research results to the List Coordinator (contact details on inside front cover of this issue). On receipt, these research results become a 'List'. A list may cover a short or long time span, there are no fixed rules. It is allotted a unique number, prefixed by a capital L, and the data is added to our records in our own Computer Index. As our Computer Index keeper updates the various records, this List number is then also written on the record so that we can see the sources of all the information on that record. This is extremely important to enable us to validate and authenticate any information from our records that we give to you, our members.

How is it beneficial to you? As you know our Archivist can do research for you by sending her requests. But if you want to do your own research, or you want to search a specific parish to find out if there are any relatives of your Metcalfe individual, or do more of a general search in a census return, then you may request a List. So before you do any of your own research do stop and check with Anita to see if the research has already been done and recorded in one of over 2,500 Lists that we currently hold. An Index of all of these Lists is currently held on the Members Only section of the web site.

How to request a List? When you request a List, please make your detail as specific as possible eg looking for the birth of John Metcalfe in Sedbergh and surrounding area between 1830 and 1835. Please don't ask for all the births in Sedbergh or Darlington and surrounding villages 1820-1850. Send your requests via post or e-mail to Anita O'Donoghue, our new list coordinator. Return postage would be much appreciated. Anita will use her own discretion when dealing with your requests.


Sampler by Margaret Metcalfe age11, 1852 Donated by Mrs K M Parker


