

tional home of the Metcalfe's - Askrigg in Wensleydale. Everywhere you looked there were scarecrows. As the weekend wore on some looked the worse for wear suffering from the blustery heavy showers, especially the queen who by the Tuesday was barely hanging on to her position over the window of Sykes's shop!

I took some photographs and was hoping to include them in this issue but unfortunately with the change in circumstances regarding our copying arrangements I have had to reduce the non-text items to a minimum but hope to include them in the December News. THE RAYDALE SEIGE or the ruin and overthrow of the Nappa Metcalfes

If you travel up the south side of Wensleydale to Bainbridge then head south along the banks of the River Bain (which at two miles long is the shortest river in England) you arrive at the peaceful lake of Semerwater. The lake, claimed to be the site of an Iron Age village, nestles at the base of the hills and at the end of a summer's day the picture is of peace and tranquility - but it was not always so. In the fourteenth year of the reign of King James the First of England, around mid-summer's day it resounded to the sounds of battle in what was called 'the last private war in England'.

The seeds of conflict were sown some sixty years before and involved the Black Knight of Nappa - Sir Thomas Metcalfe. Sir Thomas was short of funds; he had entered litigation with his tenants over the demand for the payment of a hay tithe which they disputed. Whilst he won the legal battle he alienated his leaseholders and incurred costs of £2000, a massive sum for those days, which "was the ruin and overthrow of his estate".

The latest of a number of legal disputes in 1609 coincided with a further elevation of the thirty year old to the rank of Commissioner by the Lord High Treasurer, Robert Cecil. However the elevation, the court case, the ongoing dispute over the tithe collection with his tenants were costing him dearly and he was forced to mortgage part of his estate in Raydale. A small local landowner William Robinson of Warton loaned Sir Thomas £1000 for a six year lease of the land. They agreed that the Black Knight could retain Raydale Hall paying an annual rental of £100 over the lifetime of the lease.

The legal disputes with his tenants "the greatest number of them being his own name and kindred" continued and this may have been part of the reason why at the end of the lease no repayments had been made. As a result Robinson foreclosed and placed his son John Robinson in Raydale Hall. Sir Thomas reacted angrily by expelling the younger Robinson and installed his own steward. A flurry of legal proceedings followed with charge and counter charge being laid before the courts throughout the spring and summer with Judgement finally given in the autumn of 1616 against Sir Thomas.

On 20 May 1617 John Robinson finally took occupancy of the Hall but that was not to be the end of the matter. Even more incensed at the result and in an attempt to recover what he considered to be his property the Black Knight gathered together sixty of his family and retainers including his wife, brother - Ottiwell Metcalfe of Swinithwaite and his nephew and on the evening of June 17 arrived at Raydale Hall.

The Metcalfe party was met by John Robinson's barefoot wife who had been in the progress of retiring for the night, who asked them why they were on the

property. For her pains she was beaten senseless and left in a ditch whilst Sir Thomas, not one to stand on ceremony, demanded that the other occupants leave the house. At the negative response from the house the group armed with muskets, pikes, javelins and long bows attacked the Hall

John Robinson together with some of his brothers and retainers piled featherbeds, pillows and furniture against the doors and windows and proceeded to return fire. Their accuracy was greater than the attackers with Thomas Hodson (some reports say James Hodgson) being fatally wounded. This incensed the band of attackers and they threatened to hang all those within the house. Lady Metcalfe (Elizabeth, daughter of Sir Henry Slingsby of Scriven) offered money to a local woman to burn down the Hall! Mrs Robinson, who recovering conciousness after her beating, fled the scene and made her way to York to put her case before the Council of the North. She also informed her Assheton and Grenacres relatives (well known Lancashire families) of their predicament and it was they who next encountered the raiders.

The defenders continued to thwart the attackers with a stand-off resulting. The Metcalfe party leaving some at Raydale were found over the next few days in a local village "drunk and insolent" when Nicholas Assheton and an elderly Richard Greenacres, with only a servant each sought to resolve the matter "by a peaceful and quiet proceeding". Their request to speak with Sir Thomas resulted in a George Scarr and others being despatched from the Metcalfe camp. However this group's demeanour was so threatening that the small party worrying for their safety withdrew.

After four days and some seventeen fruitless sorties against the Hall the seige was lifted by the arrival of a sergeant at arms and his men sent by the Court at York who took Sir Thomas and six of his men into custody. So ended the Siege of Raydale. However the ramifications rumbled on for some time with Sir Thomas encouraging the local coroners court to bring a charge of wilful murder, rather than manslaughter against the defenders. Even this action failed. Whilst the jury endorsed the murder verdict it was overturned by the Star Chamber with the coroner being fined £1000 (a poor return for his £10 bribe from Sir Thomas) and the Black Knight receiving a further £2000 fine added to the £1000 he had been fined for undertaking the seige!

The financial situation of the Metcalfes of Nappa never recovered from these setbacks; although monetary support from Lady Metcalfe's relatives helped to maintain their social position "the Metcalfe power was lost". So next time you are in peaceful Raydale remember that midsummer Siege.

Report on the March meeting

Chairman:

The Committee had all been saddened by the untimely death of Nina Benson's husband, Michael and condolences had been sent to Nina.

Secretary: Diane noted that there had been a promising number of enquiries about joining the Society and from those wishing to register an interest in the proposed new edition of "Metcalfe - History of the Clan".

Treasurer: The new Treasurer, Carol had spent time computerising the records. She outlined how the paypal system worked for making payments via the internet. This would be tried out with overseas new member applications who wished to use this method and then be reviewed at the next Committee meeting.

Archivist: Eileen reported some traumas with the computer but was now settling more comfortably into her new role.

List Coordinator: The Committee gratefully accepted Anita O'Donohue's offer to take on this role, as Alan Vickers had stepped down.

New Members' Secretary: Carol reported that 51 new members had joined since the last meeting.



Master Membership File: There were 435 current members: 326 from the UK, 32 in the USA, 28 in Australia, 24 in Canada, 18 in New Zealand, 4 in France, 2 in South Africa and 1 in Germany.

Agents: Alison Hutton had kindly volunteered to take over as agent in New Zealand.

Editor: Peter reported that the new scanner and printer had led to improved quality of picture reproduction in the "Mecca News". While grateful to regular contributors, he would welcome more articles from members who have not yet seen their work in print

Computer Index: David has merged over 3000 burial entries with the Main Index. There are now nearly 82,000 entries on the Main Index. The Committee accepted his kind offer to collect Metcalfe entries from the 1901

census, using the resources at Leeds Central Library.

Web Administrator: Carol was congratulated on winning a web award for the site. This also reflected the hard work of Susan Harper in building the site initially. Those with roles in the Society all now have e-mail aliases.

Publications: Diane had completed the updating of the various forms used.

Affiliations: The Society plans to be represented at the Genealogical Fair on

York racecourse on 29th June and at the North West Fair in Manchester on 27th October.

Conference Secretary: There was discussion of the plans for the Muster due to be held at Askham Bryan College on 5th October.

Projects: Plans are now well advanced for the publication of the second edition of "Metcalfe - History of the Clan", which should be available by the Muster in the early autumn.

Although Stephen Newman had stepped down from the Committee, he was happy to continue with the Wills project, which was making good progress.

Chairman's Report

I write this during the Golden Jubilee weekend, a time for thanksgiving, reflection and fun. It coincides with the Soccer World Cup. So far as England's team is concerned not one for celebration, rather a lot of reflection and only a bit of fun, if the first game played by them is anything to go by. Thank goodness for Family History many of you probably say.

Our Society has not been established for 50 years, although we are well on the way to our Silver Jubilee. I would like to thank again everyone, on your behalf, who has been associated with the running of the Society since its foundation. It is appropriate here to thank Mary Morris in New Zealand for doing so much for us in New Zealand as our first "agent" there. Mary has had to give up this role and will be greatly missed.

I was looking at our Magazines in 1992 before writing this report. This has caused me to reflect how much the Society has developed in a relatively short period. No Metcalfe Clan Book contemplated ten years ago. The second edition is now at the printers and orders have already, after a matter of weeks, exceeded 100. We were worried in 1992 that we had lost more members during the year than had newly joined. Membership now is very healthy with those joining vastly exceeding those who leave.

The Internet has greatly enhanced our membership and promoted the Society in ways not dreamt of ten years ago. We then boasted 27,000 records of Metcalfes, on computer; earlier this year it stood at 87,000. We were proud to announce,ten years ago, the purchase of a second computer to add to the existing "second hand" model we already owned; by my reckoning we now have 8 computers. We had no overseas agents, who make the Committee's work so much easier. We now have 4 including our new USA agent. The Society had become a member of the Federation of Family History Societies. Last year we were privileged to welcome Lady Teviot, the President of the Federation, to open the 21st Anniversary Muster.

The purpose of our Society is, to me, more than to help fellow researchers to find that elusive piece of information, or ancestor; it is also to educate and to help our colleagues to enjoy doing so, in the company of other like minded persons, whether through the pages of the Mecca News or personally at the annual Muster.

Everyone certainly seemed to have enjoyed themselves over the Bank holiday and I trust you will continue to enjoy being a member of our Society. I look forward to seeing as many of you as possible at the October Muster. **David Lambert**

A CONUNDRUM

To copy or to print that is the question!

For the last 12 years the Mecca News has been published in A5 format, the society has been extremely fortunate to be the benefactor of a free copying service of the three Mecca News journals each year. That is a total of 36 editions of the journal, somewhere between 500 - 700 copies of each 32/40 page edition an awful lot of copying and an awful lot of trees!! This service has saved the society a great deal of money over the years which has been channelled into other projects (eg Metcalfe-History of the Clan) and enabled the society to maintain a low subscription level.

Due to the current economic climate this service has had to be temporarily, and possibly permanently, withdrawn by the provider. You will see a variation on the presentation and the look and feel of this edition of the Mecca News. The society is keeping everything crossed that we will be the bearer of good news in the December edition that this excellent service will be available again. However, if not, then your committee is looking at the longer term cost/benefit implications of paying for either a low quality photocopied Mecca News (as we have been getting) or paying a higher amount for a printed Mecca News of better presentation quality. "A TORTUOUS AND UNGODLY JUMBLE" -- PART TWO -by David Lambert M11

(The second article about title deeds and the legal system which created them. Part I appeared in Issue 66 - April 2002.)

INCIDENTS

On the News today a reference was made to the fact that several "incidents" had occurred which the police were investigating. A word which we are used to hearing but one which 600 years ago had a different meaning.

In this article I hope to explain the reason for the difference between freehold and copyhold tenure. In so doing I will refer to feudal incidents, manorial courts and the important distinction between free and unfree tenants.

In the previous Article I explained that land holding was originally dependent on rendering a service to one's lord in return for the right to hold, under him, the land granted. What I mentioned there was ownership by free tenants. I concluded with a reference to the tenant's obligations to comply with certain incidents.

Manorial incidents were the source of great wealth to the lord, including it should not be forgotten the Crown. They included: "heriot", "homage and fielty", "wardship and marriage" and "escheat". The most crucial incident was that of "homage and fealty". The swearing of loyalty to the lord and agreement by the tenant that he would attend the lord's court. In return for this the lord contracted to uphold the rights of occupation ("seizin") of the tenant. Having sworn his loyalty to his lord, the tenant was required to attend the lord's court. It will be seen that this became part of the conveyancing procedures.

- "Heriot" was the right of the lord to the best beast or a sum of money (usually 5 shillings (25 new pence)) payable when the tenant died.

- "Wardship" gave the lord the right to manage the holding for his own profit where the tenant had died and was survived by a male heir who was a minor, that is a boy under the age of 21, or was survived by a daughter who was unmarried, under the age of 14. At the end of "wardship", the former ward would have to pay the lord a "relief"(a monetary payment) to take up his landholding. During wardship the Lord could chose a spouse for the ward.

- "Escheat" was in effect the forfeiture of the tenure. It occurred :(1) on the death of a tenant without an heir; (2) if the tenant was convicted and sentenced to death for a felony; or (3) if the tenant was in breach of his obligations to render services to his lord. On escheat, the holding went back to the lord and the tenant was dispossessed.

In the case of the free tenure in common socage, the tenant was primarily only subject to the incident of escheat. The services were commuted to nominal sums of money. In 1290 the statute of Quia Emptores prohibited the creation of new tenures and allowed all free tenants to transfer or convey their land holdings to third parties without the consent of the lord being obtained. Tenure in socage accordingly became more valuable to the tenant. The holding was subject to the performance of the few onerous existing services and only one incident. It became what we call Freehold tenure.

UNFREE TENURE

Free tenants enjoyed, as we have seen, a fair amount of autonomy, paying eventually a small rent with only a few obligations to their lord. Unlike them, the "unfree" tenants (often called a villein or bondsman) were more restricted. Originally they, in effect, were the agricultural labourforce of the manor. They were granted land holdings in return for services, often including rent but also manual labour too. Unlike their free tenant neighbours, they were required to carry out the work, at a given time and at a given place. The free tenants could undertake their services when they wanted to do, the unfree tenants could not; they had no choice as to when to do the work. Some of their duties (services) included providing butter and other foodstuffs to the lord. They had to repair the manorial mill etc.

They were not free to leave the manor without the lord's consent. These tenants were of the villein class a status higher than slaves but lesser than free tenants. The villeins were treated as property of the lord and would be sold whenever as manor was sold. By the end of the 14th Century the old servile villein class was in decline and it has been said that there were none by 1600. It became usual for a lord to grant a new type of tenure, similar to the villein tenure referred to above. In place of services of an agricultural nature a fixed rent would be charged. The tenant was now earning wages and could afford to pay rent.

Unlike the free tenant, who had "seizin" of his land (see above), an unfree tenant did not have seizin in the land granted to him, since this was retained by the lord. The unfree tenant held his land by the will of the lord, according to the custom of the manor where the land was situated. Each manor had its

own customary laws and, whilst there were common rules, there were variations from manor to manor.

They, too, were subject to manorial incidents, similar to those referred to above in connection with free tenants. The unfree tenant had to swear homage and fealty to his lord. A heriot would have to be paid and if an unmarried daughter wanted to marry a merchet had to be paid to the lord.

The unfree tenants only held their land with the consent of the lord and any transfer had to be with the lord's approval. The procedures were carried out before the Court Baron.

MANORIAL COURTS

In the previous article I referred to the obligation contained in the title deeds of Ashton Old Hall Farm that its owner must give "suit and service" to "every Court Baron of ...Viscount Allen ...to be holden and kept for the Manor of Ashton-upon -Mersey upon summons and warning used and accustomed in such cases within the Manor".

This was the lord's Court Baron, a manorial court comprising the other tenants of the lord. It dealt with the escheat (see above) of tenures, transfers back to the lord by way of surrender or minor disputes between the tenants. Confusingly another local court, called the Court Leet was often held at the same time and comprised, in certain cases, the same individuals.

The original Court Leet was devolved from the Crown and it became involved with the free tenants, as well as carrying out certain administrative functions such as the election of constables. The Tudor reform of local government, with its empowering of the Justices of the Peace and the Quarter Sessions, meant that the powers of the Court Leet were very restricted by the 17th century.

With the passage of time the functions of the two courts became confused and the name of the courts became interchangeable. The Court Baron, however, was the manorial Court which continued to deal at local level with the manor and its unfree tenants. In practice the obligation to attend such courts mostly fell into disuse by the 19th Century. We are fortunate that court records have survived. These usually comprise the court "Call Book", which lists the "jurors" who attended the sessions of the court and "Verdict Books" which give a brief description of the cases heard before the jurors with their verdict.

The Historical Manuscript Commission (HMC) of Quality Court, Quality Court,

Chancery Lane, London WC2A 1HP will answer limited, simple, queries about the survival of the Manorial records for a manor or a parish in a manor. It does not hold any records itself. They have a useful Website for those with computer access. The address is www.hmc.gov.uk. For further information also see the Public Record Office Reader's Guide No.6 ("Using Manorial Records" by Mary Ellis). Queries should be made in writing, by post, fax or email about the whereabouts of Manorial records. It can be rewarding to consult them. Many records are lodged with local or County record offices, but in some cases they are still in private hands, held by solicitors or the family, who are or were lords of the manor.

The Manorial Document Register is maintained by them but is not fully not fully computerised. By extreme good fortune though, Yorkshire (together with Hampshire and the Isle of Wight) have been indexed and are available for searches over the Internet.

When preparing this article I searched against Nappa but unfortunately no surviving manorial documents are recorded. A search against Horton-in-Ribblesdale, which is where my Metcalfes originated, was more successful revealing 4 entries: A court roll for 1517-18, two in 1551-61 and a court roll for 1766. Anyone with ancestors in the Manor of Wakefield, which covered a huge area of the West Riding of Yorkshire, is extremely fortunate since their Rolls and records survive going back to the 1300s. The Yorkshire Archaeological Society is publishing these and already a large number have been published.

As a digression the HMC, also maintain the National Register of Archives, which can be accessed via the Web, post or a personal visit. This contains over 40,000, often unpublished, catalogues. The Register permits simple and detailed searches against personal names, family names and place names. It is not terribly productive so far as the Metcalfes are concerned.

A search against the surname METCALFE reveals only the family of our name of Inglethorpe Hall Emneth Norfolk. Their 19th century family and estate papers await you at Cambridgeshire County Record Office [ref:Acc R84/62][NRA 36648 Metcalfe]. Any of you interested?

CONVEYANCING

In the next article I will explain how the ability to transfer the free and unfree tenures developed until the 20th Century and where some of the documents are to be found.

What you will notice is that all prices are given in US dollars (\$) rather £ sterling - each \$ price roughly equivalent to our published £ price. All members can use this online service on a world-wide basis, paying in US dollars. UK members will probably find that it is still slightly cheaper (by just a few pennies) to continue paying by personal £ sterling cheque and sending it by post. But for convenience, do feel free to order/pay online.

The service is totally secure, reliable and convenient. We tested the service with the advance orders of the 'Metcalfe-History of the Clan' book with total success. We even signed up a few new members at the same time! We only experienced a few problems - all of WHICH were of the human 'user error' variety!

So do try it if you wish especially when it is time to renew your subscriptions - the society (treasurer and agents especially) will certainly reap the benefit at that time, and you also receive automatic confirmation that your subscription has been paid.

Durham County Library Publications

The 1851 census has been used as it was the first census to name a person's place of origin. It has been frustrating trying to work out the number of people, houses, place of origin, etc., of the occupants of tile yards because if a yard was not adopted (ie. did not come under the Board of Health's control for repairs) its name was never mentioned and the list of households dwelling in the yards, was detailed as if they all lived on the main street. Tubwell Row is a good case in point, as not one yard is mentioned by name, for it must be borne in mind that all these yards were cul-de-sacs, not one was a right-of-way.

There seemed to have been about three hundred and fifty households in the yards out of a total of two thousand six hundred and eighty eight in Darlington but this included Blackwellgate making about seven and a half per cent of the total. Out of a total of one hundred and thirty nine empty houses in the town, twenty nine (nearly twenty per cent) were in the yards. It would appear therefore that as there were more families than houses and people packed into the yards for economic reasons, these twenty nine empty houses must have been ones beyond repair.

Nearly half of the heads of households (one hundred and forty eight out of three hundred and twenty) were Darlington born, but one hundred and twenty heads of households came from the surrounding countryside of County Durham and Yorkshire. Six heads of households came from Scotland, whilst Ireland supplied thirty eight, who congregated in the yards off Clay How like Princess Square and Feetham's Yard off Priestgate. The remaining eight heads of households came from London, Carlisle or elsewhere in Britain.

There were twenty paupers receiving Parish Relief but only four persons had Darlington as their place of origin so the other sixteen must have qualified for Parish Relief through marriage, apprenticeship or have lived here for a great number of years. The Irish did not qualify for Relief, so about twelve families were described as "beggars", like poor John McGallon of Palace Yard, his wife Elizabeth, their sons Patrick and Sandy who were all described as "beggars no relief", for their place of origin was Ireland.

Darlington's yards were not only inhabited by poor folk, for John Bell aged sixty six years, who lived in Johnson's Yard (later it was better known as

Russell's Yard) was described as a "Proprietor of Houses." He originated from Stockton and as there were two in the household, the other person must have been a servant. Altogether there were three "Proprietors of Houses" living in the yards and three "Annuitants."

Michael Pigg, the innkeeper of the Black Bull Inn in the Market place, had an unusual visitor staying with him on the day of the census - a John Welsh bachelor from the U.S.A., noted as a "Proprietor of Land and a magistrate." John Welsh was born at Fishburn, Co. Durham, so here was a local man who had made good.

A fifty six year old widow, Mrs. Susan Steward of Johnson's Yard, was noted as a "Labourer in the fields," this shows the close relationship then between town and country. She hailed from Scotland and there were four others in her household to care for.

George W. Simpson aged twenty six, is noted as a newspaper editor, who lived in Garbutt's Square and Henry Spencer aged thirty nine, described as a sub-editor, lived in the purpose built and higher class area, Potter's Yard. In Peaceful Valley, John Beswick aged fifty years, who originated from Blackly in Lancashire, was the "Bleacher of Flax". John Butterfield was a cowkeeper in Stubb's Yard, the yard south of Russell Yard on High Row and James Hunter was the cowkeeper in Clark's Yard who originated from Chigwell, Essex. The positioning of this trade in a densely populated area just off High Row must have been very convenient for their customers but objectionable to nearby households.

John Smith aged fifty three was a dyer of woollens and lived in Catterick's Yard. Woolcombing, a former elite craft was now very much on the decline, the census only mentioned twenty two wool combers and they relied on their wives to go out to work. The hand-loom weavers were still around, but steam-loom weavers were coming to the fore, showing the transition in technology from hand-working to mechanisation.

Short Summary of the People living in The Yards in 1899.

There were two hundred and forty families living in forty seven yards and of these forty six were Irish. Seven houses were vacant (unfit for habitation?) and there were seventy widows and spinsters living in the yards - mostly living on their own in probably the cheapest and smallest accommodation that could be afforded.

The occupations of the men are ranked as follows allowing for the fact

that fourteen were unemployed.

This shows that the occupants were mostly unskilled and that their wages would barely keep them above the bread-iine even if they were lucky enough to have regular employment.

Seebohm Rowntree, the son of Joseph Rowntree, the Quaker cocoa manufacturer, made a survey of conditions in York in 1899 "Poverty: A Study of town life." He stated that a family with three children needed 21s. 8d. a week to provide food, fuel, clothing and rent to keep them out of "primary poverty" and about twenty five per cent of York's population fell into this group. The average wage in Darlington at this time for a man was from £1 to £1, 2s. 6d.

Statistics.

- 1767 Only one Yard mentioned in local census.
- 1801 Population 4.670, with 900 houses, there were over 200 Yards.
- 1841 Population 11,877 with 2,100 houses and with 18 lodging houses mostly in the Yards.
- 1846 200 people died of typhus in the Yards of Blackwellgate and Houndgate.
- 1851 Population 12,439 and there were 108 Yards but only 42 were drained and they contained 151 privies or one for every 17 persons. There were also 350 pig sties in these yards. There were 7 public pumps at Blackwellgate, Bondgate, Northgate, Priestgate, Skinnergate and 2 in Tubwell Row.
- 1861 Population 16,762.
- 1863 300 houses built at Albert Hill by Henry Pease (Quaker), son of Edward Pease, on the Nestfield Estate which belonged to the Allan family. This was the first purpose built housing estate for workers in this town.
- 1865 15,000 people lived in the Yards, Bondgate with the greatest density,

having 15 Yards.

- 1871 Population 30,298, people drifting into the town due to the agricultural depression.
- 1899 All Yards still lived in had to be paved with Commondale or Scoria bricks, in order to make them easier to sweep, wash and disinfect.
- 1901 Population 45,958.
- 1902 40 Yards contained a population of 661 who lived in the 171 houses.
- 1915 59 Yards were lived in due to the housing shortage of World War I. The average rent was 4s.6d. per 2 rooms.
- 1926 64 Yards were lived in, the increase was due to the depression.
- 1936 48 Yards were lived in.
- 1966 All yards free of habitation.

Average age at death of Quakers. 54 years

1842-3. The death rate of children;- Quakers Others Under 1 year of age 27% 73% 10 to 15 years 22% 78%

The one that got away!an original 'Metcalfe Records'

For those of you who have the first edition of 'Metcalfe-History of the Clan' you will read in the preface that the book is based on two primary sources about the Metcalfes - one being Walter & Gilbert Metcalfe's 'Metcalfe Records'. This is an exceedingly rare publication about the Nappa branch of which 50 copies were printed and distributed privately in 1891. The society is aware of the existence of fourteen copies and indeed J.P. Warwick Metcalfe (M256), the lead editor of 'Metcalfe-History of the Clan', is a fortunate inheritor of such a copy.

Hence, you could understand that if ever another copy came to light, there are certainly a few members of the society who would probably go a long way to own one of these limited editions your President probably being at the front of the queue closely followed by yours truly - your Secretary!

So there I was, reading the newspaper in my conservatory after a hard day at work when I received a phone call out of the blue from a lady non-member offering the society one of these rare books that she had inherited alongside many others in a bookcase from her father. She was not aware of any personal connection with the Metcalfe family, but as her interest in family history had made her aware of the society, she thought we may be interested in purchasing the book for 'a fair price'.




