METCALFES IN THE BOER WAR

On the night of 10/11 December 1900 the British Infantry made a costly raid on Surprise Hill. Col. Metcalfe led a force from the Rifle Brigade and Lt. Digby-Jones accompanied them with a party of Royal Engineers. Once again the Boer sentries were taken by surprise and fled after a short fight, but at this point the British plans went awry. Digby-Jones had difficulty with the explosives and by the time the gun was destroyed the Boers had rallied. A gallant party from the Pretoria Commando blocked the British line of withdrawal. The Rifle Brigade had to fight its way through to Ladysmith under heavy fire and lost fifteen men killed and fifty wounded.

[Surprise Hill is just outside Ladysmith and was the site of a Long Tom gun; one of three large guns used by the Boers used to bombard Ladysmith daily (except Sundays).1

VEGETARIANISM THE MECCA CONNECTION

Many consider the opposition to meat eating to be a 20th century phenomenon brought about by our improved understanding and education leading to an enlightened consideration of animal welfare. Much of the modern development in vegetarianism has occurred over the last fifty years which has given strength to this belief. Modern magazines such as The Vegetarian have roots in the 1950's when interest started to grow after the austere post WWII years until now there are a number of publications covering the subject

The interest in non-meat diets has grown steadily over the last twenty years with a pan-European organisation as well as one in the UK and other in the US in particular. This has led to more radical approaches such as demonstrated by Vegans who look to take vegetarianism one step further by excluding all animal products from their diets.

So vegetarianism is a modern concept? Not so. Like many other ideas this is an approach which has seen a number of re-incarnations over at least the last three millennia. The early Greeks and Romans had views on the consumption of animals - as they had on many other subjects. Stoics such as Seneca wrote "I resolved to abstain from flesh meat and at the end of a year the habit of abstinence was



not only easy but delightful." Pythagoras - he of the Theorem fame, which taxed many of us when younger - also was interested in the theory. The flirtation with vegetarianism continued down the centuries with Romans, early Christians and medieval proponents looking to convince their fellows to take up the approach but usually with limited success.

Despite the involvement of well known individuals many considered the exclusion of meat from the diet as unnatural and against a balanced approach to eating. Different viewpoints have been discussed in various modern publications including The Vegetarian (September 1988) making the arguments for and against the life style pointing out the approach of our hunter gatherer ancestors. As with most early claims there are few hard verifiable facts and both sides look to use the scant information to their own advantage. As usual it is down to the individual to make up their own minds.



This article is not about the pros and cons of vegetarianism but about Metcalfe involvement. As with many modern developments the Clan seems to have a knack for being at the forefront of these ideas. Again there is an early connection with modern vegetarianism where we find one of the family members from the Fells around Shap, now in modern Cumbria, taking a major role.

In the early 19th century not far from the small Westmorland village of Orton lived Jonathan and Elizabeth Metcalle with their son William. The latter was born on 11 March 1788 and was apparently educated in the area around Kendal. Little is known of his early life but the schooling allowed him to write poetry which he used to pen a farewell note to friends and family when about eighteen he moved to Airedale in West Yorkshire to take up employment. The move to work as a clerk in Keighley was to have a profound effect on his future role in vegetarianism.

Shortly after arriving in Keighley William attended the local Swedenborgian Church (Swedenborgians are adherents to the teachings of Emanuel Swedenborg (1688-1772) who extolled phases (or new churches) of human relations with God. Hence New Jerusalem.) which was run by the Reverend Joseph Wright. Young William must have impressed the minister as he was taken under his wing and persuaded to study theology. Part of his religious training involved him attending an Academy of Art and Science in Salford (the twin city with Manchester on the River Irwell) where he rose to become head student of the classical department. After two years he was ordained on 11 August 1811 by Doctor Cowherd principal of the Academy.

Not only did William impress the Rev Wright he must of also impressed the ministers daughter for whilst he was studying to be ordained he married Susanna Wright on 14 January 1810. She and Doctor (also Reverend) Cowherd, the principal at Salford, were to have a life long influence on William. Susanna seems to have been interested and practised vegetarianism for some time before her marriage. Whether this was through her own volition or that of the Church or Dr Cowherd's influence it is not known. What is known is that William became a strong proponent of the approach with Susanna educating both her husband and friends on a meat free diet. An excellent cook her skills overcame any apparent deficiency in meals put before the household.

Whatever the influence that drove William to take this stance it was affected by his religious training. Dr Cowherd was somewhat of a Radical at the time of Thomas Paine (The Rights of Man) and other liberal thinkers. Originally part of the established Anglian Church his disagreements drove him to join the Swedenborgian New Jerusalem Church in Manchester. However his radical ideas soon led to further disputes and he broke away in 1800 to

form his own church in nearby Salford. Eventually he set up the Bible Christian Church in 1809. This church was strong on Bible teaching and had as its main pillars abolition of slavery, teetotalism, pacifism and vegetarianism. It was to this church's academy in 1809 William Metcalfe came.

Once ordained William returned to Airedale and took up preaching at the small Bible Christian Church at Addingham near Ilkley not far from Keighley. During his schooling he had preached to the small congregation and they were pleased to have him back. He was seemingly successful as the church built a school to complement his teaching. However this move caused a disagreement with Dr Cowherd who apparently had other ideas for his ex-student.

The early 1800's were a time of social upheaval brought about in part by the American War of Independence, the Napoleonic Wars and the continuation of the Industrial Revolution. Radical thoughts and ideas were not necessarily well favoured in a period of upheaval. No doubt Dr Cowherd's radical views won him few friends in the Establishment and would probably have brought some adverse reaction down on those liberal free thinkers. Whilst the continuing Napoleonic Wars and the War of 1812 with the United States did not allow an escape from their immediate environment it appears that Dr Cowherd was looking to move his flock to a more liberal regime in America. William evidently was won over by the approach as his dispute with the doctor was eventually resolved and he became one of the two ordained ministers of the Bible Christian Church under Cowherd, the other was the Rev James Clarke.



By the end of the Napoleonic Wars, in 1815, the small church in Salford had well developed plans to emigrate. However before they could be put into action Dr Cowherd died on 29 March 1816. This seems to have been traumatic for the emigrants and it was not until 29 March 1817 (a year to the day after Dr Cowherd's death) that Clarke and Metcalfe took the small group to Liverpool to embark. The party was some 41 strong (including the two ministers) and was composed of 20 adults and 19 children. The journey to Philadelphia,

their ultimate goal, was somewhat tedious taking nearly three months to complete. Even then their troubles were not over as 9 adults and 12 children left the group shortly after arrival and Metcalfe and Clarke seemingly had differing ideas on how the Bible Christians should proceed.

None the less after this difficult start the church slowly grew extolling its Christian virtues allied to its adherence to vegetarianism. The Reverend Clarke died in 1826 and the full mantle of leadership of the Bible Christian Church fell





upon William Metcalfe. He continued to preach the values of vegetarianism, writing books and pamphlets in support of his cause. The church also showed in a practical way the benefits by giving vegetarian dinners. William's ideas found resonance with other liberally minded people in the States and by the 1840's a vegetarian movement with William as one of the leading lights was gathering momentum. These included William Alcott (the uncle of Louisa M Alcott) and Sylvester Graham who considered vegetarianism as a duty.

However it was a group of like minded individuals in England in September 1847 who inaugurated the first modern Vegetarian Society with its own publication. This was the spur to the American group who founded their own society with William as Secretary. They issued their first magazine in November 1850. The annual meeting of the UK Vegetarian Society, a World Peace Conference and the opening of the Crystal Palace Exhibition in 1851 saw the 63 year old Bible Christian minister make the first trip back to his home country for thirty four years. In July 1851 William arrived back in England and whilst the conferences and exhibition would have been enjoyable his welcome at Salford before a packed congregation including the local MP would, no doubt, have given him the greatest satisfaction. He returned to Philadelphia in September 1851

The Metcalfes continued to give their vegetarian message but on 3 November 1853, Susanna, William's wife of nearly forty four years died. William lived on another nine years before expiring on 16 October 1862 aged 74. The leadership of the church was then assumed by William's son Joseph who had been ordained in 1859. Joseph who was born on 16 October 1810 (possibly had two sisters Mary and Elizabeth) died in 1867.

The Bible Christian Church never making a huge impact closed in the 1920's just over a hundred years after its beginning. The vegetarian banner was however picked up by other organisations, both Christian and secular which have taken the idea and its implementation through to the present day. So whilst vegetarianism appears a new phenomenon its modern roots stretch back some two centuries to two of its primary advocates

William and Susanna Metcalfe.

My thanks to Barbara Smith of the Cumbria FHS (via Nina Benson M29) who alerted the Society to an article on vegetarianism in the in-flight magazine "Going Places" (April 1998) of Singapore Airlines which briefly mentioned William Metcalfe. This provided the spur for this piece.



Mecca Influence or today the News, tomorrow...?



Gayle Mill, Wensleydale

After the Mecca News article on Gayle Mill in the April 2004 issue, the Mill has gone national. It is now to be one of the buildings in the BBC TV's new "Restoration" Programme due to be screened around the time of this issue. The Mill, which was operated by the Metcalfes at one stage has been short-listed as one of the competitors for Lottery and other funding. Will it be successful?

The Metcalfe Family were joiners in Hawes for some two centuries and Thomas and Albert George Metcalfe oper-


ated the Mill in 1921 (from Under Wether Fell (p119) by James Alderson). More detailed information concerning the family's involvement with the Mill is being gathered and when available will be reported in the News.

Whilst preparing this issue I received a copy of the Aldersons FHS magazine for June 2004 and they have an item on the Mill and the Restoration programme - Ed.

Now whilst it might be more than a touch contentious and arrogant to

claim that it was because of our article the Mill is in the TV programme - but it did gain recognition after our mention! - what will be the effect of our consideration of another restoration programme being undertaken in Wensleydale - the old railway?

The line originally set up by various Acts of Parliament between 1848 and 1870 was part of the Bedale and Leyburn Railway which stretched from Northallerton (on the east coast London to Edinburgh line) to Garsdale Head (on the Settle Carlisle Railway) a distance of some forty miles.






Eventually it was absorbed into the LNER Railway Company which ran passenger and goods services for many years before closing to passenger traffic in 1954. The tracks were torn up between Garsdale Head and Redmire but some 22 miles of track remained open to Norhallerton for the limestone quarry business at Redmire but even this eventually closed in 1992. The line was re-opened in 1996 to allow military traffic from Catterick Camp.

As a result of local efforts the line was restarted in 2003 between Leeming Barr (near the A1) and Leyburn in Wensleydale; with plans to open the remaining 18 miles over the next few years.

There must be some Metcalfe connection with the line, so if any of your ancestors worked on the Wensleydale railway let the Editor know.

"Not of my making"

I am unable to say where or when Charles James Metcalfe was born, married (if indeed he ever did) or died. I assume he was born in the British Isles and was about 25 years old in 1844, the date of the first entry in the records of the East India Company. That first entry was in the Bombay Marine Department dated 9th February 1844 and recorded his promotion from Senior Acting Clerk to Captains Clerk. On September 1847 Charles James was promoted to Purser and it is after he took over his new post that events take an interesting turn.

The Military Pay Master wrote to his Company masters in a letter dated 29th February 1848 reporting that "a security bond for the sum of 1721 Rupees had been made ready "Last Week" as Charles James Metcalfe "Most Faithfully Promised to submit a receipt for 1243 Rupees from Mr Connolly, who had taken charge of the accounts as clerk in charge of the Victoria; along with a Government Treasury Note for 438 Rupees. Instead Charles James Metcalfe had left for China on the Semiraris the day before."

When the Semiraris called at Madras the missing Purser was arrested and removed to prison. By the 6th of September 1848 he was back in Bombay giving his explanation as to why he was unable to produce the required receipt. His efforts were described as "*Most unsatisfactory and evasive*." Essentially his position was "*Not of my making*."

What caused this situation? It appears that Charles James served under a Lieutenant Christopher who had died so "It was out of my power to render a statement.". He further claimed it was the Lieutenant's responsibility to provide the statement and with his death any explanation was gone. He questioned why he was therefore being held responsible. As can be imagined he was investigated thoroughly and soon other irregularities came to light. It was discovered that he had not submitted 2 referees on being promoted to Purser, nor had he deposited the required surety bonds to the value of 4000 Rupees. The amount under question also increased to 3000 Rupees. Not surprisingly all his pay and allowances were stopped.

On the 23rd October 1848 he asked for 3 years furlough due to ill health and furnished one surety writing "Regret to state I find great difficulty in obtaining a second surety.". His request was rejected. However he continued to press his case and in March 1849 he again asked for furlough which was again rejected. In June 1849 he applied to be make bankrupt under the insolvency act. In the list of debtors he did not mention the money he owed to the East India Company! At the same time he managed to persuade a doctor to declare if he did not return to the UK he would not survive long in India. He was

allowed a one-year furlough, without pay and allowances.

Charles James Metcalfe was to have collected his official travel documents on the day of his departure from the Military Pay Master. However he did not turn up as he must have heard that his furlough had been cancelled on the representation of the Commander in Chief of the East India Company Indian Navy, who wanted him to be Court Marshalled. Instead he left on the ship Futtul Wahat. But again his plans did not go smoothly being "Compelled in consequence of bad weather" to call in at Cochin where he was detained and the commander and chief officer of the ship dismissed. He somehow managed to make alternative arrangements on the Royal Shepherdess and by February 1850 he was in England asking the Court of Directors for his furlough pay to be issued to him. Which it was, despite the charges against him.

Throughout 1850 he continued to claim ill health whilst collecting his pay. However in early 1851 he was pronounced fit to return to India. An effort to return to India was made, all be it only half hearted. An entry dated 16 April 1851 reports that he had reached Suez where he was detained due to ill health. Never the less whilst there he made arrangements for the company's ships to be supplied with fresh provisions at greatly reduced prices, and requested his return to London to discuss the situation with the court of directors. He also managed to claim £20 pay from the agent in Suez.

Applying on the 7th May 1851 for permission to retire from the employment of the East India Company. His request was refused on the 28th May 1851; remarkably quickly for the East India Company perhaps indicating their exasperation with the situation. On the 23rd June 1851 the Company issued an instruction that no more pay or allowances were to be paid to him and the Commander in Chief on the Indian navy wrote three weeks later that "Charles James Metcalfe being a defaulter from his duties will never return to India"


During all this time Charles James continued to write to the Court of Directors about his special deal on the provisions. He also continued to petition the directors to pay his return passage to India. It was pointed out to him he had been under orders since December 1850 to return to India! In October 1852 the Court of Directors were still receiving letters from him about the provisions payments. He again applied on 31 December 1852 for an advance to return to Bombay but Instead he was advised that his name was to be removed from the list of the Indian navy, effectively he was sacked. In reply he expressed deep regret at his name being removed, however "could he have some "pecuniary assistance" due to his "destitute situation"! I suspect out of utter desperation the Court of Directors paid a "sum not exceeding £80 to aid his emigration to Australia".

There the trail goes cold. Whatever happened to Charles James Metcalfe?



Mine's a Mr Softee!

Those of you who had your youth in the '60's in England would remember Mr Whippy and Mr Softee, those rather gooey ice cream's dispensed from musical ice cream vans that travelled the highways and byways of our towns and villages. They were nothing like the traditional ice cream (which for a start wasn't mushy and tasted like real ice cream was expected to taste against the soft and generally insipid taste of the soft ice cream - or at least that's how I remember it!) but their ready availability rather having to go to the Italian Ice Cream parlour in the town meant over time they had a hold on a large part of the ice cream market. However



like most fads they fell away and whilst the soft ice cream is still around I can't say I have seen a Mr Whippy or Mr Softee van for a long time; they were apparently victims of competition in the early 1980's.

However one recent weekend whilst reading through the Daily Express (29May 2004) I came across an article about these erstwhile roving ice cream dispensers but the central aspects of the article were about a father and son who had cornered the market in old Mr Softee vans. There are reportedly only five vans left and this family team have two of them.

The vans, run down and unroadworthy have been done up by this intrepid pair and are now back on the road. The most recent van was purchased for £6000 off the internet but cost a further £17,000 and many months of loving work before it was back to pristine condition.

The pair have been so smitten with the Mr Softee bug that they have even had ice cream uniforms specially made for them. Initially it was the son who was captivated, having ridden on the vans with his father, who was an original Mr Softee seller, but both are now hooked into the renovation project. They have already produced 99 ice creams from the original machinery and may do more in the future. However before they can do that they are embroiled in repairing another Mr Softee van recently purchased in Doncaster for £1700 and expect to spend a further £25000 to make it full operational.

The father and son from Tamworth Staffordshire are Keith and Fred Metcalfe.



FAMILY HISTORY SOURCES LIBRARIES

Most of us will have gone through the early stages of family history research having obtained the obligatory birth, marriage and death certificates and onto the census returns to take us back to the mid-1800's. Later the parish records will hopefully find more branches of our particular family tree. How-



ever, unless you are one of the lucky ones your progress will slow leading you to look at other ways to find that elusive ancestor. You may wish to put more "meat on the bones" of the bare information available from the census and registration documents. One way is through the library.

How many of us look to the library as a useful search aid? Record Offices and regional registries are the usual focus for archived material but often there are collections in libraries not readily available elsewhere. Many of the modern family history research books acknowledge the usefulness of these places. At one time the library for family historians was a hit and miss affair with few indexes available to let you know what collections they held never mind providing access to their archives. Matters have improved markedly especially over the last decade with libraries of all kinds recognising who their customers are, realising they had a large number of people wanted to access them and in some instances that they could charge us for the privilege!

Not only is information available through the shelves but increasingly through electronic access in the library and also on-line. Today you can access the internet through the local library. Your library is now a better organised and more focused operation aware of the needs of family historians, looking to provide a quick and reliable service. It is up to us as users to make use of the newly available archived material.



The largest of our libraries is the British Library. A new home was opened in Euston Road London in 1998 to house the main collection of printed books, maps and manuscripts. The library has all the modern equipment and aids to help your research and is fronted by a sophisticated website (www.bl.uk) which leads you through the various collections and helps to identify areas of interest. The Library's possibly most useful aspect for family historians is its complete collection of

52,000 UK newspapers since 1801 and a variety of earlier popular newsheets.




This collection is housed separately in Colindale North West London.

Newspapers are a rich source of family and local facts but you don't have to go to the British Library as there are many useful libraries closer to home (or the internet). Many libraries have local studies sections and these are often an under estimated source of family history information.

Yorkshire has a well developed library service. North Yorkshire County Council has a local studies facility (www.northyorks.gov.uk/libraries/local studies) which holds census returns, electoral rolls, poll books, trade directories, local newspapers, maps and photographs at its Northallerton site. In addition it has another twelve branches across the County which have a variety of services some with local study or lending and information facilities. See the web site for further information. The East Riding of Yorkshire Archive Service at Beverley has over two miles of archived documents dating from the 12th century. See www.east riding.gov.uk/libraries/. Not to be out done the West Riding of Yorkshire Archive Service based at Wakefield has documents for the West Riding Quarter Sessions, Nonconformist and Wakefield Diocese records, family and estate papers and maps. Web site www.archives.wyjs.org.uk.

A consortium of seventeen university libraries including York, Durham, Bradford, Leeds, Durham and York St John College operate under a RIDING banner which gives web access to a multiplicity of library collections. For more information see http://riding.hostedbyfdi.net/riding/services.htm.



There are many other non-public libraries holding collections of interest to family historians. Among them are The Yorkshire Archaeological Society at Claremont Leeds (www.archives.wyjs.org.uk/yas.htm) which has a substantial archive of estate and family papers, manorial records and Wakefield manor court rolls. Yorkshire Ancestors (www.yorkshireancestore. com/librarycontents.htm), the Society of Genealogists and the family centres of the Church of Jesus Christ of Latter Day Saints amongst others also have substantial holdings.

As indicated earlier you can use the internet to see what collections each library holds and you can check with them availability of the books and records before you venture out. So why not give the Library Service a go you may be surprised at what lurks in their archives which if not adding directly to your ancestor's details may provide information on their environment, workplace, neighbours and conditions in which they lived. All useful to help in gaining a greater understanding of that all elusive ancestor.



FFHS Reportback

The Federation of Family History Societies [FFHS], of which our Society is a member, held its Annual General Meeting and later a general meeting of its members in Coventry in April. I represented our Society as our delegate. Lady Teviot, President of the FFHS, presided at the AGM.





prehensive report on the financial situation. He produced a 5 year summary of the finances and a forward projection of how the FFHS will fare in the next two complete financial years. All is not doom and despondency at all.

The members approved a new set of Articles of Association for the FFHS.

Outgoing Archives Liaison director Richard Ratcliffe reported that the Government consultation paper published last year, on the future of the Registration Service resulted in a large number of replies, no less than 3,440 were received, compared to the 982 in 1999 when the consultation was first started. A sign of the raised awareness and concern by individuals at the proposals? The changes will be implemented in 2006, following the publication of Part 1 of the Regulatory Order in July this year, dealing with Births and Deaths registration. The issuing of written certificates will cease in 2006. The proposed changes to Marriage registration, contained in Part 2, should follow in December 2004, although it is dependent upon the passing into law of the Civil Partnership Bill, which was published in March 2004. At present no funds seem to have been allocated to set up the National Database that these changes will require.

In the last 12 months Richard represented all of us, by virtue of his role with the FFHS, on 8 different national committees and attended 40 meetings. We all owe a huge debt to the invaluable work he has carried out for Family Historians everywhere whilst serving on the national committees as the FFHS representative and I would like to pay tribute to him for this. His successor is Maureen Bullows, who worked in a similar role with Richard some years ago, is a worthy successor.

At the general meeting Alec Coutts gave an excellent explanation of the progress of the FFHS Pay for View Site. 60 Family History Societies have joined, and 12 more have indicated a desire to join. The site has 47 million records following the inclusion in April of the 1881 Census Index, which accounts for 26 million alone. The FFHS will launch the second enlarged edition of the National burial index at its 30th anniversary Conference in August.

The 2003/4 Best Website for Family History Societies will be judged later this year and the winners announced, like the Elizabeth Simpson Award for the Best Magazine, at the Loughborough Conference in August.

A discussion on the future of collecting Strays and how to make the information collected in the last few years available was lively but a final decision was deferred to allow more consultation

An interesting and busy afternoon. The morning had proved to be informative too as two talks were given by representatives from the Parliamentary archives and the House of Lords Record Office.

BELDY HILL You've read the article (in April's Mecca News) now visit the scene of the Beldy Hill dispute!

The remains of the quarrying of the 1700's are still in evidence behind the ruins of Crackpot Hall in Upper Swaledale, North Yorkshire and can be easily accessed. Imagine the fracas and see what was being fought over in the upper reaches of the lovely River Swale over two centuries ago.

To make the trip you need to travel to Muker (about 12 miles from Reeth the market town of Swaledale). Park either in the pay and display car park as you enter the village from the Gunnerside direction (east) or go through the village and stop on the left just beyond Swaledale Woollens (which is on the right). Go into the village centre past the parish church with many Metcalfe graves and connections towards the Post Office on the northern edge of Muker. There you see the signs for Gunnerside and Keld which take you through the seven meadows, a delightful riot of colour in June/July, to the River Swale.



By far and away the best route (well I think it is!) is along the west (left hand) side of the Swale which takes you almost to Keld before bringing you back to Beldy Hill. A little farther than the east side walk, by about ^{3/4} of a mile, this route takes you along the river, through, a small wood across fields with Crackpot Hall and Swinner Gill always beckoning. After around 1^{1/2} miles the path starts to rise and climbs steadily but not steeply by the side of Kisdon Hill. After half a mile it levels out till you approach Keld. Just before the village as you reach the rise and before the Coast to Coast route joins the path there is a gap in the wall which takes you down a fairly steep path to Kisdon Waterfalls.



Worth a visit if you can manage the path.

You can walk into Keld and visit the small church which again has Metcalfe graves in the small graveyard. It wasn't always so. In a tithe collection of 1573 all but one of the families were Aldersons! If you don't wish to go to Keld you turn off right down to the river following the Coast to Coast route which brings you to East Gill Force. Linger awhile - the Force has a mesmerising effect - then turn right (don't follow the Coast to Coasters otherwise you will end up in Whitby!) through the gate and within half a mile you are at Beldy Hill.

The Hill is on the left of the path and is not imposing from this viewpoint. Just after a swing to the left and before the path starts to go right adjacent to a barn in a field on the right. There is a green path off to the left which runs uphill between the scarp at the back and Beldy Hill. Some 200 yards or so up a rising walk there is a wall which you follow for another 100 yards and there on your right you will see the old lead mine workings. Here there are signs of heavy activity which continued for many years signifying how rich the veins were and hence the reasons for the dispute.



Stay awhile. The whole walk should not be done in a hurry. A little further up this path there are views towards Stonesdale and Birk Dale. Once you have seen the scene of the Metcalfe fracas walk back to the path, past the remains of an old tractor, then take the green path inclining left, up to Crackpot Hall. Once a magnificent building with stunning views it is now a mere shadow of its former self having being ruined by mining subsidence - the lead that made it, destroyed it.

Once you have taken in the views walk back down to the path and follow it to Swinner Gill. Another viewpoint is in prospect looking towards Muker, your final destination. For those of you adventurous (or fit enough) a look up the Gill is well worthwhile but is not part of this walk. Now it is slightly down hill and on the uninteresting (in variety







terms) path back to the bridge opposite Muker's meadows which take you back to your starting point in the village. On the way call at the Post Office for a Brymor ice cream - a fitting way to end the walk!

Around 5 to 6 miles in total (probably four if you go directly to Crackpot Hall from the meadows along the east bank of the Swale and return the same way). In time terms - if you stop and look at the views and gently amble - a good three to four hours!

On a fine dry and preferably sunny day there is little to touch this walk. As you follow


the path imagine how it must have been over 200 years ago when Metcalfes were involved in the Beldy Hill Dispute. Enjoy.



After hearing about healthy eating, and taking part in the Beldy Hill walk why not relax with an original Yorkshire dish. We make no claims on the taste but from an original recipe here are the ingredients

·8 oz mashed potatoes

·8 oz grated carrots

8 oz sugar

·8 oz flour

· 8 oz currants

-8oz raisins

·8 oz suet

·1 oz candied peel

·half a nutmeg

pinch of salt

·2 eggs

Clean currants and raisins, chop suet finely, cut candied peel fine, beat eggs well. Mix all ingredients together, add in the salt, pour the mixture into a greased pudding basin, tie closely down and steam for 4 hours (or take a third of the time with your pressure cooker).

I picked up the following newspaper article when I was in the UK in 1984 and thought it might be of interest as a snippet in the magazine (I don't know what newspaper it came from, nor the publication date, but I assume it was somewhere in the Burslem/Stoke-on-Trent area).

PRIVATE W. TITTENSOR, BURSLEM

Mr & Mrs MEDCALF, of 114 Newport-Lane, Burslem, have received news that their adopted son Pte W Tittensor, of the Kings Own Yorkshire Light Infantry, was wounded on Nov 28th. Including this adopted son Mr & Mrs MEDCALF have five sons serving with the colours - the others being Pte William John MEDCALF, Army Service Corps; Pte Alfred MEDCALF, Army Service Corps; Pte Christopher MEDCALF, Royal Engineers; and Pte Reginald MEDCALF, RFA. The second son Pte William John MEDCALF tried 5 times to enlist, but his employment on munitions stood in his way. The eldest Pte Alfred MEDCALF, is 27 years of age, and is engaged as a shoeing smith with the A.S.C. in France. The Father, who is proud of the fact that all his boys are doing their bit, is a coachman in the Surveyor's department of the Stoke-on-Trent Corporation.



Joseph Bodman Medcalf and his wife Lydia (nee Breeze) with their son Christopher Bodman Medcalf. Christopher was a driver in the Royal Engineers and died in France in WW1 on 21 April 1918. He is buried in Wimereux Communal Cemetery. (Grave/ Memorial Reference XI.E.2.). The year William Tittensor was wounded was probably 1916 based on Alfred's age and date of birth of 9 March 1889. William John Medcalf was my grandfather, The Mr & Mrs Medcalf in the article (my great grandparents) were Joseph Bodman Medcalf and Lydia Margaret Medcalf (nee Breeze).

I have learned recently after talking to my aunt that William Tittensor was adopted by Joseph Bodman because he was the son of Lydia through some relationship which we are unaware. It's still rather a tangled web but we're slowly unravelling things.



The Mecca News

After seeing the article "So whose Calves are they?" in April's Mecca News, Sheila Billot M880 - who was responsible for pointing out the shields in Gorey Castle in the first place - wrote

"I was very "tickled" to see that you had done some research on the Metcalfe shield. It would seem that both shields may have been designed before the time of registration from what has been discovered. I ooking in our history books that we have at home on a very sodden Bank holiday Monday recently I found that Sir Hugh Calverley had indeed been Warden here in 1376/77

and one of his first deeds was to arrest Bailiff de Martin for treason. His wife tried unsuccessfully to clear him but he was finally cleared of treason in 1387 but not restored to his former position.

In 1382 religious complications had occurred with France supporting Pope Clement and England supporting a man called Urban. This placed Jersey in an awkward position. Calverley as Warden had to support Urban and was instructed to show little mercy to the "Clementines" in Jersey. He then proceeded to banish the Dean and closed the Ecclesiastical Court. Our leopard did not change his spots but no doubt like some today would protest he was acting under orders! At a later date he led an unsuccessful armed Crusade to slay all Clementines in Europe. He died in 1394, presumably in office as a new Warden was appointed in the same year. Later the appointment of Warden of all the Islands was abolished in favour of a Governor to each Island (ie. Jersey and Guernsey) and later still to the appointments of Lieut. Governor instead and that position remains today.

Should any members visit Jersey just now the shields are not on display as Gorey Castle is undergoing extensive repairs and maintenance although the Castle can still be visited. We are also celebrating 800 years of allegiance to the Crown with many activities going on as you can guess. I would like also to mention that there was a spelling error as Gorey is spelt with an o not a after the G.

Here endeth the history lesson!! And thanks for an interesting article.

Extract from Green-Eyed Boys - 3 Para and the Battle for Mount Longdon by Christian Jennings & Adrian Weale published by Harper Collins.

"...42 Commando's attack on Mount Harriet - would now take place on the night of 11-12 June.

Although the no-man's land between the opposing forces was comparatively narrow,.....the British gun out-ranged the Argentine version (both sides had 155mm howitzers)...Even so, the Argentine fire was still dangerous, and there were some casualties. Lee Fisher was resting before beginning a new task:

Bill had his brew kit on and we sat around and we could see Longdon off in the distance and then these mortar rounds hit the hill and we thought 'There's nobody up there, is there? and then they hit the other hill and then they went halfway between us and the first hit and then came half that distance and I said 'It looks like bracketing' and Bill said 'Yeah,' and I said 'If they fire again I reckon they found us you know' and then boom-boom-boom WHOOOOSH!..... once they found us they kept on putting rounds down on us and that was when I got wounded.

I turned around 'cause I thought **Bill Metcalfe** had something like a sledgehammer and he'd hit me with it. I said 'Bill what the **** did you do that for? and he was just laying there and there was a smoking hole and in between me and this hole was Bill, who was just laying there drinking the brew he'd made. He was like, been there, seen it, done it not impressed. I was thinking 'How did it get me and miss him, the bastard? It must have been a curved one or something!'

Fisher was wounded and evacuated during the afternoon of 12 June. He and his patrol had just been tasked to lead one of the rifle companies up to the start line for the most dangerous operation any of then had undertaken: the assault on Longdon."
