So, all in all, a busy day ahead, and we hope as many of you will be able to join us on the day. It is always so interesting to meet distant cousins, and I am looking forward to 'seeing' you there.

#### Down a Rabbit Hole No.2

## The Metcalfe's from Lancaster, Lancashire, England A lesson in Genealogical Methodology

This is a continuation from the last Newsletter which started with the Metcalfe's in Penzance, Cornwall in the 1710s and how they came to be living there. They originated in Lancaster, Lancashire and here is their story. Information in *italics* is from the Autobiography of William Stout who was a friend and fellow merchant in Lancaster of Thoms Medcalf. Thomas was a draper and William Stout a wholesale and retail grocer and ironmonger [and a Quacker]. William also acted as co-executor for Thomas's estate.

Thomas Medcalf was born about 1648 in Lancaster to George Maideclaffe [spelling on George's baptism]. Thomas married 19 February 1713 in Lancaster to Alice Rippon. They had 9 children; a son George and daughter Ann had died as children. Alice had also died in her late 30s in 1699 leaving children aged between 14 years down to a one-year-old.

Thomas Medcalfe of Lancaster, an Alderman died 19 February 1712/3 and was buried at St Mary, Lancaster on 22 February.

The children who survived their father were Judith aged 28, Thomas 23, Elizabeth 22, William 21, Margaret 17, George 16 and Dorothy 15.1

Now to the wonderful information gleaned from the Autobiography of William Stout.<sup>2</sup>

He [Thomas] left three sons and four daughters. The eldest **Judith**, was married to Thomas Holme, the schoolmaster and curate at Lancaster,

Thomas Holme and Judith had children Alice 1713, Catharine 1715, William 1718, Joseph 1721, John 1723, Susan 1725. Thomas Holme's first child's baptism lists Thomas as a Schoolmaster, and the remaining baptisms list him as a Clerk.

The second daughter, *Elizabeth*, was married to Robert Winder, a draper; -- both their portions were paid.

Elizabeth and Robert had married a month before her father's death on 13 January 1712/3 at St Mary, Lancaster. They later had children Robert 1716, Judith 1718, Edward 1720, Alice 1721, Elizabeth 1723 and Thomas 1725.

His second son, **William**, was brought up at sea, very hopeful and improving. His legacy of £50 we paid and soon after died, upon a Guney [Guinea] voyage.

What interesting information. I doubt anyone would have known what happened to William without this autobiography. But a search of Prerogative Court of Canterbury has proven fruitful. Details from the Will: -

**These are** to certify whom it may concern that I the under written William Medcalfe being in sound sense and memory but very weak in body Doe in manner and forme following Bequeath my Soule and Body in the hands of my Allmighty Creator in hopes of a joyfull

**Memorandum** if any overplus should be I give it to my sisters. **William Medcalfe** The Will was probated at the PCC 1 Jan 1717 [1717/8]

His youngest son and two daughters were under age, and got them good education. **George** we sent him to his brother at Penzance, and from thence to London, but could no get him used to good business

Still searching for what might have become of George.

**Margaret** cost us much money for education but was not of so good government as to settle to business, but married poorly at London.

A Margaret Metcalfe married William Rivington 13 February 1717/8 at St Benet Paul's Wharf, City of London and had children Jane 1721, Mary 1723 and Thomas 1726, all baptised St Stephen, Coleman Street, City of London.

**Dorothy**, the youngest, we place he an apprentice to Ann Whitlham, a milliner, with who and her maintenance in her apprenticeship cost us much of little stature and very modest and hopeful, but had a marriage which brought her to hardship.

Dorothy Medcalfe baptised 9 November 1697 at St Mary's in Lancaster married to Roland Wainhouse 21 February 1721 at Cartmel, Lancashire.

It seems that Dorothy had a marriage settlement of £200<sup>3</sup>, and her Marriage bond says she was a Milliner.

Rowland, and I presume Dorothy as no mother's names on the baptisms, had the following children Edward 1722, Thomas 1725, Thomas 1726, Ellen 1732, William 1736, Rowland 1738 and Robert 1741. Dorothy died and was buried at Ulverston on 17 October 1741 aged about 44.

Further searches on the internet locate the following in the book titled "Time=Honoured Lancaster." By Cross Fleury <sup>5</sup>

Chapter II St Mary's Church - on page 15 is information about our family in a brass memorial

This is succeeded by one to Thomas Medcalfe and his wife:

"Here lie the bodies of Thomas Medcalf of Lancaster and Alice his wife the daughter of William Rippon of Hare... pe. She died 1609 June 17th aged 37. Hee 1712 February 19th, aged 64. Leaving surviving children—Judith, Thomas, Elizabeth, William, Margaret, George, and Dorothy."

As the book was published in 1891 I wonder if the brass is still readable.

- In school events
- In sporting news
- In articles on military service
- Heroic acts often made the papers
- Birth announcements
- Weddings or wedding announcements
- Significant wedding anniversaries
- Articles relating to employment
- Accidents were always reported
- Obituaries a good source of information.
- Inquests were often covered by newspapers
- Trials often made the news, too.

Don't forget about this valuable resource. Some are free some, require a subscription. If you know of a resource in your area, please let us know and we will create a list of links. Find My Past now includes links to newspapers in their searchs and subscriptions.

Example: This is a USA government facility: <a href="https://news-navigator.labs.loc.gov/search">https://news-navigator.labs.loc.gov/search</a> A search for "Metcalf" produced 285 items between 1900 and 1963. The "mouse over" on the image gives text that is a machine transcription - but the gist is apparent for further research. Give it a try!



#### Metcalfe Wills

One of the tasks undertaken this summer has been to go through the website checking the Wills database prior to transfer to the new website. In the transfer, some transcriptions were not copied across because of the difference between the old and the new database. On the old one, the transcription was not held as part of the record but as a separate file.



This has allowed us to check the contents of the wills and to

add Record numbers where we can find them. However, it has thrown up that some of the individual records are very basic – just a name and death/burial date, whereas the will may include a spouse and children, and even siblings and parents, as well as cousins. I would be grateful if you could check out the records for your ancestors and let me know any additional information you have, to complete the record. Also, if there is a will that you particularly want but cannot find the transcript of, do let me know and I'll try to make sure it is added, so you have the details.

In the meantime, some of them do raise interesting questions. Aside from a detailed inventory which some wills contain, and which itemise everything the deceased owned, they often highlight family problems.

Many start with something along the lines of 'being somwhat Craisie in bodie but of good sound and perfect disposing memory'.

The contents may not always appeal to our finer senses 'All the Knitt stockens in my hous washen & unwashen' and 'All the butter remaining in my hous at the time of my decease'. Specific items include articles of clothing and household furnishings, and not only from a female deceased. In some cases, stock animals or workshop contents are itemised, along with the value of the same – all dutifully accounted for by the executor/s.

Some are very explicit '*I expressly and entirely excluded my same Son from any share in my property*' including in many cases a provision that if a wife remarries, then she will only receive her dower, and not enjoy the original share of the estate she would be entitled to as a widow even if the new marriage happens much later. Certainly in one case, the will mentions a miniscule bequest (one shilling) to two sons, whereas the rest of the estate is shared between another son and daughters - a family split?

So, all in all, interesting and amusing, and well worth going through to see if we have someone related to you, especially if you fancy wading through all the legal jargon and repetitive phrasing.

#### Canadian Expeditionary Force File #1 – Francis C. Metcalf



Francis Clarence Metcalf enlisted on the 15th July 1915 in Vernon, BC, born unmarried and a plumber by trade, born 11 September 1859 in Douglas, Isle of Man. He was a Private in the 47th Battalion of the Canadian Infantry, the West Ontario Regiment, Service # 628099. Two years later, he was hit by shrapnel at Vimy 30 March 1917 and, after losing most of his right leg, was hospitalized in England before being shipped to Canada for convalescence and on-going treatment at the Davisville Military Hospital, North Toronto as an out-patient. He lived near his mother in Vancouver and left his home for

adjustments to his prosthetic leg at the Orthopedic Hospital in Toronto but died of pleurisy there on the 14th of October 1918. His body was returned to Vancouver and was buried in Mountain View Cemetery after a military funeral. Clipping is from Newspaper.com Vancouver Daily World Tue, Oct 15, 1918 Page 2. Who was Francis or Frank? He was baptised at Kirk Bradden, Isle of Man, on the 4th of March 1890, son of William Hederington (or Hetherington) Metcalf and Elizabeth Brewer Ward. (Source FamilySearch image). He was enumerated in Union Mills, Bradden, Isle of Man in 1891 with parents Wm. H. (54), Master Mariner, born in Lancashire, and Elizabeth B. Metcalf (38) with older siblings James W. (10) and Henry E. (6).

In 1901, Frank was enumerated with his widowed mother, sister Dorothy H. and grandmother Judith Ward. In 1910, Frank, his brother Henry Edward, sister Dorothy Henrietta and mother were enumerated in Seattle, Washington.

Frank and Henry were working as plumbers and Dorothy was a saleswoman. They had arrived in the USA in 1905. At some point the family moved to British Columbia. Elizabeth Brewer Metcalfe died in January 1944, the oldest member of the Vancouver Manx Society leaving son Harry of Vancouver and daughter Mrs. Dorothy Corley in England, along with six grandchildren and two great grandchildren.

Captain W.H. Metcalf, of Liverpool married, Lizzie Brewer Ward by licence at Walton, Isle of Man, in January 1881. In the census that year they were enumerated in Kirkdale, West Derby. Wm Hederington Metcalfe, 44 (b1837), a Master Mariner, along with sons Wm. Geo. Hedergtn Metcalf, 17, born in London, and Chas. Frederick Metcalf, 7, born in Liverpool who were sons of his first marriage. [William H. Metcalf, Master Mariner, son of John, a Mariner, and Mary Ann Frances Peters, married at the Church of St. Thomas, Stepney, Middlesex on June 9, 1862. This couple had at least four children between 1865 and 1874. Source: Ancestry (subscription required).]

William Hederington Metcalfe was born 17 Jan 1836 and bapt 7 Feb 1836 at Liverpool, St. Peter, son of John Hederington Metcalf, a Mariner and Ann. A sibling, John Hetherington\* Metcalf, was baptized in July 1837 and another sibling, Robert Stanley was bpt in Oct 1834.[\* as written]

William died at age 60 on 24 Nov 1896 at the Queen's Hotel, Crescent, Douglas, Isle of Man, and was buried in Toxteth Park Cemetery, Merseyside. [William George Hetherington Metcalf\*, single, shipping clerk, died in Cape Town, S.A., March, 1905 at age 40. (Ancestry. \*as transcribed]

#### Seen in Passing

I saw the Metcalfe Plant Hire vehicle parked in a road near my home the other day. See the photograph.

I looked on the internet and discovered that the truck operates from in Penrith, Cumbria, in the English Lake District. You can see the website entry at <a href="Home-Metcalfe-Plant Hire and Civil">Home-Metcalfe-Plant Hire and Civil</a> Engineering, Cumbria (metcalfe-plant-hire.co.uk)

It is possible to search online at the English and Welsh Companies House by using the link <u>Find and update company</u> information - GOV.UK (company-information.service.gov.uk) and



obtained a lot of information from the site. You can discover facts about the business and what documents have been filed after making a search and clicking on the name revealed. A search against companies including the name METCALF(E) reveals 4,000 plus registered limited companies.

The company has had several changes of name over its life. It was incorporated with the number 02093086 on 26<sup>th</sup> January 1987 as 'Othermanual Limited'. The business was owned by Anthony and initially Irene Metcalfe and the name was changed to A. Metcalfe (Plant Hire) Limited on 6<sup>th</sup> April 1987. Another change of name was made on 30<sup>th</sup> May 1996 to Metcalfe (Plant & Tool Hire) Limited. Another alteration to the name was made to Metcalfe (Plant & Tool Hire) Limited on 14<sup>th</sup> August 1998. Nine years later Anthony and the business sold on 5<sup>th</sup> June 2007. It still operates as Metcalfe Plant Hire Limited.

It is not the only plant hire company with a Metcalfe connection. Another family partnership, formed almost 100 years ago, by William Metcalfe has sites at Hawes and Catterick. It is called W Metcalfe and Sons. See the link <u>W. Metcalfe & Sons – Family Run General Haulage Since 1927 (wmetcalfeandsons.co.uk)</u>.

This business is not operated as a limited company but a partnership, owned by two or more individuals. There is not as much public information available on ownership, since unlike limited companies, there is no central registry for such businesses. There used to be a registry of businesses owned by persons in business whose surnames were not included in the business name. The Registration of Business Names Act 1916 created a register, which existed until it ceased in February 1982. There are samples of the records held by The National Archives (TNA) taken in the years of 1917, 1921, 1931, 1941, 1951, 1961, 1971, 1981 and 1982. So not all of the records have been retained. There is an explanation on the TNA website which I replicate:

".....It was originally intended as a record of enemy aliens or former aliens who were not trading under their own names, but later served as a register of persons or firms trading under a business name other than their own. Persons or bodies trading in their own names were not required to register. Under the Companies Act 1947 the register was extended to cover limited companies trading under a different business name.

The main particulars registered were the business name, general nature of the business and principal place of business, as well as details of names and nationality of owners, partners etc. The Companies Act 1947 repealed the regulations regarding the disclosure of nationality and amended the regulations regarding the disclosure of former names. The register was never comprehensive. It has been estimated that only 50-60% of those required to register did so, and that many cessations and changes of ownership were never registered...."

#### Albert Medcalf, Clerkenwell Butcher

Albert Sidney Medcalf was born in West Ham, Essex, in 1876 and was a butcher/dealer when enumerated at 106 Lower Kennington Lane, Lambeth, in 1911, with his wife and step-children. The following year he opened up his butchers shop at 40 Exmouth Market, Clerkenwell. It became renowned for Angus beef, pike, wild salmon, other meats, poultry and game until it closed in 1978. It was run by family members for 20 years

after Albert's death in 1959.


It remained empty for many years but became an award-winning bar and restaurant of the same name and storefront. which opened in 2011. However, it seems to now be closed.

[A quick search on Ancestry showed that Albert (Bertie) was the son of Walter Alfred Medcalf, a butcher, and his wife Frances Bacon who married in 1871 in Stepney. Walter was born in 1850 in Braintree, Essex, the son of a butcher Alfred and his wife Emma Emson. Walter is in our records # 100745 and Albert is # 1395.]

#### Bombay Surveyors & Loss Assessors

Capt. Metcalfe, Master Mariner, established this firm of Surveyors & Loss Assessors in September 1885 at Bombay on inducement and for the convenience of British Mercantile and Insurance Interests. A few years later as the business grew, Capt Hodgkinson, Master Mariner, joined the firm as a junior partner and the firm eventually acquired the name "Metcalfe & Hodgkinson" as a registered partnership firm.

On 27th September 1948 the partnership was incorporated in the state of Maharashtra, India as a Private Limited company and formally acquired the name Metcalfe & Hodgkinson Pvt. Ltd. #### Henry Wray Metcalfe Ancestry

You may remember reading a bit about this man in Jo Heron's article about Navy Service and Pension Records. Henry Wray Metcalfe was a navy man and an inventer with many patents. He married a Metcalfe (Dora Henrietta) in 1893 in Wycombe, Buckinghamshire and the couple had two daughters both born in Port Royal Dockyard, Jamaica: Edith Dora about 1894 and Beryl Nesta about 1896. Edith did not marry and died in Canterbury in 1983; Beryl married a military man, Charles Dandas Allender Fenwick in 1917 in Pancras, London. They had one daughter Pamela Beryl Fenwick born in 1919 registered at Christchurch Hampshire and baptised at Bournemouth: St. James Pokesdown, Hampshire but she did not survive the year. So it seems that there are no descendants. I thought that the two Metcalfe branches deserved further research into their ancestries.

Henry Wray Metcalfe was born on the 28<sup>th</sup> Aug. 1865 in Geneva, Switzerland, the son of John William Metcalfe and Harriet Atkinson Browne. John William was working at York Asylum in York St. Giles as a medical resident superintendent in 1851. Later, John William was licensed to keep a private asylum by the courts, recorded in <a href="Knaresborough">Knaresborough</a>, Yorkshire, QuarterSessions at Acomb House - for 12 male and 6 female patients for a period of 12 months from the January 1853 and seemed to have been renewed until 1857.

John and Harriet married in February, 1858, at Acomb House, Yorkshire.

Their first child, Eleanor Anne Eamonson Metcalfe was born in Gineva, Switzerland on the 3<sup>rd</sup> of April 1861. They were in Switzerland at least until late 1865 when son Henry was born but were not spotted again in the records again until 1881 when John was enumerated with his wife Harriet and daughter Elonore (sic) A.E. Metcalfe at Amitie Cottage, Grouville, Jersey in the Channel Islands. His occupation was medical profession, non-practising.

John William returned to Switzerland at some point and died there in 1896. The Index of Wills and Administrations gives his death at maison Bisley, Massongex, Valais, Switzerland, M.D. on the 18<sup>th</sup> of Apr 1896. Administration (with Will)(Limited) London 10 June to Henry Wray Browne esquire the attorney of Harriet Atkinson Metcalfe widow and Eleanor Anne Eamonson Metcalfe spinster. Effects £3776. Eleanor did not marry and she died at Chalet, Plan Névé, Bex, Vaud, Switzerland 2 Apr 1948. According to the Index of W&A, no family were recorded as executors.

Find My Past has a baptism of John William Metcalfe on 30 Sep 1818 in Canterbury, Kent, son of John Metcalfe (Clerk) and Elizabeth. Sibling baptisms followed: Eleanor Etheldreda baptised 13<sup>th</sup> November 1820; Maria Elizabeth bapt. 25<sup>th</sup> July 1822 (born May 9); Joseph Powell bapt 22<sup>nd</sup> Jan 1824; Mary Eamonson bapt 18<sup>th</sup> June 1825; Robert bapt 30<sup>th</sup> Oct 1826; Alice Eamonson bapt on 5<sup>th</sup> June 1828; Elizabeth Anne Eamonson bapt 14<sup>th</sup> May 1830; Agnes Eamonson bapt 31<sup>st</sup> Oct 1831; Lucy Curties bapt 5<sup>th</sup> May 1834. John was enumerated in the 1841 census as a 50 year old widowed Clerk in Sturry near Canterbury with seven of his eight children. Only John William was absent. In 1851 he was in the same place with four of his daughters and was 62 and a Minor Canon born in Ely, Cambridgeshire. In 1861 he was enumerated with five daughters an sister-in-law Mary Eamonson who was 71 born in Barwick in Elmet, Yorkshire. John was then the Vicar of Stone in Oxney.

Reverand John Metcalf, of the Cathedral of Christi Church, Canterbury, age 25, obtained a marriage licence 29 Oct 1816 to marry, at Bramham, Elizabeth Eamonson, of Bramham, Yorkshire by Licence (FMP).

Elizabeth died on the 6<sup>th</sup> Feb 1836 at Canterbury and found in FMP England, Newspaper Death Notices (subscription required). [She was baptised on the 3rd March 1791 at Barwick in Elmet, daughter of Benjamin Eamonson, Esq., of Bramham, Yorkshire]

Index of Wills and Administrations has: Reverend John Metcalfe of the Precincts of the Cathedral in the City of Canterbury, Clerk, deceased who died 25 July 1862. His son the Reverend Joseph Powell Metcalfe of Bilbrough in the County of York, Clerk, was one of the executors with effects under £9000.

I haven't found any Johns born 1789 or so in Ely, Cambridgeshire, so the trail ends here.

Henry Wray's mother, Dora Henrietta Metcalfe was born in 1861 in Saffron Walden, Essex. She was baptised on the 16<sup>th</sup> of June 1861 at Great Chersterford, All Saints, Essex, the daughter of Frederick Metcalfe and Harriet Jane. Frederick, a bachelor and Clerk, and Harriet Jane Kynaston were married 4th of October 1853 at Saint Alfege, Greenwich, London. Frederick's residence was given as Little Shelford, Cambridgeshire and his father was given as William Metcalfe, a Clerk. Harriet was a Spinster of Crooms Hill, her father John was a gentleman. Two of the witnesses were Henrietta Metcalfe and Robert Metcalfe.

Frederick Metcalfe was born abt 1824 in Foulmire, Cambridgeshire according to the 1861 census when he and his wife had five children, three boys and two girls 6 years of age and under, all born in Great Chesterford, Essex. Frederick was the Curate of Great Chesterford. In 1871 the family was living in Hastings, Sussex with four more children including Dora aged 9. Frederick was now the Curate of St. Mary Magdalene. In 1881, Frederick was a widower living in the Rectory House of Upper Hardres. Kent, with his older sister Eliza Metcalfe and eight of his children aged 9 to 24. Frederick was a clergyman, Rector of Upper Hardres.

In 1851 Frederick was enumerated in Little Shelford, Cambridgeshire, with his mother Susan and siblings including Robert and Henrietta who would soon witness his marriage. At age 27 Frederick was Curate of St. Shelford. His mother Susan was 66, born abt 1785 in Ely, Cambridgeshire. Ancestry's Select Marriages has Susanna Golborne marrying William Metcalfe on the 13th of September 1814 at Trinity Church, Ely. (Susan died 4<sup>th</sup> Jan 1861, Index of Wills and Admins. Has her of Haddenham, Cambridgeshire. Letters of Administration were granted at Peterborough to John Metcalfe of Haddenham, farmer and one of the children of the deceased.)

Frederick's parents may be this from Ancestry's Select Births and Christenings: William Metcalfe was christened on the 3<sup>rd</sup> of Mar 1782 at Cambridge by William Metcalfe and Elizabeth. FMP has a William Metcalf marrying Elz Potter in 1773 at Cambridge All Saints sourced from Boyd's Marriage Index. At first glance of FMP search results they likely had several children after 1773 including Robert, Rosetta, Joseph, William, Richard and John in no particular order.

So, these are probably the two Metcalfe lines of Henry Wray Metcalfe and Dora Henrietta Metcalfe.

Is this your family? Please let us know if you have details, that you wish to share, of any branch of this family. It will help expand our database to know!

#### **ANNUAL REPORT OF THE TRUSTEES**

In order to comply with our Charity Law obligations, I set out a report on the Society's activities for the year ending 5th April 2024, with some updates. The Society was founded in 1980. Membership is open to anyone, who is interested in learning about the Metcalfe family in all its variants spellings or who wishes to find members with the same Metcalfe ancestors. The Society has a written constitution, which regulates how we operate. The Trustees of the Charity are its officers, who are elected annually by the members at the AGM. The Trustees elected at the AGM on 7th October 2023 continued to work for the Society and to guide and advise on Society matters. We were delighted to be able to hold our AGM in 2023 live, with some members joining online. We have continued to hold our Committee meetings online and it has enabled us to extend the attendance at meetings to include our Agents in Australia and Canada, to our mutual benefit. Unfortunately, we have still not been able to attract a member to act as our liaison in the United States, but we remain hopeful.

The Trustees consider that they have complied with the obligation to ensure that the 'charitable public benefit test' has been met during the year. We have continued to collect genealogical data and information about the Metcalf(e) family and disseminated it in a number of ways: via our regular bi-monthly newsletters; the Society's website where members can research by searching the databases; answering enquiries raised directly with us and by the general public at events such as the Family History Federation (FHF) online Really Useful Show, in which we participated; by our archivist who assists members to find links to other members; by selling our publications including our 'Metcalfe: History of the Clan' book and 'Metcalfe Family Histories'. The Society has continued to develop links with the FHF and now retail membership and goods through their Parish Chest facility, as well as having a representative on their Committee and on the various information sessions they have set up. We have continued to attend meetings of the FHF Groups in the North West and Yorkshire when available, and build links with the Guild of One Name Studies. We attended the online Family History Fair in York in June, when we were able to connect with those members that also attended, pick up some new memberships and answer queries from members and visitors. Our Facebook page continues to attract a large number of followers although some will ask questions impossible to answer with so little available information from them. Sales had slumped for a long while but do seem to be picking up again more recently with the launch of the reprint of the Clan book, and we are looking for new products to retail.

Our website has been in need of updating for a long time, and in 2023-4 we prioritised that. In the meantime, we continue to collect and collate information on Metcalfes around the world. Following the retirement of our Newsletter Editor, the post has been taken over by our Canadian representative – with excellent results, continuing the strong tradition set by her predecessors. Membership of the society is primarily in UK but we have over 70 overseas members. Our agents continue to work on our behalf and their efforts are much appreciated. So too is Peter Dobson's role as treasurer, ensuring we remain solvent and able to fund our activities. His report on the accounts accompanies this report along with committee members' reports on their activities. Yet another busy year.

In the meantime, we do still need a Treasurer, Secretary and Agent in the USA. None of these posts would take up a lot of time, and we do hold our Committee meetings online bi-monthly – so why not give it a try? You might enjoy and find it worthwhile to contribute to the Society.
