Message from the Chair

Well, we seem to be heading into Spring in the northern hemisphere with unsettled weather in the UK but at least we are seeing some very fine days. It is lovely to see the sun and blue skies now and then,

We are still working on arranging the AGM and Muster and hope to be able to circulate final details in the not too distant future. Voting on whether to make it a live/hybrid event or online only has come down to a live event possibly with an online element, so hopefully, we will be able to make it work well and everyone will have a chance to login, especially those from overseas.

It has been an interesting couple of months since the last newsletter with some interesting enquiries coming through. Did you know of the Metcalfe Mansion in Tunkhannock, Pennsylvania? This started as a query on our Facebook page but has provided an interesting article for this issue (Is this correct Susan? If not delete this bit.) Also, another telephoned enquiry as resulted in additional information on a tree we already have, but some more recent BMDs on another branch. It is good to catch up on families.

The biggest problem we have, and the most persistent bugbear, is the assumption that ancestors we can trace back to the North Riding area are not all direct descendants of Sir Thomas or Sir James Metcalfe, and are entitled to a share of Nappa Hall, never mind a full ownership. The family were prolific, having large numbers of children as you will see on many of the earlier entries on our database. However, you can often see the same name being used for subsequent children, which usually means that the first child has died, and the next one was given the same name. Child mortality was very high in many regions – whether from disease, plague, poor nutrition and inevitable accidents and parents did not have the

advantages of contraception available today to regulate the number of children they had even if they had wanted to.

Possibly like many other families, the Metcalfes often used the same names again and again, so we have Thomas son of Thomas, son of Thomas – and a fairly narrow range of usually biblical names – John, Thomas, William, Peter, Christopher and so on. And of course, female names tend to disappear into their husband's name on marriage. Occasionally some women did manage to go into business or make what would be called advantageous marriages so their names might be recorded in legal documents, hearth taxes and other official paperwork, but for the most part, there might be a birth record and possibly a death or marriage record, but very little else to tell us what these women and girl children did. Again, the same names run through families, Mary, Margaret, Elizabeth, Susanna, Catherine so this does again make it difficult to trace family lines. And that is without trying to decipher the spelling and variations on names.

In my own case, I had a Susannah daughter of George, in a small area where there were three Susanna/h's and lots of George's. It took a marriage certificate to work out which George and which Susannah I was looking for – accomplished comprehensively by or late President, Nina Benson, with my grateful thanks.

Anyway, we hope you all have a peaceful and busy summer, and please do keep us informed of any Metcalfe related stories, places and people you come across, and help us to make our database world renowned.

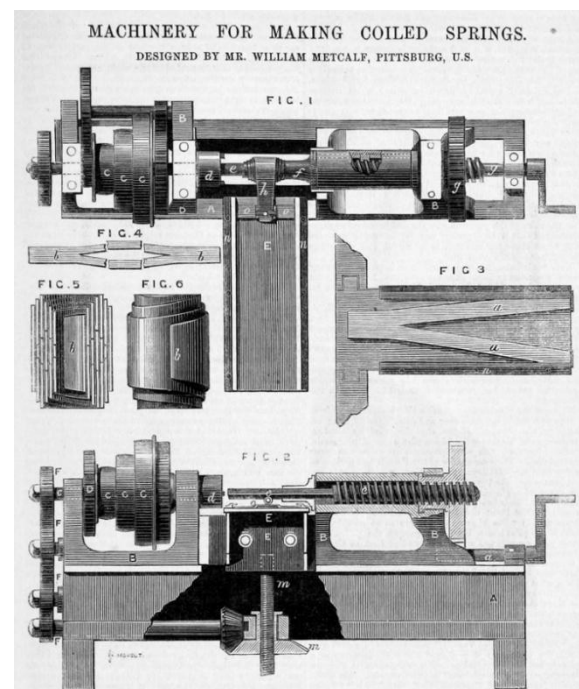

A Tale of Two Harveys

The first Harvey was a animal welfare advocate born in Kettering, Northamptonshire to James and Catherine Emma Metcalfe and [baptized in Brigstock on the 28th of April, 1901](#) as Richard Harvey Frank Metcalfe. [Mother was Catherine Emma Julyan.] His father was a coachman. Harvey was first enumerated Kettering in 1901 with parents and three older siblings. In 1911 he was enumerated as a schoolboy and in 1921 as a "pressman" for Freeman, Hardy and Willis bootmakers in Kettering. This census disclosed that of the 9 children born to James and Emma only four survived childhood. Harvey's father James' marriage was 9 Oct 1883 in Brigstock and gave George, a game keeper, as his father. James' birth was registered in 1869 with mother's surname Storr.



At some point soon after 1921, Harvey became involved in animal rights advocacy and joined the Scottish Society for the Prevention of Vivisection, becoming Secretary at first and eventually Director. He lectured and wrote articles on behalf of the society and travelled worldwide promoting animal welfare. The University of Edinburgh has a [list of articles written by Harvey Metcalfe](#) from 1934 to 1875. It includes: "The Centenary of Greyfriars Bobby", an Article from Psychic News, "Campaigns against animal cruelty are spirit inspired", and an article from The spiritual Healer, "This Must not

Happen in Britain".

The University's collection of the "Records of OneKind animal welfare charity" are Harvey Metcalfe's scrapbook of images and notes about the history of Greyfriars Kirkyard and the associated Greyfriars Bobby (legendary dog).

Richard H.F. Metcalfe married Annie W. Robinson 1Q 1928 registered in Leek, Staffordshire. They had at least one daughter. He died in Madras, India while attending the Indian National Conference on Animal Welfare on the 13th of December 1974. Obit from the Daily Post, Merseyside 1974 12 23.

Welshpool man dies in India

A WELSHPOOL man has died in Madras Province of India. Mr Richard Harvey Metcalfe, of Glanaber Drive, Guilsfield, had been attending an international animal welfare conference.

He was 73 and has been cremated in India but his ashes are to be flown home and a memorial service will be held in Welshpool Methodist Church. Mr Metcalfe leaves a daughter, Dr E. M. Jobling, of Welshpool.

The second Harvey Metcalfe, photographer, his public exposure came in 1928 when he became involved with "Hellish Nell". "In 1928, photographer Harvey Metcalfe attended a series of séances at Duncan's home. During a séance he took various flash photographs of Duncan and her alleged "materialization" of spirits, including her spirit guide "Peggy". His photographs reveal that the spirits were fraudulently produced: Duncan's equipment included a doll made from a painted papier-mâché mask draped in an old sheet." ([Wikipedia](#))

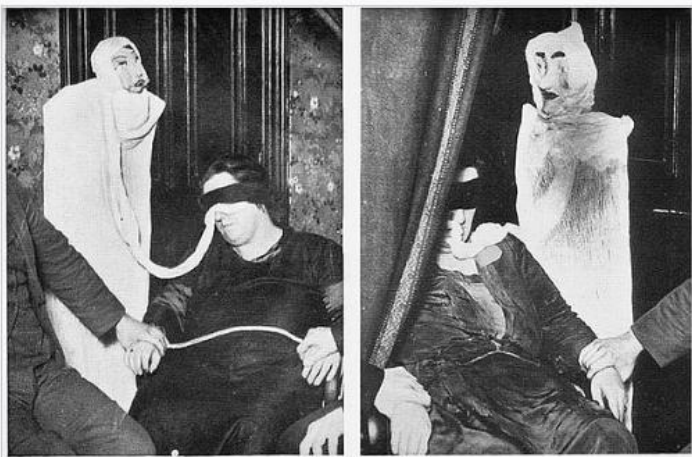

Helen Duncan was the [last person in Britain to be tried and sentenced](#) under the 1735 Witchcraft Act. She was arrested on the 19th January 1944, tried at the Old Bailey and sentenced to nine months in Holloway Prison. [Winston Churchill](#), himself a member of the Ancient Order of Druids, described the case as "obsolete tomfoolery".

The Witchcraft Act was repealed in 1951 because of this case. In its place: the Fraudulent Mediums Act 1951 which "prohibited a person from claiming to be a psychic, medium, or other spiritualist while attempting to deceive and to make money from the deception (other than solely for the purpose of entertainment).

Although not always attributed, Harvey Metcalfe's photos played a roll in the exposing of so-called spiritualists or mediums. I have not traced this Harvey Metcalfe but wonder if he was also interested in animal welfare and communicating with lost pets.

Peruvian Dream Realized

The following story is from the Congregation of the Sisters of St. Joseph in Canada: [The Rural Libraries of Cajamarca – A Peruvian Dream Realized](#), September 16, 2020.

“Since the early 1960s, the Sisters of St Joseph have had a presence in Peru. During those years a priest from England, Father John Metcalfe ministered in the Andes in Cajamarca with primarily the Indigenous population located in small subsistence farming communities. Focusing on education, he wondered why anyone would want to learn how to read when they did not have access to newspapers or books. As a result, he creatively evolved a lending library system, simple but effective, with a presence in every small community. Fifty years later his dream still promotes and encourages reading to enhance education and critical thinking. Critical thinking that included indigenous land rights with ecological protection.”

The obituary of [Father John Lewis Medcalf](#) (born 31 Mar 1935 in Canterbury, died 8 Jul 2002 St. Leonards, Sussex) by Chris Tranchell, was published in the Guardian.

Canadian Expeditionary Force File #2 – Joseph Anthony Metcalfe

Attestation papers provide that Joseph Anthony* Metcalfe was born 12 Feb 1890 in Arlecdon, Cumberland. His next of kin, wife, Catherine Metcalfe of 417 Hochelaga St. E., Moose Jaw, Saskatchewan. He was a miner and Roman Catholic. He previously served for 12 months in 2nd Border Regt., England and 2 yrs in 5th Cumberland Territorials. He enlisted on 12 Jul 1915 in Moose Jaw and was a Private in 68th Bn, promoted to Corporal in Oct, 1915 and to Sgt. from 1 Jan 1916. His unit sailed 15 Aug 1916. He was killed in action a year later on 20 Aug 1917 while serving with the 128th Bn. in the trenches SW of Lens. A month before his death, he was docked 4d pay for "While on ACTIVE Service losing by neglect one shaving brush, value 4d." He is buried in the Villers Station Military Cemetery near Souchez, France.

The marriage of Joseph and Catherine (nee Cavanagh) was registered at Whitehaven, Cumberland, in the 3Q of 1911. Their son James was born in 2Q 1912, registered at Whiteharaven. The family emigrated to Moose Jaw in July 1913 where a second son Joseph Anthony was born in Sept that year. Catherine remarried to Melville Crighton and they were enumerated in Moose Jaw in 1931 with both boys who were both working as delivery men. (Sgt.) Joseph Anthony Metcalfe married Ida Gertrude Smith in Regina, May 1943. The couple moved to Langley, British Columbia after the war and Joseph worked as a baker. He died of a heart attack in May 1955 aged 41. His obituary in The Leader Post, Regina, Saskatchewan, 26 May 1955 mentions a son Terry and a daughter Carol, and brother James in Vancouver. Catherine Crighton died in Moose Jaw in 1961 and James Metcalfe died in Vancouver 17 November 1999. The Province obituary notes that he was survived by his wife Eda, niece Carol and nephew Terry.

His mother Joseph Anthony Metcalfe (senior) listed his mother on his attestation papers as Sarah Metcalfe at 14 Parks Road, Arlecdon, Frizington, Cumberland. GRO provides her maiden name as Pearson on Joseph's birth registration. Ancestry census sheets show him enumerated with his father Joseph and mother Sarah.

Joseph Anthony Metcalfe had an older brother Thomas Pearson Metcalfe and connects to Metcalfe Society member 1141. Birth Brief below.

 The Rev. Wm. Metcalfe, M. D., who for forty-five years was a prominent and well known resident of Philadelphia, died suddenly last Thursday evening, in the 75th year of his age. The deceased was both a clergyman and homeopathic physician. He was one of the founders of the "Vegetarians." By his exertions he built the neat church edifice known as the "Bible Christian Church," and was its pastor up to the day of his death. The deceased celebrated the fiftieth anniversary of his ordination on Sunday, August 11, 1861, and officiated up to the 12th.

Charge of Perjury.

INVERCARGILL, AUGUST 28.
Thomas H. Metcalf, the celebrated canvasser for the "Picturesque Atlas," was served with a summons to-day, charging him with perjury in the recent case, Bowerman v. Grieve. The defendant then maintained that Metcalf made representation that he was accredited by the New South Wales Government, &c., and that he (Grieve) was induced to sign the order book on that representation. Metcalf deposed that he did not make such statements. After the case closed defendant discovered a man who had been within earshot when he and Metcalf had the conversation, and could corroborate Grieve's version of what occurred. His evidence was not admitted, but will be used in the perjury charge.

The members of the Gatun association will entertain in honor of Governor Richard L. Metcalfe, and Mrs. Metcalf, on Thursday evening, August 21, at 8 o'clock, Lieut.-Col. Wm. L.
